SUBJECT: 1998 MANAGED CARE PLAN CUT-OFF SCHEDULE

Enclosed please find the Managed Care Plan (MCP) Cut-Off Schedule for January 1998 through January 1999. This schedule is self-explanatory.

MCPs approved by the Department of Health Services to submit enrollments and disenrollments to the Department, must adhere to the cut-off dates and times. These cut-off dates and times must be met in order to ensure timely processing and are not negotiable. To ensure timely processing of data by any media (tape/diskette/hardcopy), it is imperative that all enrollments and disenrollments are submitted to the Department on a flow basis. Enrollments and disenrollments submitted close to the cut-off dates increase the potential for data entry errors and delays in enrollment.

This schedule also lists the run dates for the monthly Medi-Cal Eligibility Data Base Systems Renewal process and mail dates for MCP tapes and listings (system generated reports).
