MIFEPRISTONE (RU-486) AS MEDI-CAL BENEFIT

PURPOSE

SUBJECT

The purpose of **this** letter is to **remind** all **Medi-Cai** managed care plans that Mrfepnstone (**Mifeprex** RU466) was approved for use for medical abortion purposes by the Food and Drug **Administration** (FDA) on September 26 2000 and should be covered as a benefit of the **Medi-Cai** program

BACKGROUND

Abortion is covered by the Medi-Cal program as a **physician** service. Please refer to **Medi-Cal** Managed Care Policy Letter **99-08** (Attachment A) for the latest **Medi-Cal** managed care **policy** statement on abortion **services including** the prohibition on requiring medical **justification** and/or prior **authorization**

DISCUSSION

All managed care plans are contractually **required** to provide **timely** access to sensitive **services** to members **Sensitive** services Include **services** related to abortion such as the use of Mkpnstone. Access to Mrfepnstone shall be provided in accordance **with** the FDA approved treatment regimen and other mandated requirements. All plans must Include language relevant to access to and appropriate usage of **Mifepristone**, as part of their **written** abortion **services policies** and procedures. All plans must ensure appropriate oversight of the quality of services provided by physicians who are Plan providers of **Mifepristone**.
