TO: COUNTY ORGANIZED HEALTH SYSTEM (COHS) CONTRACTORS

SUBJECT: MEDICARE PART D UPDATE

On December 29, 2005, the California Department of Health Services (CDHS) sent out Medi-Cal Managed Care Division (MMCD) All Plan letter 05015 to inform you of recent changes to the Fiscal Intermediary Access to Medi-Cal Eligibility (FAME) File layout due to the implementation of the Medicare Prescription Drug Improvement and Modernization Act of 2003 (MMA). The primary change to the monthly FAME files and the daily FAME updates was the addition of the Medicare Part D Status Code, which identifies a beneficiary's Part D eligibility status. On January 12, 2006, Governor Schwarzenegger signed emergency legislation, AB 132, to ensure that all Medicare/Medi-Cal dual eligible beneficiaries receive their drug benefits.

The purpose of this letter is to provide information regarding:

- The Medicare Part D Status Code values;
- The location of the Medicare Part D Status Code on the COHS FAME Files;
- The State's Emergency Part D Prescription Drug fill process and beneficiary claims; and
- The State's notification process for Medicare Part D eligible beneficiaries.

How to Identify the Medicare Part D Status

The Medicare Part D Status Code is a 1-byte field that occurs at the end of each monthly segment on the FAME files. The value in this field identifies whether the beneficiary has Part D eligibility for the month in review. Please note that the Other Health Coverage (OHC) Code may contain a Part D value; however, the OHC Code should not be used to identify a beneficiary's Part D status.

The valid Part D Status Code values are:

- Blank or “0”: Indicates that the beneficiary is not eligible for Medicare Part D;
- “1,” “2,” or “3”: Indicates that the beneficiary is eligible for Medicare Part D and has been enrolled in a Part D Prescription Drug Plan (PDP);
- “7”: Indicates that the beneficiary is presumed to be eligible. The status of “Presumed Eligible” is applied when a beneficiary has all indications of being eligible for Medicare Part D but has not been enrolled in a PDP; and
- “9”: Indicates that the beneficiary has decided to opt out of Medicare Part D and instead has alternate, approved coverage outside of Medi-Cal.

Please refer to **Attachment A, MMA Part D Quick Reference Guide** for additional information regarding the Part D Status Code and OHC values.

As mandated, Medicare Part D is effective beginning the month that the Medicare Part D Code displays a valid Part D value in the FAME File. Regardless of a beneficiary’s Medicare Part A and B status, the health care plan should not assume that the beneficiary is participating in Medicare Part D.

The health care plan will be responsible for the beneficiary’s drug coverage and will receive full capitation payments until the Medicare Part D Status Code displays a valid value (“1”, “2” or “3”). If a valid value of “9” is displayed, the beneficiary has affirmatively declined Medicare Part D and is entitled to receive only Part D excluded drugs from the managed care health plan. Also, a beneficiary with a valid value of “9” will not be able to utilize the Medi-Cal Emergency Drug Coverage. Health care plans will not receive capitation for Part D drugs for beneficiaries with a valid value of “9”. Please refer to **Attachment A, MMA Part D Quick Reference Guide.**

Where to Locate the Medicare Part D Status Code

- COHS monthly FAME file: The COHS FAME file consists of the current month and 15 months of prior eligibility. The current month’s Part D value is located in position 260,

Please refer to **Attachment B, Medicare Part D COHS FAME File Layout.**

The Medicare Part D Status Code also appears in the corresponding position for each month of prior eligibility on the FAME files.

The State Carrier Code (SCC), Federal Contract Number, and Policy Start Date are currently available to COHS on FAME, HIS, and the Carrier Master File (CMF).

The SCC, Federal Contract Number, and Policy Start Date can be determined by using a combination of the Health Insurance System Database (HISDB) and the (CMF). PDP insurance segments on the HISDB will have the value "R" in the 8th character of the scope of coverage field. The associated PDP carrier code and policy start/stop date fields will be in their standard positions in the insurance segment. The CMF will contain an entry for the PDP carrier code and the associated Federal Contract Number can be found in the Carrier Footnote-1 field located in columns 241-270. Since the Footnote-1 field is free-form text, the Federal Contract Number will not always be found in the same location. Plans may find it easier to create their own SCC-> Federal Contract Number cross reference table by using the Carrier Cross Reference Table available on the HIPAA web site (<http://hipaa.dhs.ca.gov>) and the Medi-Cal web site (<http://www.medi-cal.ca.gov>).

How to Determine Emergency Part D Claims

The Emergency Part D Prescription Drug fill process should only be used in one of the following situations:

If a beneficiary is enrolled in a Part D PDP but experiences problems (such as excessive co-pays or PDP records containing errors); or

- If a beneficiary has a valid Medicare Part D Status Code value but has not been assigned to a PDP, and the WellPoint drug fill system is not approving the claims.

Claims for Medi-Cal Managed Care dual eligibles without an eligible Part D Status Code will not be approved for payment through the Emergency Prescription Drug fill process. Such claims should be adjudicated by the Managed Care Health Plans.

Notice of Action Process for Part D Eligible Beneficiaries


By federal mandate, the CDHS must send all Part D eligible beneficiaries a Notice of Action (NOA) letter that explains the change in their Medi-Cal benefits as they transfer to Medicare Part D. The Reduction of Benefits NOA must provide at least 10 days of notice. Part D coverage can begin on the first day of the month following the completion

of the 10 days. The beneficiary's Medicare Part D status will then be updated to reflect the change in coverage.
