ALL PLAN LETTER 15-010

**DATE:** May 1, 2015

**TO:** ALL MEDI-CAL MANAGED CARE HEALTH PLANS

**SUBJECT:** AFFORDABLE CARE ACT SECTION 1202 INCREASED PAYMENTS FOR MEDI-CAL PRIMARY CARE SERVICES – REVISED GUIDANCE AND CONTRACTUAL REQUIREMENTS

**PURPOSE:**

This All Plan Letter (APL) provides updated guidance to Medi-Cal managed care health plans (MCPs) regarding primary care rate-setting practices and requirements for calendar years (CYs) 2013 and 2014, in accordance with Section 1202 of the Health Care and Education Reconciliation Act of 2010 (Pub.L. No. 111-152), which amended the Patient Protection and Affordable Care Act (Pub.L. No. 111-148) and together are referred to as the Affordable Care Act (ACA 1202). The Department of Health Care Services (DHCS) received federal approval to change the methodology used to administer ACA 1202 payment increases for primary care services under Medi-Cal managed care contracts from Model 2, “Prospective Capitation with Risk-Sharing that Incorporates Retrospective Reconciliation,” to Model 1, “Full Risk Prospective Capitation,” for CYs 2013 and 2014 as reflected in the federal Centers for Medicare and Medicaid Services’s (CMS’s) “Technical Guidance and Rate Setting Practices” document.<sup>1</sup> In implementing the shift in methodology, DHCS requires MCPs to provide documentation of ACA 1202 payments made to eligible providers, as well as provide DHCS with an updated Managed Care Compliance Plan (MCCP) based on the Model 1 methodology. Additional information on the requirements is found below.

This APL also provides further guidance on the attestation and claiming procedures specific to Child Health and Disability Prevention (CHDP) providers in order to allow these providers the opportunity to receive increased payments under ACA 1202.

This APL supersedes the selected methodology used to implement ACA 1202 as defined in APL 13-009 as well as the requirements and submission deadline for

MCCPs under the previous model described in APL 13-010.<sup>2</sup> In the event of a conflict between this APL and previously issued APLs, the terms of this APL take precedence. The requirements of this APL are in accordance with Title 42 Code of Federal Regulations (CFR) Section (§)438.6(c)(5)(vi) and, as authorized by CMS, MCPs are contractually obligated to perform these requirements, in lieu of MCP contract amendments.

**BACKGROUND:**

Section 1902(a)(13)(C) of the Social Security Act (SSA), as amended by ACA 1202, provided an increase to Medicare rates for 2013 and 2014 for specified primary care services provided by eligible providers. Likewise, ACA 1202 amended Section 1932(f) of the SSA to provide for increased primary care payments under contracts with Medicaid managed care organizations. To be eligible, providers must have already attested either via DHCS's online self attestation registration, or an alternate DHCS-approved registry system, to practicing in the area of general internal medicine, family medicine, pediatric medicine, or a subspecialty under one of those specialty designations. However, Federally Qualified Health Centers and Rural Health Clinics are exempt from receiving any payment increase under ACA 1202. Providers must have attested to either board certification in a covered specialty or subspecialty, or that 60 percent of the services billed in the previous CY fell within the range of services specified as primary care for purposes of the increase.

MCPs are required to pay eligible providers rates that are no less than rates reflected in the Medicare Fee Schedule by National Procedure Code. See Enclosure 2 for the 2013 Medicare Fee Schedule and Enclosure 3 for the 2014 Medicare Fee Schedule.

DHCS originally received CMS approval to administer the ACA 1202 payment increase through the use of the Model 2 methodology described in CMS's "Technical Guidance and Rate Setting Practices" document issued on January 8, 2013. Model 2 would have required DHCS to conduct a reconciliation of payments made by MCPs to eligible primary care providers (PCPs).

On June 20, 2014, after consultation with MCPs, DHCS notified CMS of the its intent to switch from Model 2 to Model 1. Enclosure 1 reflects DHCS's communication with CMS on this issue and the updated implementation approach for ACA 1202. CMS accepted the switch from Model 2 to Model 1 on July 14, 2014. Under Model 1, MCPs are at full-

risk for ACA 1202 reimbursement and there will be no reconciliation of payments made to providers. Neither the capitation rates for CY 2013 and CY 2014, nor the amounts of federal financial participation claimed by DHCS for these ACA 1202 payments, will change due to this shift in methodology from Model 2 to Model 1.

DHCS began issuing increased payments to MCPs through the monthly capitation process in January 2014. These increased payments included retroactive payments covering dates of service on or after January 1, 2013. DHCS will continue issuing increased capitation payments through this same process until all payments have been made for dates of service through December 31, 2014. MCPs are required to begin making the enhanced payments to eligible physicians upon receipt of the associated capitation payments and receipt of a reliable listing of eligible providers from DHCS.

**PROVIDER ATTESTATION AND ELIGIBILITY:**

ACA 1202 is intended to encourage PCPs to participate in the Medi-Cal program by increasing payments in CY 2013 and CY 2014 to at least the equivalent of 100 percent of the applicable Medicare rate. In order to receive increased payment, all providers (including CHDP providers) must have already self-attested that they are eligible to receive the payment increases. DHCS's online self attestation registration was available for providers to self-attest for dates of service through December 31, 2014. MCPs were not required to use DHCS's self attestation data and may have used a proprietary registry. However, if an MCP chose to use its own registry system, proposed arrangements must have been submitted to DHCS for review and approval prior to use. DHCS will continue to make attestation files available for download for MCPs to identify eligible providers who attested during the attestation period, which closed on December 31, 2014. DHCS extended the attestation period for certain State fee-for-service (FFS) CHDP providers because some attested using individual provider numbers as required, but then claimed for services using a group or clinic number; therefore limiting DHCS's ability to identify those eligible for the payment increase. DHCS is making an exception to this deadline and will process FFS claims for those CHDP providers who were impacted and attested after December 31, 2014, in recognition of this unique situation. To the extent this situation is replicated for CHDP providers contracting with MCPs, DHCS encourages MCPs to work with these providers to ensure appropriate ACA 1202 payments are made.

**SUBMISSION OF DOCUMENTATION OF PAYMENTS MADE TO PROVIDERS:**

According to Title 42 CFR § 438.6(c)(5)(vi)(B), each MCP must provide sufficient documentation to DHCS and CMS to ensure that provider payments in Medi-Cal managed care are increased as required by ACA 1202. MCPs shall submit to DHCS, within six months of receiving final ACA 1202 capitation payments from DHCS, documentation of increased payments made to eligible providers.

**UPDATES REQUIRED TO ACA 1202 MCCPs:**

MCPs are responsible for ensuring that only eligible providers, who have already self-attested either by using DHCS's online registration system or a DHCS approved alternate system, receive increased payments of at least the Medicare rates. MCCPs are required to be updated to address the following:

**Use of Model 1 Methodology**

The MCCP must formally acknowledge DHCS's use of Model 1 for both CY 2013 and CY 2014.

**Documentation of Payments to Eligible Providers**

MCPs must include documentation requirements in the MCCP for ensuring that ACA 1202 payments are made to eligible providers as mentioned above. MCPs and contracted downstream providers must have a documented approach of making ACA 1202 payments that is a reasonable and defensible interpretation of the regulations and guidance issued to date. **Timely Payment to Providers**

Each MCCP must describe the processes that the MCP will implement to comply with ACA 1202 and administer the enhanced primary care payments pursuant to the full-risk Model 1 methodology. MCPs are responsible for ensuring that ACA 1202 payments are generally made to eligible providers within 45 days from the receipt of funds from DHCS.

Enclosure 4 is a checklist that will assist MCPs in completing an MCCP for ACA 1202 compliance. Please submit an updated MCCP to Sarah Blote, Capitated Rates Development Division (CRDD), at [Sarah.Blote@dhcs.ca.gov](mailto:Sarah.Blote@dhcs.ca.gov), within 45 days of the release of this APL. In addition, please provide a copy of the updated MCCP to your Managed Care Operations Division contract manager.

DHCS will review the MCCP and issue a determination letter to the MCP within 30 days of receipt of the MCCP. The determination letter will state whether the minimum

requirements have been met, and will identify any deficiencies, if applicable. If the minimum requirements have not been met, MCPs will be expected to address the deficiencies within 30 days from the date in which the determination letter was sent.

**CHDP PAYMENTS:**

State FFS CHDP providers currently submit a PM-160 form to DHCS to receive payments for CHDP services rendered. Some MCPs also use this same form for billing CHDP providers. As a result, due to a number of unique billing issues surrounding the use of the PM-160, certain CHDP providers are prevented from billing at usual and customary rates; and therefore, will not receive the increased payment under ACA 1202. In an effort to help these eligible providers receive increased payments for eligible services, DHCS established a process that allows CHDP providers to bill at usual, customary, and reasonable rates. While this process will allow CHDP providers to receive increased rates at the usual, customary, and reasonable levels, it does not guarantee providers will receive the Medicare rate provided under ACA 1202.

CHDP providers who currently have a FFS arrangement with DHCS are required to have already self-attested using the DHCS online registration form to receive ACA 1202 payments. These providers will then be able to access DHCS's Usual, Customary, and Reasonable (UCR) Web Application to update the amount previously submitted on a PM-160 form and receive increased payments for claims with eligible dates of service. Eligible CHDP providers contracting with MCPs are also required to have already self-attested to receive increased payments. Due to the nature of the payment arrangements between MCPs and DHCS, these providers will not be able to update their PM-160 Information Only forms using the UCR Web Application. Instead, these providers must complete a paper ACA 1202 CDHP Provider Attestation (see Enclosure 5 for an example). The providers must then submit a copy of the attestation via any preferred method (i.e. via mail, email, etc.) to the MCPs they contract with to appropriately update the usual and customary rates for eligible dates of service. MCPs should retain all paper attestations completed by CHDP providers.

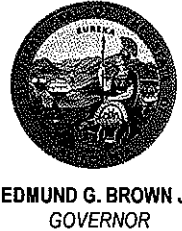

Dear Ms. Mann:

California is appreciative of CMS' time and effort in addressing the state's concerns with administering the increased payments to primary care physicians, in accordance with the intent of ACA Section 1202. As has been expressed to us by our plans and providers, and relayed to CMS, additional guidance was needed from CMS to effectuate these payments in California's highly delegated and sub-capitated managed care environment. The discussions with CMS have been helpful in clarifying certain questions that arose from the guidance CMS released on April 14, 2014, through a Q&A document on ACA Section 1202 reimbursement.

CMS has indicated that they are amenable to approval of a switch in the methodology used to administer the payment increase in managed care from Model 2 to Model 1 for CY 2013 and 2014. Based on discussions with our actuaries, DHCS can confirm that neither the CY 2013 capitation rates nor DHCS' federal claiming for ACA 1202 reimbursement will change due to the shift from Model 2 to Model 1. As required by the definition of Model 1 (full risk prospective capitation), the managed care plans (MCPs) will be at full risk for the ACA 1202 reimbursement and there will be no reconciliation.

The state shares CMS' desire to ensure these payments are distributed to qualifying providers as timely as possible. In order to make certain that the direction California is moving to operationalize these payments is in line with Section 1202 and additional

guidance CMS has provided to date, DHCS' planned approach for facilitating ACA 1202 payments through sub-capitated entities is outlined below.

The DHCS approach for direct contractor payments to those contractors' sub-capitated entities is that such payments should be allowed as long as there is a differential between what the direct contractor health plan paid to the sub-capitated entity (pre ACA 1202) and the ACA 1202 Medicare rate. That differential is present within the certified actuarially sound ACA 1202 capitation rates that the direct contractor plan receives from the state and thus is what is paid from the direct contractor to the sub-capitated entity. After receiving payment from the direct contractor, the sub-capitated entity should either pass the funds on to their provider(s), or if there is an agreement with the provider(s) that their contracted payment or salary is payment in full, the sub-capitated entity could retain those funds in order to assist in maintaining Medi-Cal access and quality.

Our actuaries, both internal DHCS actuaries and our consulting actuaries at Mercer (different groups handled different ACA 1202 capitation rate programs), continue to assure us that the ACA 1202 capitation rates were developed consistent with CMS' "Medicaid Managed Care Payment for PCP Services in 2013 and 2014; *Technical Guidance and Rate Setting Practices*" Section 4.0 which states (there and elsewhere): "The base rate for managed care is based on the payment between the state and the MCPs rather than the specific fee schedule between the MCPs and provider." This holds true regardless of risk sharing model, and regardless of whether a direct contractor uses sub-contractors (in any delegated form) or not. For direct contractors, or for delegated sub-contractors, eligible service costs for non-ACA 1202 and for ACA 1202 have not been directly built into the capitation rates if those costs were not viewed as reasonable, appropriate and attainable for a Medicaid program and population. Instead, those outlier costs would have been actively discarded or adjusted to an appropriate Medi-Cal payment level. This approach is consistent with the rate setting methodology used to develop the Medi-Cal capitation rates and ties with that of the *Technical Guidance*, and also with what was communicated strongly and consistently by CMS Regional and Central Office staff to DHCS on multiple occasions over the last eighteen months.

Unless CMS raises concerns on the proposed treatment of sub-capitated providers and the switch to Model 1, our MCPs have generally indicated to us that for funds they have in hand for ACA 1202 payments, they can release payments to plans by July of this year.



DHCS proposes the following schedule for submission of rates that account for the ACA 1202 provider payment increase to CMS for review and approval:

Finally, due to a number of unique systems and billing issues, we intend to request a self-attestation letter from Child Health and Disability Prevention (CHDP) Medi-Cal FFS and managed care providers due to the “lessor of” billing requirement that would otherwise prevent them from realizing the benefit of ACA 1202. The system limitations only allow a maximum of \$99.99 to be billed. We and our plans will request each provider group (by tax ID) submit a one-time attestation letter that includes their usual and customary charges for the national codes that were cross-walked to the CHDP codes.

We thank you again for your attention to the unique landscape in California and your assistance in moving towards an operationally viable approach to fulfil the requirements of ACA Section 1202. We intend to move forward with our proposed approach as outlined in this letter, as we consider the above consistent with the federal requirements and guidance applicable to ACA Section 1202 as communicated to DHCS. We request that if CMS has any concerns with this implementation approach, to please notify the State as soon as possible. **Affordable Care Act  
Section 1202  
Compliance Plan Checklist**

The Department of Health Care Services (DHCS) requested that each Medi-Cal managed care health plan (MCP) submit a Managed Care Compliance Plan (MCCP) to DHCS detailing how it will comply with ACA 1202. However, because DHCS is altering its methodology used to administer ACA 1202 payment increases for primary care services under Medi-Cal managed care contracts from Model 2, “Prospective Capitation with Risk-Sharing that Incorporates Retrospective Reconciliation,” to Model 1, “Full Risk Prospective Capitation,” for calendar years 2013 and 2014 as reflected in the federal Centers for Medicare and Medicaid Services’ (CMS’s) “Technical Guidance and Rate Setting Practices,” DHCS requires each MCP to resubmit their MCCP. The following checklist will provide guidance to MCPs when resubmitting an MCCP to comply with ACA 1202. The three main elements to consider when preparing the MCCP for DHCS are outlined below. When preparing the MCCP, each MCP must first determine if it will attest provider eligibility or if providers will self-attest through the State of California website: [http://files.medi-cal.ca.gov/pubsdoco/aca/aca\\_form\\_landing.asp](http://files.medi-cal.ca.gov/pubsdoco/aca/aca_form_landing.asp).

**A. PROVIDER ATTESTATION:**

- Obtain the name and address of providers requesting increased payment.
- Determine the eligibility for increased payments by verifying providers have a specialty designation in one of the following:
  - o Family Medicine
  - o General Internal Medicine
  - o Pediatric Medicine
- Provide a summary of how the MCP will verify provider eligibility.
- Maintain a master list of all verified attested providers.

**B. PAYMENTS TO PROVIDERS:**

- Establish a protocol for timing of payments to eligible providers (payment within 45 days from receipt of funds from DHCS).
- Provide documentation to DHCS sufficient to enable DHCS and CMS to ensure provider payments increased as required.
- Provide a plan to certify eligible providers receive payments at least equal to 100% of the Medicare rate.

**C. ACKNOWLEDGMENT OF MODEL 1:**

- Formally acknowledge the use of managed care payment methodology Model 1 for both calendar years 2013 and 2014.

Affordable Care Act 1202  
Child Health and Disability Prevention Program Provider Attestation

Medi-Cal managed care health plans (MCPs) must meet the requirements as set forth in the Affordable Care Act Section 1202 (ACA 1202) relating to primary care provider payments. In order to be eligible for the enhanced primary care rate increase, providers that have provided (or will be providing) services through the Child Health and Disability Prevention (CHDP) program and using the CHDP billing form (PM-160) to bill an MCP for CHDP services must document and attest to their “usual and customary charges” in order to be eligible for payment increases.

Until this form is signed by the provider and received by *[insert plan name]*, the billed charges listed on the PM-160 submission may be considered final. This attestation must be completed and returned within 45 days of the release of All Plan Letter 15-010 in order for *[insert plan name]* to consider additional payment. This attestation will only be required one time. Please note that the ACA 1202 enhanced payments are only for services rendered from January 1, 2013 through December 31, 2014.
