SUBJECT: COST REPORTING - NEW SERVICE FUNCTION CODES FOR
NON-MEDI-CAL CLIENT SUPPORTS AND NON-MEDI-CAL
CAPITAL ASSETS

With the implementation of the Mental Health Services Act (MHSA), it is necessary that the Department of Mental Health (DMH) be able to distinguish between expenditures for direct services and expenditures for client supports. As a result, DMH is adding five new service function codes under Mode 60, Support Services. Expenditures in these categories are expected to reflect the costs associated with: (1) providing fiscal housing supports; (2) operating costs for housing; (3) providing other supports, such as food and clothing; (4) non-Medi-Cal capital assets; and (5) other non-Medi-Cal client supports to clients, their family and/or caregiver. While it is expected that the majority of expenditures reflected in these categories will be related to the MHSA, expenditures from other funding sources may also be relevant.

The service function codes described above: 70, 71, 72, 75 and 78, under Mode 60, should be used beginning with the fiscal year 2005-06 cost report. Please refer to the attachment for the service function code definitions.
