

The purpose of this information notice is to comply with the stipulated court order dated July 22, 1996, of the United States District Court for the Northern District of California in the matter of Voting Rights Coalition, et al. vs. Pete Wilson, et al. (Case Nos. C-94-20860 JW and 95-20042 JW). This order reflects the parties' stipulation to amend the court's orders of January 5, 1996, and May 31, 1996, with respect to the implementation of the NVRA in California. Enclosed you will find a survey form. Each county should send a copy of the survey to all contract providers of mental health services for their county. Each provider will have already been notified of their responsibilities under the NVRA per DMH Information Notice No. 96-03 and DMH Information Notice No. 95-19. The survey will provide the Department with information regarding compliance efforts, which will then be forwarded to the court.
