SUBJECT: CONFIRMATION OF FINAL FY 2012-13 REALLOCATION OF FUNDING
FOR PAROLEE SERVICES NETWORK (PSN)

This letter is to inform counties that the Department of Alcohol and Drug Programs (ADP) has made a determination in regards to the redistribution of the PSN allocation for FY 2012-13. As stated in our previous PSN letter dated January 28, 2013 (Letter No. 13-01), ADP has the authority to redirect funds made available through relinquishment from one county to another county.

There is a total amount of \$ 260,158 available for immediate redistribution to eligible counties. The counties of San Diego, Santa Clara, and Sonoma will receive the additional FY 2012-13 PSN funding.
