

## NOTES

All rates are calculated per 100,000 individuals.

Suicide deaths data are reported by the deceased's county of residence. Causes of death were captured using ICD10 range U03, X60-X84, Y87.0.

Nonfatal self-inflicted injury data are based on hospital admissions (Principle E-Codes E950-E959 only). The data represent first hospitalizations for an injury. Readmissions for the same injury were not counted again. However, one individual may have multiple records if they were readmitted with a different injury. Patient Discharge Data is not available for counties with populations of less than 30,000. N/A is displayed for these counties.

Note that not all self-inflicted injuries are suicide attempts, and not all self-inflicted injuries or suicide attempts result in hospitalizations.

Rates are based on a ratio of deaths to population (per 100,000 individuals) and are not weighted by age or other factors.

- Use caution when analyzing small numbers and rates derived from them.
- Rates calculated from small numbers of deaths or from small populations tend to be **unreliable** and are subject to significant variation between years.
- Rates may not provide statistically valid methods for comparison, particularly among smaller populations.

Race/ethnicity categories are consistent with those used by the United States Census Bureau and the California Department of Finance.
