The California Mental Health Planning Council (Council) invites you to attend its meeting on April 16, 17, & 18, 2014 at the Hotel Irvine (formerly Hyatt Regency Irvine) in Irvine or listen in on the conference line provided above.

The Executive Committee will meet at 9:00 a.m. on Wednesday morning, followed by a new member orientation for incoming Council members at 11:00 a.m. The Patients' Rights Committee will meet at Noon. The Continuous System Improvement, Advocacy, and Health Care Reform Committees will meet at 1:30 p.m. on Wednesday afternoon.

Members of the public are welcome to attend and observe these meetings. Teleconference capabilities are not available for the committee meetings.

On Thursday morning, the Chairperson of the Orange County Mental Health Board has been invited to provide opening remarks to the Council. After, the Council will review and approve the minutes from the January 2014 meeting. This will be followed by a report from the State Rehabilitation Council. In addition, the Council will review and approve its 2014 legislative platform.

Thursday afternoon's session will begin with presentations by the Patients' Rights Committee, followed by a brief Q&A session with the presenters. As always, Thursday's General Session will be immediately followed by a mentorship forum for the Council.

On Friday, a member of State Senate for the 37th District in Irvine has been invited to provide opening comments. The President of the California Association of Local Mental Health Boards and Commissions will update the Council on its activities. The Council will hear reports from the Department of Health Care Services, and the California Mental Health Directors Association. The Council will also hear from Chairperson Richard Van Horn regarding the Mental Health Services Oversight and Accountability Commission.

The Council has scheduled time on the agenda on Thursday at 9:35 a.m. and 4:30 p.m.; and on Friday at 11:20 a.m. for public comment and to voice concerns about mental health issues of importance to them.
