Performance Outcomes System Initial Reports Report run on August 17, 2016

Background

These are the second in the series of reports for the Performance Outcomes System (POS). The reports meet the intent of the Legislation, as stated in Welfare and Institutions Code Section 14707.5, to develop a performance outcomes system for Early and Periodic Screening, Diagnosis, and Treatment (EPSDT) mental health services that will improve outcomes at the individual, program, and system levels and inform fiscal decision-making related to the purchase of services. This reporting effort is part of the implementation of the performance outcomes system for Medi-Cal Specialty Mental Health Services (SMHS) for children and youth.

Since 2012 DHCS has worked with several groups of stakeholders to create a structure for reporting, develop the Performance Measurement Paradigm, and develop indicators and measures. Through this process, seven domains were identified as necessary to assess in order to meet the legislative requirements for the POS. The domains are: Access, Engagement, Service Appropriateness to Need, Service Effectiveness, Linkages, Cost Effectiveness and Satisfaction.

Purpose and Overview

For the Consumer Perception Survey (CPS) data one statewide aggregate report will be produced. Due to the small yearly sample sizes it is not possible to provide reports at the population-based county grouping level or at the county-specific level. These are the initial statewide, aggregate reports using CPS data created for the Performance Outcomes System; they establish a foundation for on-going reporting and are anticipated to be produced on an annual basis.

These reports provide trend information by displaying information for Fiscal Years (FY) 11/12, 12/13, 13/14, and 14/15. This report includes all the CPS questions broken out by youth respondents and caretaker respondents. The CPS questions address the following seven domains: General Satisfaction, Perception of Access, Perception of Cultural Sensitivity, Perception of Participation in Treatment Planning, Perception of Outcomes of Services, Perception of Functioning, and Perception of Social Connectedness.

Definitions

Population - Youth or a family member of a youth receiving specialty mental health services. Specifically:

• Youth ages 13 - 17 and transition-age youth who still receive services in child system; or

• Parent/caregiver of youth under age 18.

Data Source -

• Consumer Perception Survey Database FY 11/12 through FY 14/15.

Report Highlights

Sample size varies by question and by domain.*

The number of youth respondents for FY 11/12 was 2,119 and the number of caretaker respondents was 3,804. The number of youth respondents for FY 12/13 was 3,485 and the number of caretaker respondents was 5,643. The number of youth respondents for FY 13/14 was 17,551 and the number of caretaker respondents was 28,514. The number of youth respondents for FY 14/15 was 19,325 and the number of caretaker respondents was 34,967

Each of the questions are answered using a 5-point Likert scale with the following values: 1 = Strongly Disagree; 2 = Disagree; 3 = Undecided; 4 = Agree; and 5 = Strongly Disagree.

-For FY 14/15 in the "General Satisfaction" domain, the average score for youth respondents was 4.2 and was 4.4 for caretakers.

-For FY 14/15 in the "Perception of Participation in Treatment Planning" domain, the average score for youth respondents was 4.0 and was 4.3 for caretakers.**

-For FY 14/15 in the "Perception of Access" domain, the average scorefor youth respondents was 4.1 and was 4.4 for caretakers.**

-For FY 14/15 in the "Perception of Cultural Sensitivity" domain, the average score for youth respondents was 4.3 and was 4.6 for caretakers.**

-For FY 14/15 in the "Perception of Outcomes of Services" domain, the average score for youth respondents was 3.8 and was 3.8 for caretakers.

-For FY 14/15 in the "Perception of Functioning" domain, the average score for youth respondents was 3.9 and was 3.9 for caretakers.

-For FY 14/15 in the "Perception of Social Connectedness" domain, the average score for youth respondents was 4.1 and for caretakers was 4.3.

*Note: The Consumer Perception Survey has typically been administered two times a year. However, for FY 11/12 and 12/13 the CPS was administered only once during the year. Thus, for FY 11/12 and 12/13 the sample sizes are smaller when compared to the other FY's that are included in this report. **POS specific indicators fall within these domains.






