COMMUNITY MENTAL HEALTH SERVICES BLOCK GRANT (MHBG))
FINAL ALLOCATION AND COST REPORT

This letter transmits the Final Allocation Worksheet and Cost Report forms for settlement of the SFY 2011-12 Substance Abuse and Mental Health Services Administration (SAMHSA); Community Mental Health Services Block Grant (MHBG) funds. The Catalog of Federal Domestic Assistance Number 93.958 is applicable when referring to or auditing this grant.

Final Allocation

The Final Allocation is the Department of Health Care Services approved level of MHBG funding for the county.

Counties must incur expenditures before receiving payments from their MHBG allocation. Payments are based on actual expenditures documented on quarterly expenditure reports, which are due to the Department of Health Care Services 20 days after the end of the quarter: October 20, January 20, April 20, and July 20. Counties must expend all SFY 2011-12 MHBG funds by September 30, 2012, but will have until October 20, 2012, to report SFY 2011-12 MHBG expenditures.

Counties that do not submit their final fourth quarter expenditure report for SFY 2011-12 by October 20, 2012, will not be reimbursed.

Final Budget

The Federal Grant Detailed Provider Budget Form, DHCS 1779M, is used as a program control document and is not intended for fiscal audit control. Counties have received an approved budget for each of the programs funded by the MHBG. The last approved budget revision before submittal of the final fourth quarter expenditure report on October 20, 2012, will serve as the Final Budget.

Cost Report

The Year End Cost Report and Final Allocation Worksheet are due **December 31, 2012**. The following forms to complete the Year-End (YE) Cost Report are enclosed:

- DHCS 1767M, Federal Grant Expenditure Report
- DHCS 1767M-S, Federal Grant Expenditure Report Summary
- DHCS 1784YE, Grant Financial Status Report
- DHCS 1785YE, Grant Cash Transaction Report

Submit one DHCS 1767M for each program and one DHCS 1767M-S as a summary if you have more than one program funded by the MHBG. The DHCS 1784YE and DHCS 1785YE are to reflect total expenditures. Please mail the signed Year-End Cost Report and Final Allocation Worksheet to:
