The Executive Committee will meet at 9:30 a.m. on Wednesday morning, followed by a new Council member orientation at 11:00 a.m. The Continuous System Improvement, Advocacy, and Health Care Committees will meet at 1:30 p.m. Members of the public are welcome to attend and observe these meetings.

On Thursday morning, the CMHPC has invited the San Diego Mental Health Board to provide opening remarks. The Council will hold an election for the 2014 Chairperson, followed by committee reports and an open discussion of potential Council issues.

Thursday afternoon, Sheree Kruckenburg, Vice President, Behavioral Health, California Healthcare Association will provide a presentation regarding the CHA's effort to examine and modify and standardize the LPS "5150" Act. The afternoon will conclude with a forum regarding the Council's and MHSOAC's areas of responsibility, and any new business. As always, Thursday's General Session will be immediately followed by a mentorship forum for the Council.

On Friday, Cary Martin, President of the California Association of Local Mental Health Boards and Commissions will update the Council on its activities. Rollin Ives, Special Advisor to the Deputy Director, Mental Health & Substance Use Disorder Services, will provide a Department of Health Care Services update and overview. The Council will also hear from Jaye Vanderhurst regarding the California Mental Health Director's Association and Sherri Gauger regarding the Mental Health Services and Accountability Commission.

The CMHPC has scheduled time on the agenda on Thursday at 4:15 p.m., and on Friday at 11:50 a.m. for public comment on the agenda items or to voice concerns about mental health issues of importance to them.
