**From I-80, I-5 or Highway 99:**

Take Highway 50 East towards South Lake Tahoe

Exit on Hazel Avenue

Turn LEFT onto Hazel Avenue (stay on left lane)

Turn LEFT onto Tributary Point Drive.

Tributary Point Dr. becomes Foundation Place (end at 11971 Foundation Place)

### Directions to Pasadena

**Address:** 1055 E. Colorado Blvd  
Suite 300 (3rd floor)  
Pasadena, CA 91106

**From East:** Take Freeway 60 or 10 West to either 15 or 57 or 605 North

Merge onto 210 West

Exit on Lake Avenue

Turn LEFT onto Lake Ave

Turn LEFT onto Colorado Blvd

Turn LEFT onto Wilson St

Turn LEFT into the parking lot

**From Freeway 101 or I-5 North:** Merge onto CA-134 East  
134 becomes I-210 East

Exit Lake Avenue
