

CMS Net Web

PIP:

- SAR will display the correct provider type.
- The provider type will display correctly on the Daily Activity Report
- The Special Care Center type will print correctly on the SAR.

SAR:

Inactive providers will now display when searching by NPI number, the message "No Records Found" will no longer display.

When a provider SAR address is edited by selecting from the list, if the selected city is different from the default city, it will appear that the city was changed and not revert back to the original entry.

GHPP

The GHPP (FIN) Financial Review Tickler will display only records within the date range specified the search criteria.
