This flyer, developed by the CHDP Program’s Statewide Nutrition Subcommittee, provides information describing nutrition-related training modules and education materials available on the CHDP Program website as well as the internet addresses where these items may be viewed and downloaded free of charge.

A recent survey administered to counties and CHDP Program providers by the CHDP Program’s Statewide Health Education Subcommittee demonstrated that less than 50 percent of the respondents had received trainings related to obesity and the use of the WHO Growth Charts. Also, more than 50 percent of respondents wanted more information on obesity prevention. This flyer identifies trainings and education materials related to these topics that are currently accessible on the CHDP Program’s website. The Statewide Health Education and Statewide Nutrition Education Subcommittees will continue to develop additional materials and revise outdated materials in order to meet the needs of CHDP Program’s providers as identified from the survey.

Local program staff may use these materials to provide training for CHDP Program medical providers and support staff to assist them in conducting the Nutrition Assessment component of the CHDP Program examination. The CHDP Program nutritionists, health
