SUBJECT: VACCINES FOR CHILDREN (VFC) ADDS MENVEO™ AS A
MENINGOCOCCAL CONJUGATE VACCINE (MCV4)

The purpose of this Provider Information Notice is to inform you that Menveo™, a new MCV4 with FDA and ACIP approval in February 2010, has been added as a VFC vaccine effective May 5, 2010. This vaccine is to be billed in the same way as Menactra™ using existing codes for MCV4: CHDP VFC code 69 for the administration fee, and CHDP codes 70 and 73 when billing for purchased vaccine.
