PURPOSE OF THE HCBS WAIVER PROGRAM

The Medicaid Home and Community-Based Services (HCBS) waiver program is authorized in §1915(c) of the Social Security Act. The program permits a State to furnish an array of home and community-based services that assist Medicaid beneficiaries to live in the community and avoid institutionalization. The State has broad discretion to design its waiver program to address the needs of the waiver's target population. Waiver services complement and/or supplement the services that are available to participants through the Medicaid State plan and other federal, state and local public programs as well as the supports that families and communities provide.

The Centers for Medicare & Medicaid Services (CMS) recognizes that the design and operational features of a waiver program will vary depending on the specific needs of the target population, the resources available to the State, service delivery system structure, State goals and objectives, and other factors. A State has the latitude to design a waiver program that is cost-effective and employs a variety of service delivery approaches, including participant direction of services.

2. Purpose(s) of Amendment

Purpose(s) of the Amendment. Describe the purpose(s) of the amendment:

This is a technical, non-substantive amendment to the Assisted Living Waiver and is made up of six components:

1. Expansion into San Francisco County;
2. Addition of California's Statewide Transition Plan. A renewal application for ALW was submitted in late December 2013 before the addition of a Statewide Transition Plan was required - this includes the removal of bathroom requirement within the Residential Care Facility (RCF) model to align with the requirements of the Home and Community-Based Services (HCBS) Final Rule;
3. In Waiver Year (WY) 4 and WY 5, addition of 44 Waiver slots to accommodate expansion into San Francisco County;
4. Update to the unduplicated number of participants in WY 4 and WY 5;
5. Addition of waitlist process and procedure; and
6. Increase in provider rates (no change to rate methodology).

2. Brief Waiver Description

Brief Waiver Description. *In one page or less*, briefly describe the purpose of the waiver, including its goals, objectives, organizational structure (e.g., the roles of state, local and other entities), and service delivery methods.

The Assisted Living Waiver (ALW) offers Medi-Cal eligible beneficiaries the choice of residing in an assisted living setting as an alternative to long-term placement in a nursing facility. The goal of the ALW is to facilitate nursing facility transition back into a homelike and community setting or prevent skilled nursing admissions for beneficiaries with an imminent need for nursing facility placement.

Assisted Living services from Tier one to five are provided to eligible participants who live in Residential Care Facilities (RCF) or Public Subsidized Housing (PSH) sites. Services are delivered by either the RCF staff or licensed Home Health Agency staff based on the participant's choice of residential setting.

Tier Five was added in an amendment just prior to this renewal. Tier Five is a community residential option for participants who have physical and mental disabilities that make being in other facilities, such as skilled nursing facilities, or in Tiers one through four of the ALW, inappropriate. Participants eligible for Tier Five services will require Nursing Facility Level of Care but will also exhibit severe mental/cognitive disabilities as a result of a traumatic brain injury. They will also have demonstrated one or more failed placements in the past.

Residential Habilitation is a new service that was added to the ALW as part of an amendment just prior to this renewal. This service, which is available to all tiers, requires prior approval from DHCS Nurse Evaluators and provides for additional, appropriate staff to assist in acquiring, retaining and improving the self-help, socialization and adaptive skills as needed by the participant. This may be one-to-one or some other ratio of staff-to-participant depending on need.

Augmented Plan of Care Development and Follow-up is a new service that was added to the ALW as part of an amendment just prior to this renewal. This service is comprised of two parts:

- A behavior assessment or systematic assessment of a participant's behavior that includes a description of their functional and dysfunctional behaviors, the circumstances under which identified behaviors are exhibited and the factors that should be taken into account when developing a programmatic response to the behavior(s). This assessment is followed by the development of a written behavior plan; training personnel to implement the behavior plan; monitoring the effectiveness of the behavior plan; and modifying the plan as necessary. The written behavior plan shall identify those participants who need more structured approaches to address challenging behaviors (such as Residential Habilitation Services).
- Those care coordination activities described under "Care Coordination" plus additional assessment and determination of possible mental health and psychiatric service needs of the participant, including the prescription and management of psychiatric medications. The Care Coordination Agencies (CCA) shall work closely with the County Mental Health plans to coordinate mental health services and ongoing medication management. The increased level of contact with the participant and coordination with County Mental Health is expected to require approximately twice the contact and assistance as persons who receive the routine Care Coordination services.

Every waiver participant receives Care Coordination from an independent CCA. A Registered Nurse (RN) with the CCA administers a semiannual (every six months) assessment for level of care determination. The CCA develops the Individualized Service Plan (ISP) to identify the participant's needs and the methodology to meet those needs. The assisted living provider is either the RCF or a Home Health Agency (HHA) in the PSH setting. The assisted living provider is responsible for meeting the needs of the participant, including Activities of Daily Living (ADLs) Instrumental ADLs (IADLs), meals, transportation, medication administration and skilled nursing as needed. The RCFs are licensed and regulated by the California Department of Social Services, Community Care Licensing (CCL) Division. The HHA renders

assisted living services in the PSH setting. The HHA is responsible for meeting the needs of the participant analogous to the RCF. Meal preparation may be provided individually in each participant's apartment, or in a common dining area depending on the availability of common space at the PSH site. The HHAs are licensed and regulated by the California Department of Public Health, Licensing and Certification Division (L&C).

3. Components of the Waiver Request

Participant Access and Eligibility.** Appendix B specifies the target group(s) of individuals who are served in this waiver, the number of participants that the State expects to serve during each year that the waiver is in effect, applicable Medicaid eligibility and post-eligibility (if applicable) requirements, and procedures for the evaluation and reevaluation of level of care.

- Limited Implementation of Participant-Direction.** A waiver of statewideness is requested in order to make *participant-direction of services* as specified in **Appendix E** available only to individuals who reside in the following geographic areas or political subdivisions of the State. Participants who reside in these areas may elect to direct their services as provided by the State or receive comparable services through the service delivery methods that are in effect elsewhere in the State.

5. Assurances

In accordance with 42 CFR §441.302, the State provides the following assurances to CMS:

- A. Health & Welfare:** The State assures that necessary safeguards have been taken to protect the health and welfare of persons receiving services under this waiver. These safeguards include:
1. As specified in **Appendix C**, adequate standards for all types of providers that provide services under this waiver;
 2. Assurance that the standards of any State licensure or certification requirements specified in **Appendix C** are met for services or for individuals furnishing services that are provided under the waiver. The State assures that these requirements are met on the date that the services are furnished; and,
 3. Assurance that all facilities subject to §1616(e) of the Act where home and community-based waiver services are provided comply with the applicable State standards for board and care facilities as specified in **Appendix C**.
- B. Financial Accountability.** The State assures financial accountability for funds expended for home and community-based services and maintains and makes available to the Department of Health and Human Services (including the Office of the Inspector General), the Comptroller General, or other designees, appropriate financial records documenting the cost of services provided under the waiver. Methods of financial accountability are specified in **Appendix I**.
- C. Evaluation of Need:** The State assures that it provides for an initial evaluation (and periodic reevaluations, at least annually) of the need for a level of care specified for this waiver, when there is a reasonable indication that an individual might need such services in the near future (one month or less) but for the receipt of home and community-based services under this waiver. The procedures for evaluation and reevaluation of level of care are specified in **Appendix B**.
- D. Choice of Alternatives:** The State assures that when an individual is determined to be likely to require the level of care specified for this waiver and is in a target group specified in **Appendix B**, the individual (or, legal representative, if applicable) is:
1. Informed of any feasible alternatives under the waiver; and,

2. Given the choice of either institutional or home and community-based waiver services. **Appendix B** specifies the procedures that the State employs to ensure that individuals are informed of feasible alternatives under the waiver and given the choice of institutional or home and community-based waiver services.
- E. Average Per Capita Expenditures:** The State assures that, for any year that the waiver is in effect, the average per capita expenditures under the waiver will not exceed 100 percent of the average per capita expenditures that would have been made under the Medicaid State plan for the level(s) of care specified for this waiver had the waiver not been granted. Cost-neutrality is demonstrated in **Appendix J**.
- F. Actual Total Expenditures:** The State assures that the actual total expenditures for home and community-based waiver and other Medicaid services and its claim for FFP in expenditures for the services provided to individuals under the waiver will not, in any year of the waiver period, exceed 100 percent of the amount that would be incurred in the absence of the waiver by the State's Medicaid program for these individuals in the institutional setting(s) specified for this waiver.
- G. Institutionalization Absent Waiver:** The State assures that, absent the waiver, individuals served in the waiver would receive the appropriate type of Medicaid-funded institutional care for the level of care specified for this waiver.
- H. Reporting:** The State assures that annually it will provide CMS with information concerning the impact of the waiver on the type, amount and cost of services provided under the Medicaid State plan and on the health and welfare of waiver participants. This information will be consistent with a data collection plan designed by CMS.
- I. Habilitation Services.** The State assures that prevocational, educational, or supported employment services, or a combination of these services, if provided as habilitation services under the waiver are: (1) not otherwise available to the individual through a local educational agency under the Individuals with Disabilities Education Act (IDEA) or the Rehabilitation Act of 1973; and, (2) furnished as part of expanded habilitation services.
- J. Services for Individuals with Chronic Mental Illness.** The State assures that federal financial participation (FFP) will not be claimed in expenditures for waiver services including, but not limited to, day treatment or partial hospitalization, psychosocial rehabilitation services, and clinic services provided as home and community-based services to individuals with chronic mental illnesses if these individuals, in the absence of a waiver, would be placed in an IMD and are: (1) age 22 to 64; (2) age 65 and older and the State has not included the optional Medicaid benefit cited in 42 CFR §440.140; or (3) age 21 and under and the State has not included the optional Medicaid benefit cited in 42 CFR § 440.160.

6. Additional Requirements

- A. Service Plan.** In accordance with 42 CFR §441.301(b)(1)(i), a participant-centered service plan (of care) is developed for each participant employing the procedures specified in **Appendix D**. All waiver services are furnished pursuant to the service plan. The service plan describes: (a) the waiver services that are furnished to the participant, their projected frequency and the type of provider that furnishes each service and (b) the other services (regardless of funding source, including State plan services) and informal supports that complement waiver services in meeting the needs of the participant. The service plan is subject to the approval of the Medicaid agency. Federal financial participation (FFP) is not claimed for waiver services furnished prior to the development of the service plan or for services that are not included in the service plan.
- B. Inpatients.** In accordance with 42 CFR §441.301(b)(1)(ii), waiver services are not furnished to individuals who are in-patients of a hospital, nursing facility or ICF/IID.
- C. Room and Board.** In accordance with 42 CFR §441.310(a)(2), FFP is not claimed for the cost of room and board except when: (a) provided as part of respite services in a facility approved by the State that is not a private residence or (b) claimed as a portion of the rent and food that may be reasonably attributed to an unrelated caregiver who resides in the same household as the participant, as provided in **Appendix I**.
- D. Access to Services.** The State does not limit or restrict participant access to waiver services except as provided in **Appendix C**.

- E. Free Choice of Provider.** In accordance with 42 CFR §431.151, a participant may select any willing and qualified provider to furnish waiver services included in the service plan unless the State has received approval to limit the number of providers under the provisions of §1915(b) or another provision of the Act.
- F. FFP Limitation.** In accordance with 42 CFR §433 Subpart D, FFP is not claimed for services when another third-party (e.g., another third party health insurer or other federal or state program) is legally liable and responsible for the provision and payment of the service. FFP also may not be claimed for services that are available without charge, or as free care to the community. Services will not be considered to be without charge, or free care, when (1) the provider establishes a fee schedule for each service available and (2) collects insurance information from all those served (Medicaid, and non-Medicaid), and bills other legally liable third party insurers. Alternatively, if a provider certifies that a particular legally liable third party insurer does not pay for the service(s), the provider may not generate further bills for that insurer for that annual period.
- G. Fair Hearing:** The State provides the opportunity to request a Fair Hearing under 42 CFR §431 Subpart E, to individuals: (a) who are not given the choice of home and community-based waiver services as an alternative to institutional level of care specified for this waiver; (b) who are denied the service(s) of their choice or the provider(s) of their choice; or (c) whose services are denied, suspended, reduced or terminated. **Appendix F** specifies the State's procedures to provide individuals the opportunity to request a Fair Hearing, including providing notice of action as required in 42 CFR §431.210.
- H. Quality Improvement.** The State operates a formal, comprehensive system to ensure that the waiver meets the assurances and other requirements contained in this application. Through an ongoing process of discovery, remediation and improvement, the State assures the health and welfare of participants by monitoring: (a) level of care determinations; (b) individual plans and services delivery; (c) provider qualifications; (d) participant health and welfare; (e) financial oversight and (f) administrative oversight of the waiver. The State further assures that all problems identified through its discovery processes are addressed in an appropriate and timely manner, consistent with the severity and nature of the problem. During the period that the waiver is in effect, the State will implement the Quality Improvement Strategy specified in **Appendix H**.

Comments and suggestions were received by the California Assisted Living Association and other vested groups and were considered and as appropriate, incorporated into this waiver renewal.
- An additional Stakeholder Teleconference was held on November 14, 2013. Additional comments and suggestion were received and will be considered for future amendments.
- J. Notice to Tribal Governments.** The State assures that it has notified in writing all federally-recognized Tribal Governments that maintain a primary office and/or majority population within the State of the State's intent to submit a Medicaid waiver request or renewal request to CMS at least 60 days before the anticipated submission date is provided by Presidential Executive Order 13175 of November 6, 2000. Evidence of the applicable notice is available through the Medicaid Agency.
- K. Limited English Proficient Persons.** The State assures that it provides meaningful access to waiver services by Limited English Proficient persons in accordance with: (a) Presidential Executive Order 13166 of August 11, 2000 (65 FR 50121) and (b) Department of Health and Human Services "Guidance to Federal Financial Assistance Recipients Regarding Title VI Prohibition Against National Origin Discrimination Affecting Limited English Proficient Persons" (68 FR 47311 - August 8, 2003). **Appendix B** describes how the State assures meaningful access to waiver services by Limited English Proficient persons.

Home and Community-Based Settings Transition Plan

California assures that the settings transition plan included in this amendment will be subject to any provisions or requirements included in California's approved Statewide Transition Plan. California will implement any required changes upon approval of the Statewide Transition Plan, and will make conforming changes to the Waiver when it submits the next amendment or renewal.

Statewide Transition Plan Regarding Assisted Living Waiver

• This waiver offers eligible seniors and persons with disabilities age 21 and over the choice of residing in either a licensed Residential Care Facility for the Elderly or independent Publicly Subsidized Housing (PSH) private residences with Home Health Agency services as alternatives to long-term institutional placement. The majority of Publicly Subsidized Housing units serve low-income applicants, while a percentage of units are designated for ALW members. The goal of the ALW is to facilitate nursing facility transition back into community settings or prevent skilled nursing admissions for beneficiaries with an imminent need for nursing facility placement. Eight care coordinator agencies serving seven counties independently maintain wait lists. The current waiver was approved on March 1, 2014 for five years, through February 28, 2019.

ALW provider types include the following:

o Care Coordination Agency

- o Home Health Agency in Public Subsidized Housing
- o Residential Care Facility for the Elderly

Monitoring and Oversight Process

In keeping with state laws and regulations, and CMS approved Waiver and State Plan commitments, California's HCBS programs currently conduct periodic reviews of their care-management entities, providers, and residences of program members. Prior to implementation of the HCB Settings Final Rule, HCBS programs were required to conduct site visits to monitor and assess federal assurance compliance. Among the activities conducted during these on-site visits are member record reviews, member and staff interviews, home visits, person-centered plan review, and special incidents review,

In order to assess current settings and ensure ongoing compliance with the HCB Setting Final Rule, the State has expanded its current processes to include activities that will ensure compliance with the Final Rule, and remediation strategies to achieve compliance in the event a setting does not meet the HCB criteria. The state has developed an at-a-glance view of California's monitoring and oversight process demonstrating each programs approach to on-site assessments and compliance with the HCB Settings Final Rule.

Private Residences Presumed to be in Compliance

CMS issued home and community-based (HCB) settings regulations which define HCB settings based on individual experience and outcomes with the purpose of maximizing the opportunities for members receiving Medicaid HCB services to receive those services in integrated settings. In formulating a plan to implement these regulations, California has determined that the following types of non-provider owned or controlled private residential settings qualify as HCB settings:

1. Private residences owned, leased or rented by the member, a relative of the member, a conservator, or any other individual legally authorized to represent the member.
2. Private residences may take a variety of forms provided they still afford members with access to the community as required by the new HCBS definitions. A private residence may be a single family home, apartment, rental unit or any other space in the greater community.
3. Private residences where the member pays for part or all of the lease costs with the assistance of federal, State, or local funding. Examples include:
 - Affordable Housing Apartment Complexes funded by a combination of Low Income Tax Housing Credits, California State Housing and Bond initiatives, Housing and Urban Development, City and County local and federal funds, and bank financing, where residential eligibility is income based.
 - Housing and Urban Development (HUD) Section 8 Housing Choice Vouchers, which can be used to pay for housing anywhere that accepts vouchers. This includes the Medi-Cal partnership with the Housing Authority of the City of Los Angeles (HACLA), for section 8 vouchers for Medi-Cal seniors residing in skilled nursing facilities (SNFs) who would like to return to the community. All units must meet the applicable Housing Quality Standards (HQS) set forth in 24 C.F.R. § 982.401.
 - HUD Non-Elderly Disabled Vouchers, which can be used by disabled individuals to live in any residence of their choice that accepts these vouchers. These vouchers do not require that the residences are limited to disabled residents. All units must meet the applicable Housing Quality Standards (HQS) set forth in 24 C.F.R. § 982.401.
 - HUD Shelter Plus Care and Continuum of Care Vouchers, issued to people experiencing homelessness. This program provides case management supportive services to the homeless but do not require the residence be restricted to the homeless. All units must meet the applicable Housing Quality Standards (HQS) set forth in 24 C.F.R. § 982.401. All units must meet the applicable Housing Quality Standards (HQS) set forth in 24 C.F.R. § 982.401.
 - HUD Section 811 Project Rental Assistance Demonstration Program. For this program, no more than 25% of the units can be set-aside for 811 tenants, which results in a mix of tenant types. All units must meet the applicable Housing Quality Standards (HQS) set forth in 24 C.F.R. § 982.401.
 - Veterans Affairs Supportive Housing vouchers issued to homeless veterans and disabled veterans to help them pay for housing.
 - Veteran Housing and Homeless Prevention Program, which acquires, constructs, rehabilitates and preserves affordable multifamily housing for veterans and their families.
 - HUD Section 202 Senior Housing rent subsidies for very low-income households with at least one person who is at least 62 years old.
 - LA Department of Health, Housing for Health, rental subsidies and supportive services for persons who are homeless, for use in a variety of community-based housing options such as non-profit owned supportive housing with units dedicated to serving homeless individuals and/or families, long term leases of privately owned buildings, and scattered site housing

units rented from private landlords.

Consistent with CMS' HCB settings rules, California presumes that these non-provider-owned or controlled private residential home settings qualify as HCB settings. The members realize the benefits of community living, including opportunities to seek employment and work in competitive integrated settings. The State presumes these settings do not isolate the member from the broader community, and do not have the characteristics of an institution. These settings do not control the personal resources of the member, or utilize interventions or restrictions that exist in institutional settings. HCB Settings will be determined compliant through existing monitoring and oversight practices, if the individual's person-centered service plan addresses their unique needs and the required setting characteristics. If it is discovered through the course of normal reviews that an individual's person-centered service plan does not address an individual's unique needs for HCB Setting qualities and a setting is non-compliant, members will have access to: 1) compliant settings, 2) settings of their choice, and 3) not lose federally funded HCBS while waiting for compliant settings; via standard corrective action processes which typically last 60 days but are no longer than 90 days. Only when a setting, including a private residence, does not fully demonstrate HCB Settings remediation on the 90th day will an individual have to choose between:

- 1) Remaining in a non-compliant setting and loss of HCBS with referrals to other services, or
- 2) Relocating to a compliant setting with continuity of HCBS. Relocation to a compliant setting may take an additional 90 days in which case, a member will continue to have access to HCBS.

In the event of conflict between the final rule and additional guidance issued by CMS, the final rule will solely be followed.

Individuals living in these settings, or utilizing the described subsidies or vouchers to pay for rent in non-provider owned and controlled dwellings, personally select their homes that include non-disability specific settings and options for a private unit in a residential community setting. The individual decides whether or not to share a room with a person of their choice. Residents in these settings who are receiving HCB services are treated with the same respect and dignity as persons not receiving HCB services. The settings do not restrict the member from interaction with other non-disabled people or other persons with disabilities in the broader community. These settings do not restrict the member's independence in making life choices. The settings do not restrict the member's choice of HCB services and supports or who can provide those services.

Notably, California law governs all of these private residences in ways that makes them meet the minimum qualifications for HCB settings. Residential rental agreements are subject to fundamental Code limitations. Several provisions in residential rental agreements are deemed invalid as contrary to public policy and, if included, will be unenforceable. These statutory limitations demonstrate the legislative recognition of the unequal bargaining power historically typifying residential landlord-tenant relationships. The codes help prevent the unknowing signing away of valuable rights by tenants who may not fully understand the rental agreement. (See *Jaramillo v. JH Real Estate Partners, Inc.* (2003) 111 CA4th 394, 402-403.) A member living in these settings has a legally enforceable agreement for the housing which ensures the member's rights of privacy, dignity and respect, and freedom from coercion and restraint. Residential rental agreements cannot waive or modify any of the following tenant rights:

- Tenant's right to return of security deposit under Civil Code sections 1950.5(m) and 1953(a)(1);
- Tenant's right to protection under the implied warranty of habitability under Civil Code section 1942.1;
- Tenant's statutory protection against "retaliatory eviction" by the landlord under Civil Code section 1942.5;
- The tenant's right to have the landlord exercise a lawfully-imposed duty of care to prevent personal injury or property damage, under Civil Code section 1953(a)(5);
- Statutory limitations on the landlord's right to access the rented unit during the lease term under Civil Code § 1953(a)(1). The rights of a Landlord to enter a dwelling are limited to certain conditions under Civil Code section 1954;
- Tenant's right to assert a cause of action against the landlord under Civil Code section 1953(a)(2);
- Tenant's right to legally-required notice and hearing, including three or 30/60-day notice to terminate the tenancy, filing of a response to an unlawful detainer complaint, and an unlawful detainer trial, under Civil Code section 1953(a)(3) and (4). The non-waivable right to three-day notice also applies to federally-subsidized (HUD) rental housing. In federally-subsidized "Section 8" housing, landlords are required to give 90 days' written notice under Civil Code section 1954.535 and specify "good cause" to evict. In rent control jurisdictions, some form of "eviction control" restricts the grounds upon which tenancies may be terminated. Some local controls are quite extensive and others very selective.
- A landlord must allow a tenant with a disability to make reasonable modifications to the rental unit to the extent necessary to allow the tenant "full enjoyment of the premises." (Civil Code § 54.1(b)(3)(A).)
- Landlords of "buildings intended for human habitation" must install dead bolt locks on each "main swinging entry door of a dwelling unit" and exterior doors that provide ingress or egress to common areas with access to dwelling units in multifamily developments (Civil Code § 1941.3(a).) Any dwelling unit which lacks a proper lavatory or kitchen sink, bathtub shower, or less room or space dimensions than required by code, to an extent that endangers the life, limb, health,

property, safety, or welfare of the occupant, is deemed substandard. (Health & Safety Code § 17920.3) “Dwelling unit” means a structure or the part of a structure that is used as a home, residence, or sleeping place by one person who maintains a household or by two or more persons who maintain a common household. (Civil Code §1940(c).) Landlords are responsible for installing at least “one usable telephone jack” and the placement, maintenance and repair of inside telephone wiring “in good working order.” (Civil Code § 1941.4.)

- A residential rental agreement compelling binding arbitration of disputes over a tenant’s rights or obligations falls within the section 1953(a)(4) bar, and thus is void, because inherent in an arbitration agreement is the waiver of any right to a jury trial. (Jaramillo v. JH Real Estate Partners, Inc., supra, 111 CA4th at 403-404.)
- As a matter of state constitutional law, a contractual provision waiving the right to a jury trial in advance of pending litigation is unenforceable because it is not one of the ways the Legislature has directed that a jury may be waived. (Cal. Const. Art. I, § 16; Code of Civil Pro. § 631(d)).
- The California Fair Employment and Housing Act effectively makes protection from unlawful housing discrimination a non-waivable tenant right. (Gov. Code §§ 12920, 12955; see also Gov. Code § 12921(b).)

Other Residential Settings

The State presumes private residences meet the HCB settings requirements and are deemed in compliance; however, as required by CMS, California will assess all residential setting types that are not identified above as presumed compliant with the HCB Setting requirements through provider and on-site assessments. The State will not disallow settings with disability-friendly and supporting amenities and programmatic aspects. The Final Rule states that disability-specific housing and congregate settings are permissible, and that there is no singular definition of home-and-community based. HCBS recipients will be able to choose from all residential settings, including those designed specifically for HCBS recipients, that meet the HCB Settings requirements by March 2019.

California’s Statewide Transition Plan

This STP identifies the framework and strategy for achieving and maintaining compliance with the federal requirements for HCB settings in California.

California’s HCBS waiver and 1915(i) State Plan program differ significantly in the populations they serve, their size and complexities, and their statutory and regulatory structures, among other differences. The largest and most complex are the DD Waiver and the 1915(i) State Plan program, where the programs serve approximately 130,000 members in the provision of a vast array of residential and nonresidential services that are separately licensed and/or regulated. Participation in the DD Waiver is not required to access the State’s full array of available developmental services. Providers are not separately identified for DD Waiver or 1915(i) State Plan program purposes; therefore, all providers potentially utilized for HCBS must be in compliance with the HCB setting requirements. For the developmental services system over 300,000 members, are potentially affected by the new requirements.

In contrast, the SFCLSB Waiver, with 17 beneficiaries, represents the smallest 1915(c) waiver in California. Eligibility is open only to San Francisco residents who meet level of care eligibility and require at least one of six available services.

This STP identifies at a high level the commitments and requirements that each of the eight HCBS waivers, 1915(i) and 1915(k) State Plan programs, and 1115 waiver will meet. The specific approach and details of each program’s transition process will reflect the input and guidance of the particular program’s stakeholders, and the unique structure and organization of the program itself. The complexity of each task will vary significantly across programs.

Resources to address and implement the many changes necessary to be in compliance with the regulations are and will continue to be limited. When resources are needed, they must be raised and vetted through the annual legislative budget process, which only allows for new resources prospectively, typically in the upcoming state budget year. Therefore, careful thought and analysis must go into every aspect of implementation in an effort to achieve compliance as cost effectively as possible. Since program systems and processes have long been established in California, standard processes will be considered for modification to bring about and ensure ongoing compliance, such as revising existing monitoring and oversight protocols to incorporate the regulatory requirements, utilizing available data, such as the National Core Indicator (NCI) and expanding existing complaint and appeal processes to allow for member and/or provider due process when disputes arise.

Stakeholder Input

To achieve compliance, California will strongly emphasize inclusive stakeholder processes that analyze and guide implementation. Essential involvement will come from members. Their input concerning how they experience community inclusion and freedom of choice will be critical for system changes and implementation strategies. Also essential is provider input. Providers are the backbone of the system, ensuring that services and choices are available to

members. How the regulations are implemented may affect the viability of providers as sustainable businesses. Stakeholder processes will also include entities and experts who are impacted by, or are knowledgeable about, the various topics, particularly, the California Department of Social Services as the licensing agency (Community Care Licensing [CCL]) for many of the HCB settings.

As the State continues this process, stakeholder input will evolve over time as implementation phases progress, as described below. With the stakeholder input, specificity will be added and/or modifications will be made to the various components identified in the STP.

Following is a summary of California's efforts to elicit stakeholder input and subsequent comments received to date on the STP. Please note: the Revised Draft CBAS Home and Community-Based (HCB) Settings Transition Plan details a separate stakeholder engagement process.

DHCS posted the first STP draft to the DHCS website on September 19, 2014, followed by a 30-day stakeholder input period, and the second STP draft on November 7, 2014, followed by another 30-day stakeholder input period. In addition, DHCS posted general public interest notices about impending public comment periods and meetings regarding development of the STP in the California Regulatory Notice Register on March 3, 2014 and April 25, 2014. The Register is available in print at public libraries as well as other public places. DHCS also posted a general public interest notice to inform stakeholders of a conference call on July 13, 2015, to discuss the revisions made to the STP, as well as to discuss comments received on the On-Site Assessment Tools and Provider Self-Survey Tools. Other notices were sent by the individual departments with responsibility for specific waivers; e.g., CDPH communicated directly with HIV/AIDS Waiver stakeholders; CDA with MSSP sites and CBAS centers; and DDS with Regional Centers.

DHCS received CMS feedback on the previously submitted STP on November 16, 2015. The letter can be found at: <https://www.medicaid.gov/medicaid-chip-program-information/by-topics/long-term-services-and-supports/home-and-community-based-services/downloads/ca/ca-cmia.pdf>. CMS hosted a series of conference calls with the State to discuss CMS feedback and clarify the STP requirements outlined in the letter. The current STP draft, which addresses CMS' requirements, was posted to the DHCS website on August 29, 2016 for public review and input. Public comment was analyzed and incorporated into the STP. DHCS also hosted a stakeholder conference call on September 27, 2016, to discuss revisions to the STP and respond to questions or concerns.

Implementation of the HCB Setting Requirements

Following is a description of the various phases of implementation that California will undertake to achieve compliance with the HCB setting requirements. California will move forward concurrently with many of the components listed below. As described previously, the details of implementation will vary significantly across the HCBS Waiver, 1915(i) and 1915(k) SPAs, and 1115 Waiver, program and be integrally guided by stakeholders. As remedial strategies are solidified, actions and timelines will be identified to track progress against objectives based on resources available.

Consistent with the above, additional State resources must be requested via the State legislative and budget processes. To ensure awareness of these needs, staff from the California Department of Finance and the State Legislature are invited to attend ongoing stakeholder meetings.

Education, Outreach, and Training

As an important early step, information and education on the requirements of the HCB setting requirements and the regulations generally has been provided to State departments/entities, members and families, care-coordination agencies, regional centers, providers, advocacy groups and other interested stakeholders throughout the State on a continuous and ongoing basis. California has used website postings, conference calls, webinars, and public hearings as methods for getting information about the Final Rules widely disbursed. Additionally, all affected parties will be informed of the ongoing methods for providing input, being involved and staying informed as implementation progresses. Ongoing communication methods will be developed with stakeholder input. DHCS will coordinate with sister departments to produce and disseminate additional outreach and educational materials as needed to continuously update and provide information to the public.

California is utilizing several methods for communicating information about the HCBS rules and how the state's transition plan assures their effective implementation. Major efforts include:

- Developing and widely disseminating general informational fliers to members and their families, providers, managed care plans, regional centers and other care coordination agencies, as well as the broader communities where members live and the general public.

- Conducting webinars and face-to-face or online training sessions specifically tailored to members and their families, providers, and care coordination agencies.
- Regularly posting and updating informational documents and FAQs about the HCBS rules on department websites.
- Seeking ongoing input from stakeholder groups convened by the several departments.
- Providing program policy and operational instructions through official correspondence, provider bulletins and regulatory changes.

The initial rollout of these education and outreach activities is taking place through Spring 2017. As various aspects of HCBS implementation proceed throughout 2017 and 2018, California will continuously update and disseminate information through department websites, official correspondence, advocacy groups and HCBS Advisory Committees. Feedback and comments from the various stakeholders will validate the efficacy of the state's outreach and training strategy.

Systemic Assessment of Statutes, Regulations, Policies and Other Requirements

DHCS and the State departments/entities responsible for operating each HCBS Waiver, 1915(i) and 1915(k) State Plan programs, and 1115 Waiver reviewed and analyzed the applicable statutes, regulations, and policies governing residential and nonresidential HCB settings to determine the extent to which they comply with federal regulations. Departments requested stakeholder participation for input into the systemic assessment process to determine whether each standard is in compliance, out of compliance or whether the standard is silent on the federal requirement. Beginning early in 2015 the State engaged assistance from stakeholders who are required to adhere daily to California law, program regulations, and program policies.

Each department convened stakeholders via webinar, teleconference, and/or face-to-face meetings, and encouraged stakeholder input either directly during the meetings, by email, USPS mail, and telephone. Stakeholder involvement in review and analysis of statutes, regulations, and policies varied by program. For example, the sheer number of residential and non-residential HCB settings available to persons with developmental disabilities through the HCBS waiver and State Plan benefits required an extensive process to consider, deliberate, and validate existing State standards and policies.

The initial draft systemic assessment process was completed July 1, 2015, and following incorporation of public input, finalized August 6, 2015. To address issues CMS identified in the systemic assessment in its letter dated November 16, 2015, the State reexamined its findings. During a series of meetings among the State departments, and as a result of discussions with CMS teams, updates have been made to the August 6, 2015 version. The revised systemic assessment indicates where specific programs will take action to bring their statutes, regulations and policy documents in conformance with the federal requirements. Given the amount of time required to effect statutory or regulatory changes in California, programs will develop and implement any needed changes during 2017 and 2018.

Please note that the systemic assessment is an indication of compliance, but does not preclude settings from further compliance determination processes, such as Provider Self-Surveys, Beneficiary Self-Surveys, and On-Site Assessments.

The State believes there is opportunity to implement policies and strategies in alignment with the HCB Settings Final Rule that will enhance and strengthen existing local practice during the upcoming legislative cycle. The Department of Developmental Services is considering what, if any, statutory changes may be needed to allow for the department to administer and release timely and appropriate policies for implementing STP activities.

Compliance Determination Process for HCB Settings

The State departments/entities will be responsible for ensuring appropriate provision of HCBS by all providers that serve, or may serve Medi-Cal members. California's assessment of HCBS providers will involve several distinct sets of activities that will feed into one another. All of these activities require large amounts of data in the planning stages, and will produce similar amounts of data needed for ongoing operations, program reporting to state management and CMS, and evaluation and program improvement. Some of the initial types and sources of data include member eligibility files, provider certification and payment files, program administration files, sampling, selection criteria, and validation protocols.

The first set of activities centers around provider self-surveys of their existing operations compared to the new requirements in the federal regulations. DHCS and State departments have developed an agency-wide core Provider Self-Survey Tool, which will be forwarded to all HCB settings for completion. The core survey tool may be modified, including guidance and instructions, to address specific provider types and programs.

The different HCBS programs may use both electronic and mail distribution processes to send the survey instruments and guidelines to providers. Additionally, California will host training webinars on the provider self-survey process and expectations, and will post follow up information on program websites. The survey distribution and training processes generally will begin the fourth quarter of 2016 and continue through the second quarter of 2017.

Depending on provider type, providers will have up to 60 days to complete and return their self-surveys. Programs will follow up with providers with reminder emails and phone calls. The outcome for not completing and returning the Provider Self-Survey varies by provider type. Some settings that fail to complete and return the Provider Self-Survey will be subject to an on-site assessment. Other settings such as CBAS require the Provider Self-Assessment to be completed as part of the certification renewal process and failure to do so could result in their not being re-certified. Completion of provider self-surveys is targeted for the third quarter of 2017, except for programs such as CBAS which is integrating the provider self-surveys with other information required in preparation for their biennial certification visits through 2018.

Program staff, or care coordination agencies and regional centers, will analyze returned self-surveys and identify them according to whether or not they meet the CMS readiness criteria. As appropriate, departments may review returned Provider Self-Surveys to validate results and promote consistency in determinations. Providers whose self-surveys do not indicate that they fully meet the criteria will be further categorized by the type and level of remediation needed to achieve compliance. Those needing corrective action through technical assistance (e.g., documenting procedures, staff training on the new requirements, reiterating rights and responsibilities to members and their representatives, etc.) will implement corrective action, monitored by program staff, care coordination agencies and regional centers. Those needing more extensive corrective action may be scheduled for on-site assessments.

Secondly, surveys of members will pose non-threatening questions to effectively elicit members' thoughts and feelings about the HCBS they receive, their ability to actively participate in life decision making, and any problems they encounter. Member survey instruments also need to be tailored to the several different types of populations receiving HCBS—the elderly; persons with developmental disabilities, cognitive impairments, or mental illness; the physically disabled; AIDS patients; children needing palliative care in addition to treatment for acute diseases.

DHCS will develop Member Survey core questions and elicit feedback from advocates and stakeholders prior to finalizing the survey. These core questions will be incorporated in existing policies and procedures used by the various programs for member interviews, service planning, and complaint investigations.

Conducting member surveys will take many different forms during 2017. To avoid confusion and to assure the consistency and reliability of member input, California will not distribute member surveys in mass through the mail or electronic media. Instead HCBS programs will conduct face-to-face interviews with members or their authorized representatives as often as possible. For example, HCBS programs which use periodic recertification of member eligibility or reassessment of need for services may add the core questions to their recertification or reassessment processes. Programs which make on-site visits to HCBS providers or to member homes may interview members during these visits. Complaint investigations will include the opportunity to ascertain how members see their ability to access community resources.

Since many members receive HCBS from more than one provider, the focus will be on the HCBS provider(s) with which the member resides or spends a significant amount of time (i.e., 4 hours) on a regular basis. Member input can be linked to identified providers through each program's system for storing provider information.

In addition to corroborating information garnered from provider self-surveys and on-site assessments, member input will play an essential role in quality assurance and program improvement efforts. Its impact is felt in the scope and duration of HCBS that programs offer, the types and qualifications of providers used, and how services are financed.

On-site assessments are the litmus test for ascertaining provider compliance with the federal settings requirements. These assessments will confirm compliance or identify areas for remediation. DHCS and State departments have developed an agency-wide core On-Site Assessment Tool, for use in the On-Site Assessments of HCB settings. The core assessment tool includes questions that relate to each new federal requirement that will be used to determine if the HCB setting meets or does not meet the required federal rule. The core assessment tool may be modified to address specific provider types, including guidance and instructions, and will become the assessment tools utilized by the appropriate State departments/entities administering the program.

The responsibility for ensuring completion of On-Site Assessments rests with the State department/entity responsible for the program as specified under "HCBS Programs in California Affected by the Final Rules" section of this document. On-Site Assessments will be conducted by a survey team that includes, but is not limited to, representation from any or a combination of the following: State personnel, case managers or other representatives of case management entities, and licensing entities.

Depending upon the HCBS program's size and diversity of provider types, the selection of providers for on-site assessments can be done on the basis of several factors that may include:

- Statistically valid samples
- Annual or biennial regularly scheduled site visits for licensing or certification purposes
- The responses to the provider self-surveys, member input, and other factors like staff's knowledge of provider operations, including a history of site visits, complaints, and corrective actions
- The provider's location being on or adjacent to institutional settings.

On-Site Assessments and Member Surveys will be used to validate Provider Self-Surveys for a sample of settings by provider type category. In the event that the results of a Provider Self-Survey differ from information gathered through validation activities, an in-depth review will occur to determine the reason for the discrepancy and identify the appropriate course of action, which could include, but not be limited to additional provider education, surveying additional members, or an additional On-Site assessment. Similarly, if a general pattern of Provider Self Survey and validation discrepancy is found across a provider type category, the State will conduct an in-depth review to identify the source of the discrepancy. Follow-up actions in this case could include, but not be limited to increasing the number of planned On-Site Assessments and Member Surveys to validate the results of the Provider Self Surveys. On-Site Assessments and Member Surveys will be ongoing until remedial strategies are identified and implemented. On-Site Assessments and Member Surveys will be incorporated into ongoing monitoring protocols as a part of existing processes.

There are HCBS providers which may serve members from several different HCBS programs. To ensure consistency and avoid duplication of effort, the program which has primary responsibility for monitoring and oversight of the providers will conduct any necessary on-site assessments. Other programs may rely on the findings of the responsible agency as to the providers' compliance with the federal requirements.

Like the analysis of provider self-surveys, on-site assessments will determine if a specific provider is in compliance with the federal settings requirements, or needs to implement corrective action to achieve compliance. The written results of each On-Site Assessment will be forwarded back to the HCB setting with specific information regarding improvements that will be required in order for the setting to come into compliance with the federal requirements and a timeline for completion. Remedial actions will be developed to include timelines, milestones and a description of the monitoring process to ensure timelines and milestones are met. Follow up of the compliance issues will be the responsibility of the administering State department/entity. Completed assessments, including documentation of any required follow-up actions as a result of the On-Site Assessments, will be maintained by the appropriate department

The following is a count of settings to be assessed, by program, and their corresponding sample size for validation, which was calculated using the Raosoft Sample Size Calculator:

HCBS Alternatives Waiver:

Congregate Living Health Facility - 54 settings, sample size is 48.

Heightened Scrutiny Process

The State must identify settings that are presumed to have institutional qualities. These settings include those that: are in a publicly or privately-owned facility that provide inpatient treatment; are on the grounds of, or immediately adjacent to, a public institution; or settings that have the effect of isolating individuals receiving Medi-Cal funded HCBS services. Settings that have one or more of these characteristics must be approved by CMS to continue to receive Medi-Cal HCBS funding. The State must demonstrate, through evidence presented by the State and public input, that the setting meets the HCB setting requirements.

Settings that may have the effect of isolating HCBS members are settings designed to provide members with multiple types of services and activities on-site, including housing, day services, medical, behavioral and therapeutic services, and/or social and recreational activities. These settings provide little or no interaction with the broader community and use interventions or restrictions that are used in institutional settings. The State will identify specific characteristics of settings that tend to isolate through a stakeholder engagement process.

Using Provider Self-Surveys, On-Site Assessments and other monitoring activities, Member Surveys and stakeholder input, the State will identify settings that are in publicly or privately owned facilities that provide inpatient treatment; are on the grounds of, or immediately adjacent to, public institutions; or have the effect of isolating individuals receiving Medi-Cal funded HCBS services. These settings will be required to submit evidence to the State to demonstrate how they have the qualities of HCBS, which the State will then review and submit to CMS if the setting is believed to overcome the institutional presumption. The evidence should focus on the qualities of the setting and how it is integrated in and supports full access to the community. Specific evidence to be submitted may include:

1. Licensure requirements or other state regulations that clearly distinguish a presumed institutional setting from licensure or regulations of institutions;
2. Provider qualifications for staff employed in the setting that indicate training or certification for HCBS, and that demonstrate the staff is trained specifically for HCBS in a manner consistent with the HCB setting requirements;
3. Procedures that indicate support for activities in the greater community according to the individual's preferences and interests; and
4. Description of the proximity to avenues of available public transportation or an explanation of how transportation is provided when desired by the member.

All settings submitted for heightened scrutiny must complete a Provider Self-Survey and will be subject to an On-Site Assessment where Member Surveys will be conducted. The State's heightened scrutiny review process will consist of:

- A review of evidence provided by the setting;
- A review of the setting's policies and services;
- An on-site visit and an assessment of the physical characteristics;
- A review of policies and procedures governing person-centered plan development and implementation;
- Member interviews and observation;
- Collection of evidence to submit to CMS in order to overcome the institutional presumption.

The State must determine, using input from the public, members, stakeholders, and providers whether or not it believes the setting overcomes the institutional presumption. The evidence required to overcome institutional presumptions must be submitted to the settings' contractor (e.g. care coordination agencies or regional centers) within forty-five (45) days of its identification for the heightened scrutiny process. The contractor will review the evidence submitted, follow up with the setting for any necessary documentation, and make a recommendation to the corresponding State agency overseeing the program. The State agency will review the evidence, follow up with the contractor to request missing documentation, and recommend to DHCS a compliance determination. DHCS will review evidence and recommendations and will follow up if necessary with an On-Site Assessment and Member Survey to ensure all necessary information is obtained before making a determination of whether or not the setting overcomes the institutional presumption.

The State will work with settings when necessary to develop remediation strategies and timelines specific to each setting to achieve full compliance with the final rule. In the event that a setting cannot achieve compliance with the HCB settings rule, the transition of members will be conducted as described under the STP section "Changes in Services or Providers for Members."

Changes in Members' Services or Providers

Currently California's HCBS programs have policies and procedures, which allow for changes in members' services or providers. These changes may occur due to several factors including:

- Changes in a member's need for specific types or intensity of services
- The member's selection of different service options available to meet needs
- The member's dissatisfaction with a provider's services or personnel
- Changes in a provider's staffing, hours of operation, or location
- Provider closure
- Provider withdrawal or suspension from the Medi-Cal program

Written notification to the member and the provider is given at least 30 calendar days in advance of the effective date of the change, identifying the specific reason(s) for the change. This notification also informs the member of their right to a fair hearing under Medi-Cal, including Aid Paid Pending if timely requested.

The initial steps in addressing the impending change include reviewing the member's person-centered service plan; reevaluating the goals and objectives, needs, preferences and choices of the member; and identifying the options available. The person-centered service plan meeting would include the member, involved family members, conservators, authorized representatives, advocates, the care management agency or regional center coordinator, and provider staff who know the member well. To ensure a smooth transition from one provider to another, a transition plan outlining the specific transition activities, including any necessary supports and services needed to ensure a successful and person-centered transition, is incorporated into the person-centered service plan.

When one of California's HCBS programs determines that a setting is not in compliance with the HCB settings requirements, the first order of business is the setting's development of a workable remediation plan to come into full compliance with the HCBS Settings Rules over a reasonable timeframe. However, if the provider owned and operated residence or day program provider cannot come into compliance with the HCBS Settings Rule by March 2019, the program will initiate its policies and procedures to transition, if possible, affected members to compliant settings so they can continue to receive federally funded HCBS.

When choosing provider owned and operated residences, members have the opportunity to explore integrated living options that match their identified service and support needs and choices. Considerations may include:

- Exploring the variety and types of community living options currently available (e.g., non-disability settings, supported living, small group homes, family home agencies)
- Proximity to services in the community
- Employment opportunities
- Needed medical services

Until California completes the process of assessing provider settings and determines appropriate remediation plans, it cannot estimate the number of individuals that may need to be transitioned eventually to other settings.

Milestones and Timeline

In order to illustrate the variety of compliance determination activities the State has performed, or will perform, California has developed a comprehensive milestones and timeline document for stakeholders to reference. It provides a convenient view of the milestone activities described in detail throughout the STP, and their associated timelines for completion.

Role of Person-Centered Planning

Even though implementation of the new federal regulations affecting the person-centered service planning process is not technically part of this STP, person-centered service planning is inextricably linked to the HCB setting requirements. The State department/entity responsible for program administration will use a stakeholder process to evaluate the role of person-centered service planning as it relates to determining compliance with the federal regulations, assessing member satisfaction with the setting options, and other possible community integration issues. Strategies may be developed to utilize information from the person-centered service planning process to improve service delivery under the federal regulations.

Public comment supports the idea of the State's understanding regarding home-like and community integration within a persons' individual plan of care and basic civil right. DHCS believes community is not the mere physical presence of other buildings and people. It includes a safe and purposeful environment where individuals have needed support and safety, and the greatest freedom to live productive, connected lives according to their own desires.

The person-centered service plan documents the member's choice of settings and services based on the needs and preferences of the member. The State will take into account the options provided and choice of the member or their parent or legal guardian when determining HCB settings compliance, thus keeping the end goal of optimizing autonomy, independence, and member choice in mind. The State is committed to participating in all opportunities to enhance person-centered HCBS and increasing monitoring, oversight and enforcement of person-centered service planning. Person-centered service planning activities will be performed outside the purview of the STP.

The State will ensure through STP activities and ongoing monitoring and oversight that the person-centered service plan documents member choice, needs, preferences, and goals. Any modification to the HCBS setting requirements must be documented and supported by the person-centered service plan and will only be made on an individual basis. For example, certain HCBS members will have a documented need to reside in a setting utilizing delayed egress and/or secured

perimeters. State statute and regulation clearly identify the policies and procedures for implementing such interventions .

Appeal Processes

As the State assesses HCBS settings for compliance with the Final Rule, providers and members will have an opportunity appeal compliance determinations made that result in loss of funding for providers or loss of service and/or member relocation of residence. In addition to the appeals and grievance policies that exist for each individual program, and department, providers and members may utilize existing state processes to file an appeal. There are two distinct processes that providers and members may use to file appeals with the State.

Provider Appeals:

In the event that a setting is determined non-compliant and cannot or will not address issues of non-compliance through remediation, the provider has the option of filing an appeal through the Office of Administrative Hearings and Appeals (OAHA). OAHA is an independent hearing office created by DHCS to provide an appeals process for enrolled Medi-Cal providers to dispute actions taken by the Department. Member Appeals:

Members looking to dispute an HCBS setting determination by the State resulting in a loss of services and/or unwanted relocation of residence may file an appeal through the Medi-Cal Fair Hearing process. Compliance Monitoring

Each HCBS Waiver and 1915(i) State Plan program, in consultation with stakeholders, will use the self-surveys, On-Site Assessments and/or other data collection methods, to develop remedial strategies and monitor progress toward compliance with the federal regulations. All State-level and individual-setting level remedial actions will be completed no later than March 17, 2019.

The State will ensure that HCB settings remain in compliance with the new requirements by utilizing current ongoing licensing and/or certification processes for both residential and non-residential settings, as well as weaving compliance reviews into current monitoring and oversight processes.

Plan Updates and CMS Reporting

During the implementation period, progress on this STP will be continuously monitored and reported to CMS, as needed.

Appendix B - Systemic Assessment Summary

6. A legally enforceable agreement between the provider and the consumer that allows the consumer to own, rent or occupy the residence and provides protection against eviction.
7. Privacy in units including lockable doors, choice of roommates and freedom to furnish and decorate units.
8. Options for individuals to control their own schedules including access to food at any time.
9. Individuals the freedom to have visitors at any time.

The Assessment Tool is based on the Minimum Data Set (MDS) and is designed to facilitate the assessment and determination of waiver eligibility by the CCA RN. The Assessment Tool is electronically scored in an Excel spreadsheet format. The CCA RN enters the data and the Assessment Tool automatically specifies the tier(s) of service for an eligible participant. The Assessment Tool was alpha and beta tested prior to implementation and was updated to strengthen the validity of the tool. The Assessment Tool provides a consistent determination of waiver eligibility and has demonstrated consistency from user to user.

The Assessment Tool used by ALW is different from the tools used to determine institutional LOC because it is designed to determine not only LOC but also a specific tier level exclusive to ALW services and the daily rate that will be paid to the RCFE or HHA to provide the necessary daily care. These tier levels are based on the waiver participants care needs. As care needs change the participant's tier level will change.

DHCS employs several methods to ensure meaningful access to waiver services by Limited English Proficient (LEP) individuals, in accordance with §50514 of the Health and Safety Code and §10746 of the Welfare and Institution (W&I) Code.

Participating waiver providers are required to provide both interpreter and translation services for applicants and participants in the Medi-Cal threshold languages most commonly encountered in that county. Threshold languages are: Armenian, Cambodian, Chinese, Farsi, Hmong, Korean, Russian, Spanish, and Vietnamese. A "threshold" is defined as 3,000 beneficiaries or 5% of the Medi-Cal population within a county (whichever is lower) whose primary language is other than English.

Language services include, as a first preference, the availability of bilingual staff who can communicate directly with applicants and participants in their preferred language. When such staff members are not available, face-to-face interpretation provided by trained staff, or contract or volunteer interpreters, will be the next preference. - 24-hour awake staff to provide oversight and meet the scheduled and unscheduled needs (Provision of awake staff at night is waived in 6-bed RCFs as per CCL);
- Provision and oversight of personal and supportive services including assistance with ADLs and IADLs;
- Assistance with self-administration of medications and/or administration by licensed nursing staff as needed;
- Recreational activities (Referral to recreational activities in a PSH setting);
- Provision of three meals per day plus snacks in the RCF setting; or,
- Coordination of three meals and snacks in a PSH setting;
- Housekeeping and laundry (Participant provides cleaning products and coins for laundry equipment);
- Licensed nursing staff, as necessary, to meet the skilled nursing needs of the participants. This does not include 24-hour skilled nursing care or continuous skilled nursing supervision.
- Transportation, or arrangement of transportation, to medically necessary appointments and to other needed services as identified on the ISP. The use of public transportation, when safe and appropriate, is an option.
- An IRS is required in the PSH setting. An IRS is a 24-hour call system that enables participants to secure immediate assistance in the event of an emotional, physical or environmental emergency. The IRS is designed to meet the needs and abilities of participants. The IRS may be a 24-hour response system, paging or intercom system.

Accommodations that must be available in ALW settings include:

- Private or semi-private bedroom with lockable door in an RCF or private occupancy in PSH with doors that lock, unless sharing is the participant's preference. (The choice of a housemate or roommate is independent of the ALW);
- Private or semi-private bathroom in an RCF or private full bathroom in PSH; There must be adequate bathroom space for the privacy and dignity of the participants when bathrooms are semi-private;
- Shared common space, such as a dining room or common activities center that may also serve as a dining room;
- Kitchenette, equipped with a refrigerator, a microwave (or cooking appliance in PSH) and storage space for utensils and supplies if participants do not have access to a common kitchen area at all times.
- PSH sites must have space sufficient for an HHA to operate a workspace with lockable doors and a telephone line;
- PSH sites must allow building access to identified employees for the purpose of rendering the ALW benefit.
- Note: These services do NOT include the cost of rent or the purchase of food.

Assisted Living Services will be delivered to participants in one of five possible "tiers" of service. Participants will be assigned an ALW tier as determined by the Care Coordination Agency RN. ALW Assessment Tool is administered by the CCA RN to potential, new participants to the waiver, and repeated at each reassessment. The tool measures the need for assistance with ADLs, IADLs and the need for assistance in one or more of the seven (7) functional categories: Cognitive Patterns, Behavioral Symptoms, Continence, Communications, Medications, Skin Conditions, or Other Treatments. Based on the combined need for assistance in these areas, the tool calculates a LOC eligibility and tier of service for the participant.

- Tier one services will be assigned to participants with the lowest level of support need;
- Tier two, tier three, and tier four services will be assigned to participants with more significant support needs, respectively;
and;
- Tier five services will be assigned to participants who require intense, focused attention to ADLs and IADLs as a result of a severe traumatic brain injury. These participants will have a need for assistance beyond that provided in Tiers one through four along with the additional residential habilitation services to successfully manage their care needs while residing in either an RCF or PSH. Tier five is designed to provide a community residential alternative for participants whose physical, mental and cognitive disabilities make placement in other facilities, such as SNFs, IMDs, ICF/DDs or in Tiers one through four of the ALW inappropriate or unmanageable. To be eligible for Tier five, participants must demonstrate one or more failed placements in the past, and demonstrate that they can successfully reside in a supervised community setting. Tier five provides extensive physical, behavioral, cognitive, communicative, social and psychosocial treatments and supervision for those ALW-eligible participants with care needs typical of severe traumatic brain injury.

To be eligible for Tier five services a participant must have suffered a traumatic brain injury and meet all of the following specific criteria:

- Meets NF-A or NF-B LOC with severe mental/cognitive disabilities;
- Demonstrates, has a history of or has the potential of wandering or flight behavior;
- Demonstrates or has a history of an inconsistent ability to provide self-care, potential or injury to self or others, or potential of behavior outbursts that negatively affect others;
- Demonstrates or has a history of unsuccessful attempt(s) of placement in other community settings;

- Requires potential 24-hours/seven days per week hands-on or physical presence supervision and management; can be left alone for short periods of time; and,
- Only able to reside in a community setting licensed to provide 24-hour services, supervision and supports, demonstrated by at least one failed placement in a less restrictive setting.

Assisted Living Services, as all ALW benefits, will be delivered in accordance with an ISP. The ISP is based on the needs identified by the CCA RN via the ALW Assessment Tool, clinical records, professional assessments and the personal preferences of the participant.

The participant takes part in the development of the ISP to the full extent possible. Participants who are unable to participate in the development of their own ISP may be assisted by a family member or other responsible party, such as a legal conservator. The person(s) responsible for a participant's health care decisions may fill the lead role in plan development and oversight in collaboration with the provider and the CCA as necessary.

Assisted Living Services includes personal care services (including assistance with ADLs and IADLs as needed), chore services, companion services, medication oversight, and therapeutic social and recreational programming provided in a home-like environment. This service includes 24-hour on-site direct care staff to meet scheduled or unpredictable needs in a way that promotes maximum dignity and independence, and to provide supervision, safety, and security.

Assisted Living Services include personalized care, available 24-hours per day rendered by onsite staff. Direct care staff will be awake and available at all times. An exception to the requirement of awake staff at night is granted to RCFs with a licensed capacity of fewer than seven beds. In RCFs with a licensed capacity of fewer than seven beds, direct care staff must be available on the immediate premises but are not required to remain awake throughout the night. Assisted Living Services are furnished to participants who reside in private or semi-private residency units which may be shared at the participant's request but not as a requirement of program participation. The ISP will reflect the choice of the participant to share a residence. The participant has a right to privacy. Residences may be locked at the discretion of the participant, except when a physician or mental health professional has certified in writing that the participant is sufficiently cognitively impaired as to be a danger to self or others if given the opportunity to lock the door. (This requirement does not apply where it conflicts with fire code). Each residence is separate and distinct from the other.

Care Coordinators assist participants in gaining access to needed waiver and other state plan services. In collaboration with participants and/or their families, the Care Coordinators will complete the assessment and reassessment of waiver participants using the ALW Assessment Tool, at least every six months, and more frequently, as indicated by a change in the condition of the participant. A CCA RN must conduct the assessment and complete the Assessment Tool. Care Coordinators must also verify Medi-Cal eligibility. Care Coordinators will assist participants in the direct development, implementation, and modification of their ISP to the extent that the participant desires to be involved. Participants who are unable to direct the development of their own ISP and participate in the oversight of their own services may be assisted by a family member or other responsible party, such as a legal conservator. The person(s) responsible for a participant's health care decisions may fill the lead role in plan development and oversight in collaboration with the Care Coordinator as necessary.

The ISP is a plan describing the services rendered to the participant, the manner in which the services are delivered, and the desired outcome for each service. The ISP must include specification of the type of provider performing each service and the frequency and duration of each service. Participants may choose to be involved in all aspects of the design, delivery, and modification of their services. They have the right to decide when services are delivered, where services are delivered and how services are delivered.

The Care Coordinator will ensure that the ISP is completed during the initial meeting and reviewed (and updated as needed) every six months. On an ongoing basis, Care Coordinators, in collaboration with participants, will also be responsible for ensuring the appropriate, timely delivery of needed services. This will be achieved through face-to-face meetings with the participant and/or responsible parties every month, and a review of participant records at each six-month reassessment. Participants may request a review of their ISP at any time. The Care Coordinator assessments and determinations of Medi-Cal eligibility are subject to verification by the DHCS. Every six months a Care Coordinator RN will reassess participants and determine with the participant what, if any, updates need to be made to the ISP. The Care Coordinator will assess the participants for health and safety. Any signs of abuse or neglect will be reported immediately to Adult Protective Services (APS), and the DHCS. Depending on whether the participant is residing in an RCF or PSH, CCL or DPH L&C will also be notified.

Participants will be enrolled into the ALW upon completion of the Assessment, verification of eligibility and completion of the Freedom of Choice Document. The Care Coordinator is eligible to submit bills for Care Coordination once the participant is enrolled. A participant can only be enrolled into the waiver after having been transitioned into an assisted living community residence.

The participant retains the unduplicated slot for 60 days to facilitate subsequent return to the ALW. After 60 days, the slot is available to another participant.

The emphasis of the ALW is the successful transition of persons from skilled nursing into assisted living based on freedom of choice. The goal is for the CCAs to coordinate at least one NF transition for every one community placement they coordinate.

The CCAs will work in conjunction with the Money Follows the Person (MFP) program, known in California as California Community Transitions (CCT) to assist with the successful placement of persons identified by CCT who choose the ALW. The CCAs will consider the placement of a CCT individual as a qualifying NF transition. The CCT Operational Protocol recognizes the PSH sites as an appropriate placement. Should a participant in the CCT demonstration choose to reside in an RCF, the CCT demonstration would refer the participant to a CCA for enrollment in the ALW.

Residential habilitation provides for additional staff with additional training to deliver a more constant and concentrated effort, on a one to one staff ratio, involving the addition of specialized behavior modification techniques. The focus is more toward a participant's safety and well-being when interacting with participants who "act out," or display violent or self-destructive behaviors, and destructive behaviors toward other individuals.

The residential habilitation service includes assistance with ADLs, but with the focus of overseeing the behavioral issues requiring a constant and concentrated effort for up to 24 hours per day, 7 days a week involving the addition of the specialized behavior modification techniques related to such issues as TBI. Provision of this service requires prior approval from DHCS Registered Nurses to allow additional, appropriate staff to focus individual attention on one participant to assist in acquiring, retaining and improving the self-help, socialization and adaptive skills while concentrating on helping them to control their behavior issues that would otherwise preclude them from living in a community setting. Providers will be reimbursed for supplying additional, appropriate staff to oversee a participant, depending on an individual's unique needs. Staff may be licensed medical staff, personal or nursing aides, security personnel, or other specialties as appropriate to the specific participant. Staff must have had a minimum of two hours of documented approved education, specific to TBI and a minimum of two hours of documented approved continuing education per year thereafter.

Specific services are an intensive form of those specified under the Assisted Living Services and specifically aimed at those participants who require more staff and more intense focus on the activity and the participant's safety and well-being than that anticipated for the participant receiving routine assisted living services. Services may include:

- Hands-on assistance with ADLs such that the participant is guided to become more self-reliant; such enhanced assistance is anticipated to take up to twice as long as that provided to those participants receiving routine assisted living services.
- In-person, eyes-on supervision/protective supervision to redirect the participant away from wandering, acting out behaviors, violent behaviors, self-destructive or other person-destructive behaviors.

- Such oversight is expected to require staff that is assigned a limited number of participants for an extended time.

Residential habilitation services are available to participants residing in both an RCF and a PSH. Residential Habilitation Services will be provided by the home health agency in addition to regular Assisted Living Services to participants residing in PSH settings.

This benefit is designed to address the increased need for Care Coordination prior to the successful transition of an individual from a nursing facility (NF) into an assisted living setting. The Care Coordinator may claim the NF Transition Care Coordination reimbursement after the successful transition of the participant from a NF, NF subacute or acute facility into the ALW and establishment of residence in an assisted living setting.

The RCFs participating in the ALW vary in size from five beds to over 200. The RCFs are licensed and regulated by the CDSS CCL. These facilities are not regarded as healthcare facilities, but social-based facilities. The RCF is the participant's home, akin to an apartment complex, providing non-medical services as necessary. The residents are regarded as living in their own home; albeit a licensed facility, not in a healthcare setting.

Larger RCFs typically subdivide the building to create small communities within the building. Participants may be grouped by special needs, such as a memory care unit. ALW participants are not distinguished from others in the RCF in any fashion.

The larger RCFs typically provide alternative meal times to offer choice and to reduce the number of persons in the dining area at any one time. Many RCFs provide additional smaller, homelike dining areas to offer the experience of a family style meal.

The care providers in all RCFs tend to care for the same individuals every day. This enables the care provider to gain familiarity with the particular needs of each individual and for the individual to develop a trusting relationship with the care provider.

RCFs with delayed egress or secured perimeters will not be considered a Home and Community-Based setting for this waiver.

All RCF's are licensed by the State. Per this license 'the licensee shall employ staff as necessary to ensure provision of care and supervision to meet client health and safety needs.

The DHCS requires the RCFs and the HHAs to submit their Significant Incident Reports (SIRs) to both the licensing entities and to the CCAs. The CCAs submit the SIRs to the DHCS.

DHCS quantifies, tracks, and monitors the trends in the SIR activity. In the event that a trend or pattern of SIRs is detected, the provider(s) are given the appropriate TA with clear timelines for improvement. Monitoring continues to ensure that remediation occurs. In the event that remediation is not achieved or is insufficient, the DHCS issues a CAP to the provider. The DHCS provides continuous and ongoing TA to all waiver providers. This assistance includes clinical input, provider requirements, assistance with billing and significant issue documentation. The DHCS provides extensive training for new waiver providers including a manual specific to provider type. The DHCS conducts an annual QA audit and review. The data from the review are aggregated and presented back to the providers in the format of TA. New strategies for improving waiver implementation are fostered by this process.

b. Methods for Remediation/Fixing Individual Problems

The DHCS identifies individual problems that are specific or unique to a single provider and addresses the problems directly with the provider. The nature of the issue and the severity of the problem are identified and discussed with the provider by the DHCS.

A Corrective Action Plan (CAP) or remediation process is developed by DHCS in conjunction with the provider to respond to the issue. The DHCS then monitors the provider with supportive TA to assure that resolution occurs.

If the issue continues, further TA with a more stringent CAP is developed. Providers may be placed in suspension from admitting and retaining additional waiver participants until the issue is resolved. The initial

CAP period is either 90 days or 180 days depending on the nature and severity of the problem. The length of the CAP period assigned is at the discretion of the DHCS.

In the event that the issue continues, or grows in proportion, the provider is disenrolled as a waiver provider and participants are moved to another provider site for continuity of care.

The participants are provided with a list of participating facilities within the county from which to choose. The CCA responsible for the participants would be the lead agency for assuring that the participant's freedom of choice is respected.

The Individualized Service Plan (ISP) is a participant-directed plan that identifies the services needed by the participant to assure health and safety in the assisted living or the assisted care settings. A participant has the

authority to include individuals of his/her choice to participate in the service plan development process. The participant has the freedom of choice to select providers, including the CCA. During development of the ISP, individuals of the participant's choice, representatives from the residential care facility or the home health agency, and the care coordination agency can offer support and guidance to the participant. Each of these individuals and/or entities can offer a unique perspective to ensure the participant's plan for long-term services and supports is personalized to his or her specific needs.

The participant signs the ISP and indicates he/she was active in the development of the ISP and agrees or disagrees with any portion of the ISP as developed. The goals of the ISP are based on the 6-month interval until the subsequent reassessment.

The ISP also identifies any known issue, intervention and outcome of identified issues. The issues are defined in nursing/health care language and are not medical diagnoses.

The intent of identifying issues for the participant is to lead to a timely resolution of those issues by setting goals for remediation. An accurate goal is measureable and definitive, not vague as to time and manner of resolution. The intervention is the specific action that will be taken to achieve the goal. The outcome is the result of the intervention. If the outcome is not the resolution of the issue, then the issue continues to be an active issue on the ISP. When issues are resolved, the resolution is documented as the outcome, and the issue is subsequently inactive on the ISP. The ISP reflects the current needs of the participant and includes short-term goals that are resolved in the first six months, as well as long-term goals that persist on the ISP until eventual resolution.

The advocates for the participants involved in the ALW have stated a strong preference for the ISP to reflect the individualized needs of the participant. CCAs are to refrain from the use of repetitive language common to all ISPs but rather ensure that the ISP accurately reflects the current needs of each participant.

The ISP is based on the needs identified by the ALW Assessment Tool, clinical records, professional assessments and the personal preferences of the participant. The CCA administers the Assessment Tool which determines participant eligibility for the waiver. The tool measures the need for assistance with ADLs and the need for assistance in one or more of the seven functional categories: Cognitive Patterns, Behavioral Symptoms, Continence, Communications, Medications, Skin Conditions, or Other Treatments. Based on the combined need for assistance in these areas, the tool calculates a level of care eligibility and tier of service for the participant.

The ISP is a plan describing the services rendered to the participant, the manner in which the services are delivered, and the desired outcome for each service. The ISP must include specification of the type of provider performing each service and the frequency and duration of each service. Participants may choose to be involved in all aspects of the design, delivery, and modification of their services. They have the right to decide when services are delivered, where services are delivered and how services are delivered.

The CCA will ensure that the ISP is completed during the initial meeting and reviewed (and updated as needed) every six months. On an ongoing basis, the CCAs, in collaboration with the participants, will also be responsible for ensuring the appropriate, timely delivery of needed services. This will be achieved through face-to-face meetings with the participant and/or responsible parties every month, and a review of participant records at each six-month reassessment. Participants may request a review of their ISP at any time. The CCA assessments and determinations

of Medi-Cal eligibility are subject to verification by the DHCS. Every six months the CCA RN will reassess participants and determine with the participant what, if any, updates need to be made to the ISP. The CCA will assess the participant for health and safety issues. Any signs of abuse or neglect will be reported immediately to Adult Protective Services (APS), the DHCS, and, if the participant is residing in an RCFE, CCL. If the participant is residing in PSH, L&C shall be notified.

RCFs and Home Health Agencies must have current, written emergency disaster plans which must include the following: contain a plan for evacuation, address elements of sheltering in place, identify temporary relocation sites, and identify detailed staff assignments in the event of a disaster or an emergency. The emergency disaster plan must be posted prominently in the facility and be available to emergency responders.

The NOA contains an explanation for the reason the State is denying, reducing, or terminating services, and provides information on how to ask for a State Hearing, and how to get questions answered, including telephone numbers for free legal aid.
- The individual's choice is documented on the Freedom of Choice document.

State Hearings are coordinated and conducted by the California Department of Social Services. Final authority for the adoption of decisions rests with the Director of the Department of Health Care Services, as per Delegation Order #94-151.

(B) Any serious injury as determined by the attending physician and occurring while the resident is under facility supervision.

C) The use of an Automated External Defibrillator.

(D) Any incident which threatens the welfare, safety or health of any resident, such as physical or psychological abuse of a resident by staff or other residents, or unexplained absence of any resident.

(2) Occurrences, such as epidemic outbreaks, poisonings, catastrophes or major accidents which threaten the welfare, safety or health of residents, personnel or visitors, shall be reported within 24 hours either by telephone or facsimile to the licensing agency and to the local health officer when appropriate.

(3) Fires or explosions, which occur in or on the premises shall be reported immediately to the local fire authority; in areas not having organized fire services, within 24 hours to the State Fire Marshal; and no later than the next working day to the licensing agency.

DHCS requires RCFs and HHAs to submit incident reports to the CCA and DHCS within 24 hours of occurrence for serious incidents or issues, or 72 hours for less serious issues.

1. CCAs e-mail incident reports to the state via a dedicated e-mail box (ALWP.IR@dhcs.ca.gov) which can only be accessed by the ALW Unit staff.

2. Incident reports are reviewed by ALW RN staff.

3. ALW RNs follow up with CCAs as needed.

4. The ALW team informs the California Department of Social Services Community Care Licensing Division when it has been determined that an RCF is restricted from enrolling additional waiver participants.

5. Incident report data is entered into a spreadsheet for tracking purposes and analyzed for trends on an annual basis. DHCS tracks incident reporting activity in the ALW database. The date, type and disposition of the incidents are tracked on a continuous basis.

- c. The CCA will be responsible for participant training and education. The CCA will discuss with and provide the participant with information regarding abuse, neglect, or exploitation; how to recognize if any of these occur; and whom to contact to report such events/incidents. The CCA will provide additional training as necessary. The CCA is a mandated Adult Protective Services (APS) reporter.

The RCF is mandated to post the contact information for the Ombudsman in the facility. The CCA conducts an independent quality assurance visit monthly with the participant and completes a reassessment every six months.

- d. The RCF and HHA are required to send a SIR to CCL or L&C within 24 hours respectively. The CCA forwards the SIR to the DHCS.

DHCS will investigate when the waiver provider fails to:

- Report abuse or neglect of a waiver participant;
- Notify the physician of a change in the participant's condition, if the participant is harmed by the failure of this action;
- Inform the participant of their rights;
- Provide waiver services as described in the participant's ISP;
- Provide adequate notification to the participant when services are changed or terminated;
- Act within their professional scope of practice (if verified, L&C will re-direct to licensing entity);
- Report suspected or verified medication misuse.

Within 30 days of the identification of a trend or pattern of critical events, the provider will be given TA as the nature and severity of the issue. The DHCS will follow up within the next 30 days to assure that the issue is ameliorated. In the event that the problem persists, the DHCS will issue a CAP with a 60-90 day timeframe for remediation. In the event that the provider is unable to fulfill the conditions of the CAP, the provider will be suspended from further waiver enrollment and disallowed from enrolling additional waiver participants. In the event that the provider continues to fail to assure the health and safety of the participants, the DHCS will work in conjunction with CCL, L&C or Medi-Cal Provider Enrollment in the consideration of suspension of the RCF, HHA license or suspension of a CCAs Medi-Cal billing privileges.

DHCS will notify the participant, their family or representative of any investigative results within 24 hours of completion of any investigation.

The CCA is the first line of quality assurance and is responsible for intervening in the behalf of the participant in the event of a significant event. The SIR is submitted to L&C (HHAs) or CCL (RCFs).

The DHCS follows up with the CCA to monitor remediation and prevention of further similar events for the participantas indicated above.

In the event that the provider continues to demonstrate the inability to meet the requirements of a waiver provider, the provider shall be disenrolled as a waiver provider and the participants transferred to another locale within 30 days as per CCL.

The CCA monitors to ensure that the participants are receiving their medications as per the physician's orders.

assure that the health and safety of the participants is not jeopardized. The DHCS retains the authority to restrict enrollment to by any provider of whom there is a question or concern in this regard. The DHCS retains the authority to disenroll any provider who fails to respond to remediation and TA in this regard.

Appendix H: Quality Improvement Strategy (1 of 2)

Under §1915(c) of the Social Security Act and 42 CFR §441.302, the approval of an HCBS waiver requires that CMS determine that the State has made satisfactory assurances concerning the protection of participant health and welfare, financial accountability and other elements of waiver operations. Renewal of an existing waiver is contingent upon review by CMS and a finding by CMS that the assurances have been met. By completing the HCBS waiver application, the State specifies how it has designed the waiver's critical processes, structures and operational features in order to meet these assurances.

- Quality Improvement is a critical operational feature that an organization employs to continually determine whether it operates in accordance with the approved design of its program, meets statutory and regulatory assurances and requirements, achieves desired outcomes, and identifies opportunities for improvement.

CMS recognizes the value of this approach and will ask the state to identify other waiver programs and long-term care services that are addressed in the Quality Improvement Strategy.

Quality Improvement Strategy: Minimum Components

The Quality Improvement Strategy that will be in effect during the period of the approved waiver is described throughout the waiver in the appendices corresponding to the statutory assurances and sub-assurances. Other documents cited must be available to CMS upon request through the Medicaid agency or the operating agency (if appropriate).

In the QIS discovery and remediation sections throughout the application (located in Appendices A, B, C, D, G, and I) , a state spells out:

- The evidence based discovery activities that will be conducted for each of the six major waiver assurances;
- The *remediation* activities followed to correct individual problems identified in the implementation of each of the assurances;

In Appendix H of the application, a State describes (1) the *system improvement* activities followed in response to aggregated, analyzed discovery and remediation information collected on each of the assurances; (2) the correspondent *roles/responsibilities* of those conducting assessing and prioritizing improving system corrections and improvements; and (3) the processes the state will follow to continuously *assess the effectiveness of the OIS* and revise it as necessary and appropriate.

If the State's Quality Improvement Strategy is not fully developed at the time the waiver application is submitted, the state may provide a work plan to fully develop its Quality Improvement Strategy, including the specific tasks the State plans to undertake during the period the waiver is in effect, the major milestones associated with these tasks, and the entity (or entities) responsible for the completion of these tasks.

When the Quality Improvement Strategy spans more than one waiver and/or other types of long-term care services under the Medicaid State plan, specify the control numbers for the other waiver programs and/or identify the other long-term services

that are addressed in the Quality Improvement Strategy. Appendix H: Quality Improvement Strategy (2 of 2)

H-1: Systems Improvement

a. System Improvements

- i. Describe the process(es) for trending, prioritizing, and implementing system improvements (i.e., design changes) prompted as a result of an analysis of discovery and remediation information.

The ALW Quality Improvement Strategy (QIS) is designed to provide meaningful performance measures through the review of participant ISPs to identify all health care needs and develop prevention strategies through trend analysis, prioritization of assessed participant risks, and development of specific goals and objectives resulting in the implementation of system improvements.

The State assures quality of participant health and welfare by setting proactive quality improvement strategies with participation and collaboration of the CCA in tandem with participants and/or their families, providers, consumer/participant advocates, and local and state agencies. Agreed upon quality improvement goals are set on an annual basis with specified objectives. The State uses reported data to set ad hoc improvement goals as the data and circumstances suggest.

This approach is focused on the expectation that through comprehensive development of a participant's ISP, (which includes all measures of the ALW Assessment Tool - assistance with ADLs, IADLs as they relate to coordinated physical health and community-based supports and services, as well as the seven (7) functional categories of cognitive patterns, behavioral symptoms, continence, communications, medications, skin conditions and other treatments). Each ALW participant will have a greater likelihood of improved health status and quality of life. Concurrently, this process allows early identification and prevention of deterioration of the participant's intake health status while supporting the assurances of 42 CFR §441.301 and §441.302. The ALW uses the participant's ISP as a gauge to measure all health care needs and develop prevention strategies through qualitative analysis of the services delivered. The ISP focused preventions allow the ALW participants and providers to have a direct role in the quality assessment and quality improvement processes allowing timely interventions to assure early identification of health and welfare needs.

Access

The CCA is responsible for assessment of the participant for admission into the ALW.

The CCA is responsible for the following:

- Prior to the participant's enrollment into the ALW, complete the initial ALW Assessment and develop the initial ISP documenting the participant's initial health care needs.
- As stated in Appendix C-3, the ISP will include specified services to be provided with measureable outcomes for each service.
- The ISP will be updated as needed (at a minimum of every 6 months).
- The service performance measures are addressed by a regular review of the desired outcome of each health care need with the development of specific action plans if needed to improve or review the participant's health care needs.
- Each ISP review will assess the participant for health and safety needs, including any signs of abuse or neglect that will be immediately reported to APS, DHCS and the L&C.

Trending

- The DHCS tracks and monitors the following data sources:

- ISPs and SIRs from the RCF and the HHA
- ISP updates to measure the effectiveness of updated and/or revised service plans
- Complaints or concerns voiced by the participants
- Concerns identified by the CCAs
- The ISPs and SIRs are tracked in a log and trended by provider and type of action.

Prioritizing

The ALW recognizes the following hierarchy of concerns:

1. Any ISP change, (as detailed in Appendix D) change in presenting health condition(s), altered care delivery goals, intervention needs, and measured outcomes to quantify compliance with waiver health and welfare assurances.
2. All SIRs, specifically;
 - a. Events resulting in participant injury or accident;
 - b. Events resulting in hospitalization or treatment;
 - c. Immediate threats to health and safety;
 - d. Potential threats to health and safety;
 - e. Other health care concerns that may manifest under certain conditions.

Implementing

1. The DHCS annual QA audits provides the data for TA to all ALW provider(s).
2. Identified ISP and SIR trends are closely monitored by the DHCS to support the assurances of 42 CFR §441.301 and §441.302.
3. For all assurance problems with providers the DHCS reviews the nature and severity of the problem and, if needed, develops a CAP as indicated for the provider in question.
4. The DHCS continues to monitor and follow up with the provider to ensure that the conditions of the CAP are met and the health and safety needs of the participant are met.
5. If the conditions of the CAP are not addressed, then probationary action is initiated.

The DHCS primary systems improvement objective for the QIS is to assure participant health and welfare through the following measures:

1. To identify, quickly and reliably, positive or undesirable trends that will allow for necessary adjustments to enhance overall performance of the system, and act on opportunities for improvement;
2. Assure data undergoes rigorous reliability and validity testing that is used to drive policy and procedure decisions to increase performance; and,
3. Ensure timely discovery and remediation that allows the DHCS to take swift action to improve meaningful outcomes for the participants in the ALW.

The QIS process is designed to review all participant reports, assessments, reassessments, special incident reports, critical incidents reports, etc. The following details how the ALW performs trend analysis and prioritizes areas in need of remediation.

The ALW Trending/Prioritizing/System Improvement Process:

The QIS will determine to what extent each waiver assurance has been met during the reporting period, measure it against ALW goals, and assess and prioritize trends towards the goal of implementing system improvements.

1. Aggregate data is collected for each performance measure. Measures include: participant assessments; reassessments; ISPs and SIRs from the RCFs and the HHAs; complaints or concerns voiced by the participants and concerns as identified by the CCAs.
2. The ALW methodology is to coordinate the analysis of each performance measure, and track data by: participant, frequency, provider type, action, remediation, and systemic issues. Additional data review includes identification of health care needs based on enrollment primary diagnosis and reassessed changes in participant health service tier.
3. The participant’s LOC is reevaluated every 6 months. Trending of these data sources measures the provider’s compliance with quality assurance and promotes identification of needed remedial or corrective actions. A combination of audit tools is used to support analysis of the performance measures.
4. CAPs are prioritized based on risk assessment and health and welfare needs of participants. Interventions include a continuum of actions from staff training to removal of provider from the ALW. All CAPs are monitored for efficacy of remedial action. The remedy/improvement may be more appropriately targeted to specific situations.

The DHCS primary systems improvement objective for the QIS is to assure participant health and welfare through the following measures:

- Identify, quickly and reliably, positive and adverse trends that will allow for necessary adjustments to enhance overall performance of the system, and act on opportunities for improvement;
- Assure data that is used to drive policy and procedure decisions undergoes rigorous reliability and validity testing to increase performance; and
- Ensure timely discovery and remediation that allows the DHCS to take swift action to improve meaningful outcomes for the participants in the ALW.
- Performance Measure Indicator: – All SIRs are followed up within 24 hours by the State and specific licensing agencies as provided in state regulations. Identified ISP and SIR trends are closely monitored by the DHCS to support the assurances of 42 CFR §441.301 and §441.302.

b. System Design Changes

The Medicaid agency retains the ultimate authority for the assurance of quality and quality improvement in the ALW.

The QIS uses a multi-level approach. Each level is designed to promote discovery, identify trends and capture timely remediation information that promote system improvements.

Level One: Level of Care Evaluation/Reevaluation

- LOC determination as detailed in Appendix B-6 is generated by the CCA prior to initial enrollment and reviewed by the DHCS
- Each waiver participant is reassessed for LOC at least every six months or upon significant change by the CCA. All reassessments are reviewed by the DHCS.
- The ISP, jointly developed by the participant and the CCA, is used to guide all plan services and safeguards as detailed in the waiver guidance.

Level Two: Service Plan

- As detailed in Appendix C, the CCA reviews the ISPs monthly with the participant to assure that the participant's needs are addressed and considered.
- The ISPs are developed in accordance to the waiver requirements to identify all health care needs and address health and safety risks of participants, with monthly review by the CCAs and annual review by the DHCS.
- The ISPs are revised as needed and at least every six months by the CCAs and reviewed by the DHCS.
- Services outlined by the ISP are implemented by staff of the RCFs and HHA, and reviewed monthly by the CCA and annually by the DHCS.
- Providers are held accountable for the health and safety of the participants. ISPs are reviewed for completeness and the appropriateness of the interventions for addressing the healthcare needs of the participant as identified in the assessment.

Level Three: Coordination of the Qualified Providers

- CDSS CCL is responsible for ensuring RCFs meet licensing and certification requirements of the CDSS.
- CDPH L&C is responsible for ensuring that HHAs meet the licensing and certification requirements of the CDPH.
- DHCS is responsible for annual monitoring to assure provider adherence to waiver requirements, and follow up when providers have not met specified standards.
- DHCS is responsible for annually compiling and reviewing data collected from waiver providers and waiver participants for quality assurance.
- Providers are responsible for the health and safety of the participants. The CCAs monitor the RCFs and HHAs and the DHCS monitors the CCAs (as well as the RCFs and the HHAs).

Level Four: Prevention of instances of abuse, neglect and exploitation

- Through the ALW Provider Manual and annual training, the State provides TA to the CCAs and all

providers on the identification of abuse, neglect and exploitation, timelines for the notification of specified authorities, and remediation information.

- The State reviews all SIRs, with linkages to the State Licensing Agencies.
- The State analyzes a statistically significant percentage of SIRs for trends to allow development of risk prevention strategies. Data is reviewed continuously and analyzed annually by the DHCS.
- Systemic issues are addressed through CAPs and TA by the DHCS. The DHCS continues to monitor the providers after the deliverance of the TA to assure that the practices are changed according to the CAP and that the issues are remediated.

In the event that the systemic issues persist, the DHCS will revisit the provider, offer additional TA and impose sanctions as indicated and as described in H.1.a.i. TA is offered to the providers on a global basis for program-wide systemic issues and on an individual basis for issues pertaining to a particular provider.

Level Five: Administrative Authority provided by the DHCS

- DHCS is the administrative authority for the ALW that monitor actions of other State agencies and of all providers.
- The annual review of provider records and of participant records followed by monitoring and analysis produces the recommended changes brought to the QMS for discussion and action.
- The Olmstead Advisory Group and the ALW Stakeholders' Group provide input to the ALW quality management system. These advisory groups are comprised of primary customers and family members, providers, and advocacy organizations that meet quarterly.

ii. Describe the process to periodically evaluate, as appropriate, the Quality Improvement Strategy.

The Medicaid agency retains the ultimate responsibility for the assurance of quality improvement through the implementation of the QIS. The process for periodic evaluation of the QIS is embedded in the annual QA audit. The audits are based on the performance measures and are held to the standard of the confidence interval.

The QIS has a process that separates the programs measures into,

- 1) required actions taken, indicating that the provider has followed protocols and all corrective measures have been resolved, and
- 2) corrective actions taken by provider and reported to the QIS prior to audits and/or review of trend analysis.

Individual provider problems are based on review of State regulations and policies governing actions specified in licensing guidelines. As required by corrective action findings individual providers will complete specified staff trainings to update staff competencies based on ALW participant's needs.

The QIS documents all oversight activities through program letters, coordination of provider continued eligibility as a Medi-Cal contracted provider of ALW services, noted in all provider records, maintained in a running record in the providers files, and update reports to CMS as required.

Appendix I: Financial Accountability

I-1: Financial Integrity and Accountability

Financial Integrity. Describe the methods that are employed to ensure the integrity of payments that have been made for waiver services, including: (a) requirements concerning the independent audit of provider agencies; (b) the financial audit program that the state conducts to ensure the integrity of provider billings for Medicaid payment of waiver services, including the methods, scope and frequency of audits; and, (c) the agency (or agencies) responsible for

conducting the financial audit program. State laws, regulations, and policies referenced in the description are available to CMS upon request through the Medicaid agency or the operating agency (if applicable).

The Health Insurance Portability and Accountability Act (HIPAA) Compliant HCPCS Codes are unique to each waiver service. Each provider type is only eligible to bill for the waiver service(s) they render. The billing is via a standardized billing form, the UB-04. Claims are submitted to the fiscal intermediary for payment. Only recognized Medi-Cal billers may be paid for waiver services.

Residential habilitation services are available to participants residing in both an RCF and a PSH. Residential Habilitation Services will be provided by the home health agency in addition to regular Assisted Living Services to participants residing in PSH settings.

Audits are conducted at three levels:

- 1) The DHCS examines the provider records and contrasts and compares the records with the authorized services;
- 2) The Audits and Investigations Division (A&I) is available to conduct a more detailed financial analysis in the event of suspicious billing practices; and
- 3) The state conducts routine, random audits of all Medi-Cal billers to ensure competency and accuracy in the paid claims.

A&I is responsible for ensuring the fiscal integrity and medical necessity of Medi-Cal program services. All claims submitted by waiver and state plan providers are subject to random review regardless of provider type, specialty, or service rendered. A&I verifies that claims selected have sufficient documentation to approve the claim for payment. Providers are notified if a claim requires additional documentation before approval for payment. Failure to comply with the request for additional documentation may result in suspension from the Medi-Cal program, pursuant to W&I §14124.2. A&I has three branches that conduct reviews using various methodologies to ensure program integrity and the validity of claims for reimbursement.

The A&I Medical Review Branch (MRB) performs essential medical reviews of non-institutional providers. Providers may also be subject to a more comprehensive review on a weekly basis known as a pre-checkwrite review. This review is based on a set of criteria, such as irregular billing patterns, designed to identify potential fraud or abuse. Providers selected for this more comprehensive review may receive an on-site visit by A&I staff. Many of these reviews result in program removal, monetary penalties, or less intrusive sanctions and utilization controls.

The MRB also conducts Medi-Cal provider anti-fraud activities that include performing field reviews on new Medi-Cal providers and providers undergoing re-enrollment. MRB is charged with bringing closure to sanctioned providers through audits designed to quantify the abuse, settlement agreement, or permissive suspensions (exclusions) from the Medi-Cal program. Failure to comply with any request by A&I staff for documentation may result in administrative sanctions, including suspension from the Medi-Cal program, pursuant to W&I §14124.2.

MRB staff work closely with the fiscal intermediary in data mining and extracting processes as well as the performance of the annual Medi-Cal Payment Error Study.

The A&I Financial Audits Branch performs cost settlement and rate setting audits of institutional providers, i.e. hospitals, nursing facilities, and certain clinics.

The A&I Investigations Branch (IB) conducts investigations of suspected Medi-Cal beneficiary fraud as well as preliminary investigations of provider fraud. IB is also responsible for coordinating provider fraud referrals to the state Department of Justice (DOJ) and Federal Bureau of Investigations. Suspected fraud or abuse identified through any audit or investigation process is referred to the DOJ via the IB. IB and MRB coordinate the placing of administrative sanctions on providers with substantiated evidence of fraud. IB serves as DHCS' principal liaison with outside law enforcement and prosecutorial entities on Medi-Cal fraud.

DHCS released the design and reimbursement structure of the ALW in a series of public stakeholder meetings in the summer of 2005. The original four tiers of service and the Care Coordination service remain cost neutral with the assumption that ALW participant use of state plan services does not generally exceed the predicted annual average of \$5,300.

The estimate of the Assisted Living bundled services was preliminarily calculated by developing a comprehensive provider business model. Additional information for the development of the rates came from researching the cost of providing similar services in waiver programs in other states including Oregon, Washington, and Vermont.

For all services except the Assisted Living bundled service, costs were developed by the State from estimates of unit price and utilization. The State developed unit price estimates by benchmarking these services against services in California's MSSP and NF A/B waiver programs. The rate for Residential Habilitation has been increased for this amendment based on this methodology.

The new reimbursement structure, which includes the addition of Tier five has been publicly presented through a stakeholder meeting held August 29, 2013 and reflects the severity of the physical, mental and cognitive condition of an individual with traumatic brain injury as an ALW participant. The increase rate for Assisted Living Services and the addition of Residential Habilitation and Augmented Plan of Care Development and Follow-Up(both services available to participants in all tiers) will ensure appropriate care and supervision of all ALW participants.

The State arrived at the rate of \$1,000 for NF Transition by estimating the amount of work necessary to transition an individual from a SNF into the waiver, within the limitations of cost effectiveness standards and yet still offering a financial incentive to Care Coordinators to actively pursue the NF transition.

The increased reimbursement rate for Tier five, Assisted Living Services is based upon the statewide weighted average NF-B rate.

The rate for Augmented Plan of Care Development and Follow-Up is based upon the assumption that many participants will require approximately 11 hours per month of this type of service that would be reimbursed at the Medi-Cal home and community-based services waiver, home health agency case management rate of \$11.36 per 15

minutes.

Tier five will continue to provide cost neutrality in the aggregate with the assumption that the use of State Plan services will not generally exceed the predicted annual average of \$5,300.

All waiver participants will continue to receive the services they are entitled to through the waiver and the State Plan. This waiver will not violate the Medicaid comparability requirement that services must be comparable, and are based on medical necessity, not enrollment in another Medicaid program.

- b. **Average Length of Stay.** Describe the basis of the estimate of the average length of stay on the waiver by participants in item J-2-a.

The Average Length of Stay (ALOS) for waiver participants is 247 days. The ALOS is based on the most recent available 372 data.

ALW enrollment experience shows that participants enrolled in the waiver will maintain continuous enrollment until forced to leave due to illness or death. The ALOS is expected to remain constant each waiver year.

The ALOS estimate is consistent with the turnover rate. ALW enrollment trends show that the Waiver experiences an attrition rate of 50 - 60 participants each month or an average of 660 unduplicated participants each Waiver Year.

- i. **Factor D Derivation.** The estimates of Factor D for each waiver year are located in Item J-2-d. The basis for these estimates is as follows:

The last five years of the ALW there has been a consistent enrollment at the different Tier levels:

- Tier 1 33%
- Tier 2 17%
- Tier 3 28%
- Tier 4 22%

It is anticipated that Tier 5 will be <1% of waiver enrollment.

Factor D is calculated as the average cost for waiver services per year based on paid claims data for the past three years.

It is anticipated that NF Transition Services will be rendered to one-third of new enrollees. The figure of \$1,000 is derived from the estimation that NF transition is the equivalent of 5 months of Care Coordination. The ALW is working closely with the CCT program and it is anticipated that all additional NF transitions will be in conjunction with CCT.

It is anticipated that Service Assessment/Plan of Care Development will be utilized by 10% of enrollees in this waiver.

It is anticipated that Residential Habilitation will be utilized by 10% of enrollees in this waiver. For the estimate of Factor D costs it is assumed that the average usage of this service will be 12 hours per day for every day the participant is enrolled.

- ii. Factor D' Derivation.** The estimates of Factor D' for each waiver year are included in Item J-1. The basis of these estimates is as follows:

Factor D' is the average cost for utilization of state plan Medicaid services per year based on the actual paid claims data over the last three years. There is no projected increase in these costs. This is attributed to the steady utilization of State Plan services and an effective educational program to reduce the use of emergency room care in favor of physician visits. Increases in access to and the cost of Medicaid services are not anticipated to increase.

Medicare Part D drug costs are not included in the Factor D estimates.

- iii. Factor G Derivation.** The estimates of Factor G for each waiver year are included in Item J-1. The basis of these estimates is as follows:

The values for G and G' in the waiver renewal application are based on the average Medi-Cal nursing facility and State Plan costs of individuals in California. The values for G and G' are weighted to a 365 day year. This is based on the assumption that the relative peer group in the institutional setting remains in place for a time period of greater than one year. The values for the ALW are static.

The Factor G estimates for inpatient NF A/B costs are from weighted daily facility rate for NF-A and NF-B facilities of \$142.00 per day. It is assumed that if a participant were to reside in a NF facility rather than accessing ALW services, the participant would remain in place for the full year. The weighted average is calculated at 365 days. There is no anticipated increase in NF reimbursement.

- iv. Factor G' Derivation.** The estimates of Factor G' for each waiver year are included in Item J-1. The basis of these estimates is as follows:

The Factor G' estimates the state plan services utilization during inpatient NF A/B hospitalization. There is no anticipated increase in state plan services reimbursement.

The Factor G estimate reflects actual utilization during inpatient NF A/B hospitalization. This figure (\$5,395) is based on the average reported in the following CMS 372 Reports:

WY 3 (January 1, 2008 - December 31, 2008)
 WY 1 (March 1, 2009 - February 28, 2010)
 WY 2 (March 1, 2010 - February 28, 2011)

Factor G' is not projected to increase.
