I am pleased to inform you that your request to renew the California Section 1915(c) In-Home Operations (IHO) Home and Community-Based Services Waiver has been approved. The renewal has been assigned Control Number 0457.R02.00 and is approved with an effective date of January 1, 2015.

This five-year renewal continues to provide case management/coordination services, habilitation, home respite, community transition services, environmental accessibility adaptations, family caregiver training, medical equipment operating expenses, Personal Emergency Response (PERS) installation and testing, Personal Emergency Response Systems (PERS), private duty nursing, traditional case management, and Waiver Personal Care Services (WPCS) and Personal Care Services.
