 - Purpose of renewal: To maintain the continuity of care of the current waiver participants
 - IHO Waiver Renewal January 1, 2015 December 31, 2019

- 4) IHO Waiver Changes
 - A. No changes in Services or Benefits to current IHO waiver participants
 - B. Changes to the IHO Waiver (1-5 have already been made in the Nursing Facility/Acute Hospital (NF/AH) Waiver and approved by CMS):
 - Revised Family Training to include training for an unlicensed caregiver (NF/AH Waiver Change)
 - Revised Habilitation includes peer monitoring to reflect changes recommended by the Disability Rights of California. (NF/AH Waiver Change)
 - 3. Removed IHSS Public Authorities as waiver providers

- Added language specifying a participant satisfaction survey shall be provided to IHO waiver participants at least once every waiver renewal.
- 5. Developed new performance measures per CMS directive for quality assurance compliance.
- 6. Removed Home and Community-Based Continuous Care Facility (HCBCCF) formerly known as a Congregate Living Health Facility (CLHF), which is still a NF/AH wavier benefited service. A HCBCCF/CHLF is considered a participant residence. There are currently no IHO Waiver participants residing in a CHLF.
