**NOTICE OF MODIFICATIONS TO THE TEXT OF
PROPOSED AIM REGULATIONS
ER-5-11, Paid Surrogacy Exclusion**

Pursuant to the requirements of Government Code section 11346.8(c), and section 44 of Title 1 of the California Code of Regulations, the Managed Risk Medical Insurance Board is providing notice of changes made to the proposed regulation text for Title 10 California Code of Regulations, section 2699.301. Section 2699.301 was the subject of a regulatory hearing on March 28, 2012. The amendment of section 2699.301 is included because it is sufficiently related to the proposed changes at that hearing.

The changes are in response to comments received regarding the proposed regulation. The changes being made are:

Section 2699.301

Subsections (a)(18) is being amended to clarify that, in applying the paid surrogacy exclusion, Participating Health Plans shall not withhold, or seek reimbursement from, a participating provider who renders maternity services to a Subscriber who has entered into an agreement to serve as a paid surrogate mother when the provider had not been notified that the mother had entered into such agreement.
