SUBJECT: CAMERA-READY NOTICES OF ACTION AFFECTED BY MID-YEAR
STATUS REPORTING AND SENATE BILL 87 AND OTHER NOTICES
OF ACTION FORMS, AND THE TRANSITIONAL MEDI-CAL FLYER
(Ref: All County Welfare Directors Letter No. 01-17, 03-41)

This letter contains camera-ready copies of English and Spanish Notices of Action (NOAs) that were revised to reflect the mid-year (semiannual) status-reporting requirement. The Four-Month Continuing Denial and Discontinuance NOAs, which were required by Senate Bill 87, are also enclosed, as they were not sent out with the previous camera-ready copies of revised NOAs. The Section 1931(b) *Sneede v. Kizer* Net Nonexempt Income Determination for Applicant and Recipients has been updated to indicate that the parental/spousal needs for a pregnant woman is more than one (Section F). The Transitional Medi-Cal (TMC) Flyer has been revised and no longer mentions the second year of TMC that has been eliminated. More Information is also required in the declaration so that counties may more easily identify the beneficiary if he/she returns the form.
