Additional type of Community Mental Health Clinic includes a n Outpatient Mental Health Facility which would seek certification through the County for Medi-Cal Certification. 5. Also referred to as Social Rehabilitation Program (SRP). The California Department of Social Services (CDSS) licenses Social Rehabilitation Facilities (SRF), and DHCS provides the SRP certifications as either a Short-Term Crisis Residential Treatment Program, Transitional Residential Treatment Program, or Long- Term Residential Treatment Program.
