State Specific Reporting Requirements

Dual Eligible Special Needs Plans (D-SNPs) are Medicare Advantage (MA) plans that provide specialized care and wrap-around services for dual eligible beneficiaries (eligible for both Medicare and Medicaid). The Centers for Medicare & Medicaid Services (CMS) requires several types of quality reporting for MA plans, which includes D-SNPs. In addition to all federally required MA reporting requirements, the California Department of Health Care Services (DHCS) has state-specific reporting requirements for D-SNPs, including Medi-Medi Plans, referred to here as Exclusively Aligned Enrollment (EAE) D-SNPs, non-EAE D-SNPs, and SCAN's Fully Integrated Dual Eligible Special Needs Plan (FIDE SNP). These requirements are detailed in the Reporting Requirements chapter of the [CY 2024 D-SNP Policy Guide](#) and the [CY 2024 D-SNP Reporting Requirements Technical Specifications](#).

Health Risk Assessment (HRA1) Measure

The tables below display the data that D-SNPs reported to DHCS on a quarterly basis for the state specific Members with a Health Risk Assessment Completed within 90 Days of Enrollment (HRA1) measure for Contract Year (CY) 2024. The tables display percent of members unwilling to participate in an assessment, members the D-SNP was unable to reach to complete an assessment, and members who completed an assessment, per quarter and by plan.
