SUBJECT: Substance Use Disorder (SUD) Recovery or Treatment Facilities'  
Licensure and Certification Fee Increase Beginning Fiscal Year (FY)  
2026-2027

PURPOSE: To provide notification of the Department of Health Care Services  
(DHCS) licensing and certification fee increase for residential and  
outpatient SUD facilities commencing on July 1, 2026

REFERENCE: [Health and Safety Code Section 11833.02; Senate Bill 104 \(2023 Leg. Session\)](#); and [Title 9, California Code of Regulations, Division 4, Chapter 5.5](#)



**BACKGROUND:**

Health and Safety Code (HSC), Section 11833.02 authorizes DHCS to collect licensing and certification fees from alcohol or other drug (also known as substance use disorder (SUD))<sup>1</sup> recovery or treatment facilities licensed and/or certified by DHCS. The revenues collected fund DHCS' SUD recovery or treatment facility licensing and certification activities. Licensure and certification activities include, but are not limited to, review and processing of initial, extension, and supplemental applications; initial and biennial onsite compliance reviews; complaint investigations; administrative support; disseminating information to the public, governmental agencies, and stakeholders; updating and maintaining databases; policy, regulatory, and statutory development; provider training and technical assistance; and appeal processing for revocation or suspension of providers' licenses and/or certification.

The current fees have been in effect since July 1, 2025, for FY 2025-26. Funds in the Residential and Outpatient Program Licensing Fund and the current licensing and certification fees are not sufficient to support current or planned expenses incurred by DHCS for SUD licensing and certification activities.

HSC Section 11833.02 authorizes DHCS to increase the licensing and certification fees. Section 57 of Senate Bill 104 amended the Budget Act of 2023 and directs DHCS to increase those fees by up to twenty percent (20%) each FY through FY 2026-27 to reach a cumulative fee increase of 75 percent. Accordingly, effective July 1, 2026, DHCS is increasing the licensing and certification fees by fifteen percent (15%).

**POLICY:**

Effective July 1, 2026, DHCS will assess the following fees for licensure and certification of residential and outpatient SUD recovery or treatment facilities:

Licensed and/or certified SUD recovery or treatment facilities, with **an expiration date on or after July 1, 2026**, that have already submitted biennial extension fees will be invoiced for the additional amount owed due to the increased fees. The fee difference must be submitted to the Department within 60 days of the invoice date.

The DHCS' [Licensing and Certification Portal](#) is now live. Renewal applications are available to currently licensed and/or certified SUD providers within 150 days of their license or certification expiration. Providers with renewals beyond 150 days are encouraged to sign in and verify their profile to receive notifications when their renewal becomes available.

DHCS offers applicants and providers the option to make online payments using electronic money transfers through the Automated Clearing House (ACH) network. To pay fees electronically, providers can visit the DHCS [EFT online portal](#), select Licensing and Certification Division, and follow the instructions provided.

Licensing and/or certification fees may also be submitted by mail with an application. Make sure to reflect the facility name, license and/or certification number(s) (if applicable) on the check or money order and mail it to the following address:

For dishonored checks, an administrative fee of \$25.00 must be paid to DHCS in addition to the licensing and/or certification fees.

In addition, HSC, Section 11833.02(g) required DHCS to develop a process for programs and facilities to apply for a hardship fee waiver. DHCS issued BHIN [24-036](#) on October 31, 2024, detailing the process and eligibility requirements to apply for a hardship fee waiver.
