# **PURPOSE OF THE REPORT**

Pursuant to <u>Government Code, Title</u> 2, <u>Division 3, Part 2, Chapter 6, Article</u> 2, <u>Section 12534</u>, the <u>California State-</u> <u>Subdivision Agreements</u><sup>1</sup>, and the <u>California</u> <u>Mallinckrodt Statewide Abatement</u> <u>Agreement</u>, the Department of Health Care Services (DHCS) is required to administer and oversee the funds distributed from opioid settlements and opioid-related bankruptcies for California and its participating cities and counties. This shall include, but is not limited to, the following:

- Conducting related stakeholder engagement.
- » Adding additional High Impact Abatement Activities.
- » Monitoring the California's cities and counties for compliance.
- » Preparing annual written reports.

State departments, cities, and counties receiving funds from opioid-related settlements and bankruptcies are required to submit reports to DHCS that include payments received and use and expenditure of funds. DHCS uses this information to prepare and publish an annual written report on the state's use of funds until those funds have been fully expended, and for one year thereafter. The report includes the state and the participating cities and counties' payments, use, and expenditures for the period of July 1 to June 30 each year.

The California Opioid Settlements Annual Expenditures Report demonstrates DHCS' commitment to providing accessible and transparent information regarding the collected financial data related to state and local spending of opioid settlement funds. By reviewing the information outlined in this report, cities and counties can generate ideas for opioid remediation projects. Public citizens can also utilize this report as an introduction to the opioid settlement funds, allowable uses, and accountability required of their local Participating Subdivisions.

This annual report, and the reports filed by participating counties and cities, will be made publicly available on the DHCS California's Opioid Settlements webpage.

**Report Disclaimer:** This report contains only a summary of relevant details of the National Opioid Settlements and the California State-Subdivision Agreements (SSA). Specific details, definitions, and requirements need to be obtained from the settlement agreements, or by consulting with relevant counsel. In the event of any discrepancies in this report, the settlement agreements, the SSAs, and related court orders, supersede this report.

# DEFINITIONS

**California (CA) State-Subdivision Agreements:** The State of California Agreements that govern the allocation, distribution, and use of Settlement Fund payments made to California pursuant to the respective Settlement Agreements.

**Capital Outlay:** The purchase of land and projects involving construction of a new facility or renovation of an existing facility to create new and/or accommodate program/facility expansion.

**Costs:** The reasonable amounts paid for the attorney and other City Attorney and County Counsel staff time for individuals employed by a Plaintiff Subdivision at the contractual rate (including overhead and other related costs), which were paid or incurred (1) prior to July 21, 2021, in litigation against any Opioid Defendant and/or (2) in negotiating and drafting the CA Allocation Agreements (State-Subdivisions Agreements). Costs do not include attorneys' fees, costs, or expenses incurred by private contingency fee counsel.

**Encumbered Funds:** Funds in an account owned by a Participating City or County that are reserved, obligated, or committed for a specific future opioid remediation expense.

**Expenditure:** The costs associated with implementing planning activities and programs for opioid remediation (i.e., spent funds).

**Harm Reduction:** Harm Reduction is an evidence-based approach to engaging with people who use drugs and equipping them with life-saving tools and information to create positive changes in their lives, reducing the negative effects associated with using drugs and potentially saving their lives. Harm Reduction incorporates community-driven public health strategies including, prevention, risk reduction and health promotion.<sup>2</sup>

**Initial Participating Subdivision:** All eligible Subdivisions that signed on to the settlements by the date required in the respective settlement agreements.

**List of Opioid Remediation Uses:** The list of approved opioid remediation uses from the National Opioid Settlement Agreements (Exhibit E) and the opioid-related bankruptcy National Opioid Abatement Trust II Distribution Procedures (Exhibit 4; Schedule A: Core

Strategies and Schedule B: Approved Uses). For purposes of this report, the list of opioid remediation uses will be referred to as "Exhibit E."

**Local Government:** Counties and incorporated cities, as identified in the California Mallinckrodt Statewide Abatement Agreements. For purposes of this report, Local Governments refer to California's cities and counties that received a direct distribution of National Opioid Abatement Trust II (Mallinckrodt bankruptcy) funds from July 1, 2022 – June 30, 2023. Local Governments will also be referred to as "participating cities and counties".

Non-Opioid Related Use: Expenditures that do not qualify as Opioid Remediation.

**Opioid Defendant:** Any defendant named in a lawsuit seeking damages, abatement, or other remedies related to or caused by the opioid public health crisis in any lawsuit brought by any state or local government on or before October 1, 2020.<sup>3</sup>

**Opioid Remediation:** The National Opioid Settlements define Opioid Remediation as "Care, treatment, and other programs and expenditures (including reimbursement for past such programs or expenditures except where the SSA restricts the use of funds solely to future Opioid Remediation) designed to (1) address the misuse and abuse of opioid products, (2) treat or mitigate opioid use or related disorders, or (3) mitigate other alleged effects of, including on those injured as a result of, the opioid epidemic." Exhibit E provides a list of expenditures that qualify as being paid for Opioid Remediation. Qualifying expenditures may include reasonable related administrative expenses. Generally, opioid remediation activities are focused on prevention, intervention, harm reduction, treatment, and/or recovery services intended to mitigate and/or abate the effects of California's opioid epidemic. Throughout the report, "Opioid Remediation" indicates the use of the term to imply an eligible activity per Exhibit E whereas "opioid remediation" is used more generally.

**Opioid Settlements Fund (OSF):** Created in the California State Treasury through <u>Government</u> <u>Code, Title 2, Division 3, Part 2, Chapter 6, Article 2, Section 12534</u>, in which California's state abatement share of opioid settlement and opioid-related bankruptcy funds are deposited.

**Participating Cities and Counties:** For purposes of this report, includes both Local Governments and Participating Subdivisions.

#### DEFINITIONS

**Participating Subdivision:** Any Subdivision that meets the requirements for becoming a Participating Subdivision pursuant to the national settlement agreements and is either a Plaintiff Subdivision and/or a Primary Subdivision with a population equal to or greater than 10,000. For purposes of this report, Participating Subdivisions or CA Participating Subdivisions refer to California's participating cities and counties that are listed in the respective CA State-Subdivision Agreements, and that received a direct distribution of settlement funds from July 1, 2022 – June 30, 2023. Participating Subdivisions may also be referred to as "participating cities and counties" or "Subdivisions" in the report.

**Plaintiff Subdivision:** A Subdivision located in California, other than a Litigating Special District, that filed a lawsuit, on behalf of the Subdivision and/or through an official act of the Subdivision on behalf of the People of the State of California, against one or more Opioid Defendants prior to October 1, 2020.<sup>4</sup> Unless otherwise noted, Plaintiff Subdivisions are included when referring to Participating Subdivisions, Subdivisions, or Participating cities and counties.

**Special Master:** A retired judicial officer or former public lawyer not presently employed or retained by a Plaintiff Subdivision, who will aggregate, review, and determine the reasonable Costs to be awarded to each Plaintiff Subdivision that submits a claim for reimbursement of Costs. The Special Master was selected by a majority vote of the votes cast by Plaintiff Subdivisions.

**State Fiscal Year (FY):** The California state fiscal year (FY) begins July 1 each year and concludes June 30 the year directly following (e.g., July 1, 2022 – June 30, 2023). The shorthand of a state FY will be the year in which the FY begins (e.g., 2022), followed by the last two digits of the year in which the FY ends (e.g., 23) and shown as "FY 2022-23".

Subdivision: See "Participating Subdivision".

# **EXECUTIVE SUMMARY**

# **Report Overview**

The California Opioid Settlements Annual Expenditures Report for state fiscal year 2022-23 (FY 2022-23) provides aggregated financial data and narrative summaries of the state and the participating cities and counties' payments, and expenditures of opioid settlement funds for the period of July 1, 2022, through June 30, 2023. This report provides background on the national opioid settlements and opioid-related bankruptcies, and California's participation in these settlements, including California's State-Subdivision Agreements (SSA).<sup>5</sup> To compile this report, DHCS received detailed use and expenditure information from California state departments, counties, and cities in receipt of opioid settlement funds in FY 2022-23. The report contains three parts:

- 1. Introduction and Background of the opioid crisis, opioid settlements and opioid-related bankruptcies, California's payments, expenditure requirements and restrictions, and California's additional state-specific requirements.
- 2. State-Directed Projects including payment amounts, state department appropriations, and state-directed project overviews.
- **3. City and County Projects and Expenditures** including total payment amounts, payments by fund type and settlement/bankruptcy, detailed expenditures in FY 2022-23, and highlighted local projects.

# **Financial Overview**

In total, California and its participating cities and counties received over **\$362.5 million** in payments from three opioid settlements and one opioid-related bankruptcy, described later in this report, during FY 2022-23. Over **61 percent** of these funds were distributed directly to California's cities and counties for local opioid remediation strategies, as outlined in the national and state-specific agreements.

#### **State Allocation**

At the state level, California received payments totaling over **\$141 million** from three opioid settlements and one opioid-related bankruptcy in FY 2022-23. This amount reflects the total

amount of payments received in FY 2022-23 by the State of California from the Janssen, Distributors, and McKinsey settlements and the Mallinckrodt bankruptcy.<sup>6</sup>

Table #1 provides the total amount of payments received by California for state-directed projects (i.e., amount deposited into Litigation Deposits Fund), the amount transferred into the Opioid Settlements Fund (i.e., amount available for state appropriation), and the amount appropriated for state-directed opioid remediation activities, as identified in the <u>2022-23</u> <u>California Budget.</u>

Based on the data presented in Table #1, California immediately appropriated over **97 percent** of its available opioid settlement funds to begin state-directed opioid remediation activities. For more information on the state's share of FY 2022-23 opioid settlement funds, including a breakdown of FY 2022-23 payments, appropriations, and project overviews, please see the State Payments and State-Directed Projects section of the report.

#### Local Spending

California's participating cities and counties received payments totaling over **\$221.5 million** from two opioid settlements and one opioid-related bankruptcy in FY 2022-23. This amount reflects the total amount of payments received in FY 2022-23 from the Janssen and Distributors settlements, and the Mallinckrodt bankruptcy.

Table #2 provides the total payment amount received and the total amount spent by all participating cities and counties in FY 2022-23. Expenditures include project costs,

administrative costs, and past opioid-related expenses. Participating cities and counties cumulatively spent approximately **2 percent** of the total amount of payments received by all participating cities and counties. More information on the participating city and county expenditures, including an overview of opioid remediation activities pursued, can be found in the City and County Payments and Expenditures section of the report.

# **Key Findings**

#### **Opioid Settlement Funds Supported Statewide Priorities**

Payments made to the State of California were deposited in the State's Opioid Settlements Fund and distributed across state departments including DHCS, the California Department of Public Health (CDPH), and the California Department of Rehabilitation (DOR). These funds supported statewide initiatives based on California's current opioid priorities, including:

- » Bolstering California's substance use provider workforce.
- » Releasing opioid awareness and anti-stigma campaigns.
- » Increasing naloxone distribution efforts.
- » Creating a substance use treatment locator.
- » Improving statewide overdose data collection.

#### High Spending from Participating Cities and Counties on Harm Reduction Efforts

The National Opioid Settlement Agreements provide a "List of Opioid Remediation Uses", referred to as Exhibit E, for participating cities and counties to pursue with their funds. An identical list, titled Exhibit 4, can be found in the <u>National Opioid Abatement Trust (NOAT) II</u> <u>Distribution Procedures</u> for the Mallinckrodt bankruptcy. During FY 2022-23, **50** out of **272** participating cities and counties (over **18 percent**) reported expenditures totaling **\$4,962,303.99**. Of those expenditures, **\$4,590,464.94** (or approximately **93 percent**) was spent on a remediation use attributable to an Exhibit E category. The largest proportion of spending amongst the 50 cities and counties that reported expenditures, was associated with the "Prevent Overdose

Deaths and Other Harms (Harm Reduction)" category within Exhibit E, making up nearly half, approximately **46 percent**, of all reported participating city and county expenditures.

#### **Continuing Opportunities for Future Opioid Remediation Activities**

Many of the opioid settlements will continue providing payments over several years (through FY 2038-39 in the case of the Distributor Settlement Agreement). Additional settlements with opioid manufacturers, distributors, pharmacies, marketing agencies, and other entities are final and have begun providing funding, while other proposed settlements are currently pending. These settlements are expected to provide substantial funds to California in future years.

The California SSA also allows for most funds to be expended or encumbered within five years generally and up to seven years for capital outlay projects beginning the year in which the payment was received. Many participating cities and counties elected to rollover funds in FY 2022-23 to pursue strategic planning activities, finance potentially larger opioid remediation projects in the future, or reallocate and pool resources with other participating cities and counties. DHCS has met with and provided technical assistance to numerous participating cities and counties on future uses of their funds to make each locality aware of the opportunities these funds provide for their communities.

### **Summary Conclusion**

The California Opioid Settlements Annual Expenditures Report reflects DHCS' commitment to ensure California is utilizing funds from the opioid settlements and opioid-related bankruptcies solely for allowable opioid remediation activities. Although many participating cities and counties elected to hold their FY 2022-23 payments for future opioid remediation activities, DHCS will continue to monitor funding expenditures to ensure compliance with the requirements while providing transparency to the public on the expenditures of these funds.

# **Introduction and Background**

The opioid crisis has evolved from a prescription opioid epidemic during the 1990s to a rise in heroin use beginning in the early 2010s.<sup>9</sup> Today, synthetic opioids such as fentanyl, which is 50 times more powerful than heroin, are pervasive in the illicit drug supply and are causing unprecedented harm.<sup>10</sup> The history of the opioid epidemic is directly attributed to pharmaceutical companies that promoted highly addictive prescription opioids in the late 1990s. These companies are alleged to have fueled the opioid crisis by downplaying risks of the medications, exaggerating their benefits, and engaging in reckless distribution practices that misinformed the public about the impacts of prescription opioids.

California has joined national settlements with opioid manufacturers, distributors, and other entities in an effort to abate the opioid epidemic. As a result, California received funds from three opioid settlements and one opioid-related bankruptcy in FY 2022-23. California is expected to receive additional funds from these, and other, settlements to be used for future opioid remediation and other opioid-related activities through 2038.<sup>11</sup>

In FY 2022-23, over **\$362.5 million** was paid to California and its participating cities and counties from the McKinsey, Janssen, and Distributor Settlements and the Mallinckrodt bankruptcy. Table #3 provides an overview of these payments received by California in FY 2022-23.

#### **Janssen and Distributor Settlements**

In 2021, opioid manufacturer Janssen Pharmaceuticals, Inc., and its parent company Johnson & Johnson (together, Janssen), and distributors McKesson, Cencora (formerly AmerisourceBergen), and Cardinal Health (collectively, the Distributors) were the first entities to enter global settlements to resolve lawsuits and investigations brought by state, local, and tribal governments. In all, it's expected that the Distributors will pay up to \$21 billion over 18 years, and Janssen will pay up to \$5 billion over 9 years.<sup>12</sup> California is expected to receive up to \$1.8 billion from the Distributors and up to \$423 million from Janssen.

#### Mallinckrodt Bankruptcy

Mallinckrodt PLC (Mallinckrodt), a drug distributor and manufacturer, filed for bankruptcy in October 2020. As part of the bankruptcy, the company agreed to pay \$1.725 billion over eight years to the National Opioid Abatement Trust II (NOAT II) that would make payments to states and local governments (participating cities and counties) for opioid abatement. Mallinckrodt made its first payment totaling \$450 million to NOAT II in June 2022. California and counsel representing a group of cities and counties reached agreement on the allocation of funds, which is reflected in the abatement agreement filed with the court in December 2022. In January 2023, California received over \$15 million, of which the state received \$6 million and participating cities

and counties received \$9 million. Mallinckrodt failed to make its second scheduled payment to NOAT II and ultimately filed a second bankruptcy in August 2023. Prior to the second bankruptcy filing, Mallinckrodt agreed to settle with NOAT II for a one-time payment of \$250 million. In November 2023, California received approximately \$17 million, with \$7 million allocated to the state and \$10 million allocated to participating cities and counties.<sup>13,14</sup>

#### **McKinsey Settlement**

In February 2021, a \$573 million settlement with one of the world's largest consulting firms, McKinsey & Company (McKinsey), was announced after an investigation into the company's role in advising opioid companies, helping those companies promote their drugs, and profiting from the opioid epidemic. California will receive over \$59 million from this settlement.

This settlement differs from the Janssen and Distributor Settlements in that it was a states' only settlement, with all funds for the state's exclusive use on opioid abatement. Cities and counties, along with school districts, separately settled with McKinsey for \$230 million in February 2024.<sup>15</sup>

### **Oversight of the Opioid Settlement Funds**

Current national opioid litigation is frequently contrasted against the Tobacco Master Settlement Agreement (MSA) of the 1990s, an approximately \$200 billion settlement between 46 states and several of the biggest tobacco manufacturers in the US. Critics of the Tobacco MSA note that while states continue to collect billions of dollars from the tobacco settlements, only a small fraction of those funds are spent on smoking prevention and cessation program.<sup>16</sup> This divergence of MSA funds is often attributed to the absence of clear parameters and guidance on spending requirements when the settlement agreement was first established.<sup>17</sup>

To prevent a similar outcome with the opioid settlement and opioid-related bankruptcy

funds, the National Opioid Settlement Agreements and NOAT II Distribution Procedures require the vast majority of funds to be used for opioid abatement. The National Opioid Settlement Agreements and NOAT II Distribution Procedures established a list of eligible opioid remediation activities (referred to as "Exhibit E" in the National Opioid Settlement Agreements and "Exhibit 4" in the NOAT II Distribution Procedures). This list guides California and its localities on appropriate spending for the abatement funds. These activities include opioidfocused treatment services, harm reduction initiatives, community prevention and education campaigns, and the evaluation of community interventions. The California SSA and California Mallinckrodt Statewide Abatement Agreement mandate further requirements on the use of opioid settlement funds.

In addition, the California SSA and Statewide Abatement Agreement named DHCS as the oversight and monitoring entity for these funds. DHCS oversees annual reporting on the opioid settlement expenditures. DHCS also provides cities and counties with guidance on requirements for the funds, including direct technical assistance to cities and counties pursuing opioid remediation activities.

### **Settlement Agreements Overview**

The state and counsel representing a group of California cities and counties reached an agreement on the allocation of funds that California receives from the national opioid settlements. These agreements on intrastate allocation are formally adopted by California cities and counties through the sign-on process, which acceptance is a condition of a city or county joining these settlements. Copies of the allocation agreements for the two settlements, which became final through court-ordered judgments, and that made payments in FY 2022-23, are available here:

- » California State-Subdivision Agreement Distributors
- » California State-Subdivision Agreement Janssen

Table #4 below, outlines the allocation structure.<sup>18</sup>

Funds from opioid settlements do not pass through DHCS. Payments to the State of California (CA State Fund), Participating Subdivisions (CA Abatement Accounts Fund), and Plaintiff Subdivisions (CA Subdivision Fund) are distributed by the Directing Administrator, BrownGreer, PLC.

#### **CA Abatement Accounts Fund**

Allocations from the CA Abatement Accounts Fund must be expended on future opioid remediation activities in one or more of the areas described in <u>Exhibit E</u>, as required in the California SSA. The individual CA Abatement Accounts Fund allocation for participating cities and counties, is based on an allocation model that can be found in the respective SSA. CA Abatement Accounts Fund key highlights include:

- » Funds must be expended or encumbered within five years of receipt or up to seven years of receipt for capital outlay projects.
- » Funds may be reallocated among other participating cities and counties assuming that reallocations are agreed upon and used for eligible opioid remediation activities.
- » Funds are restricted to one or more uses listed in Exhibit E.
- » No less than 50 percent of the funds received by a participating city or county in each calendar year, must be spent on High Impact Abatement Activities.

#### **High Impact Abatement Activities**

In addition to the agreed upon allocation of recoveries that California receives, the State of California and counsel representing cities and counties, agreed on a set of additional opioid remediation uses that must be prioritized by Participating Subdivisions. These priorities, referred to as High Impact Abatement Activities (HIAA), were informed by California's opioid remediation priorities and are intended to direct funds to services for populations disproportionately impacted by the opioid crisis. As required in the SSA and DHCS Behavioral



Health Information Notice (BHIN) <u>24-002</u>, no less than 50 percent of the funds received by a Participating Subdivision in each calendar year must be used for one or more of the HIAA, listed below:

- 1. Provision of matching funds or operating costs for substance use disorder facilities within the <u>Behavioral Health Continuum Infrastructure Program</u> (BHCIP).
- 2. Creating new or expanded substance use disorder treatment infrastructure.
- 3. Addressing the needs of communities of color and vulnerable populations (including sheltered and unsheltered homeless populations) that are disproportionately impacted by substance use disorder.
- 4. Diversion of people with substance use disorder from the justice system into treatment, including by providing training and resources to first and early responders (sworn and non-sworn) and implementing best practices for outreach, diversion and deflection, employability, restorative justice, and harm reduction.
- 5. Interventions to prevent drug addiction in vulnerable youth.
- 6. The purchase of naloxone for local entities including for distribution and efforts to expand access to naloxone for opioid overdose reversals.

#### **CA Subdivision Fund**

Fifteen percent of the total payments are allocated to the CA Subdivision Fund to be allocated among the Plaintiff Subdivisions (Subdivisions that filed lawsuits against one or more Opioid Defendant prior to a certain date) that are Initial Participating Subdivisions in that particular settlement. Funds from the CA Subdivision Fund must be used, subject to any limits imposed by the respective Settlement Agreement and the SSA, to fund future Opioid Remediation and to reimburse past opioid-related expenses, which may include fees and expenses for opioidrelated litigation, and to pay the reasonable fees and expenses of the Special Master. CA Subdivision Fund key highlights include:

- » Funds are not restricted to expenditure timeframes but are encouraged to be spent within similar periods as the CA Abatement Accounts Fund, pursuant to DHCS' <u>BHIN 24-003</u>.
- » Funds may be reallocated among Plaintiff Subdivisions assuming that reallocations are agreed upon and used for Opioid Remediation.
- » Funds are restricted for future Opioid Remediation and to reimburse past opioid-related expenses.
- » Funds are not subject to the HIAA spending requirements.



The CA Subdivision Fund is allocated as follows:

- a) First, funds in the CA Subdivision Fund shall be used to pay the Special Master's reasonable fees and expenses.
- b) Second, funds will be allocated to Plaintiff Subdivisions that are Initial Participating Subdivisions that have been awarded Costs.
- c) Funds remaining in the CA Subdivision Fund, which shall consist of no less than 50 percent of the total CA Subdivision Fund received in any year, will be distributed to Plaintiff Subdivisions that are Initial Participating Subdivisions, in relative proportion to the Local Allocation. These funds shall be used to fund future opioid-related projects and to reimburse past opioid-related expenses, which may include fees and expenses related to litigation against any Opioid Defendant.

#### Use of Subdivision Funds for Opioid-Related Legal Fees and Costs

Pursuant to the SSA, Plaintiff Subdivisions may be reimbursed from their Subdivision Fund allocation for past opioid-related litigation fees and costs.

Plaintiff Subdivisions using CA Subdivision Funds on opioid-related legal fees or costs must file a "Non-Opioid Remediation Use Report" with the Directing Administrator, Brown Greer, PLC, as required under the National Opioid Settlement Agreements. The national agreements consider legal fees and costs to be a non-opioid related use, even if such costs were incurred for opioidrelated litigation, as such expenditures were not used directly for opioid remediation.

#### **CA State Fund**

Allocations from the CA State Fund are deposited into the California OSF and must be used for future Opioid Remediation. The OSF was created in the State Treasury through <u>Government</u> <u>Code, Title 2, Division 3, Part 2, Chapter 6, Article 2, Section 12534</u> to distribute opioid settlement funds allocated to the state for state-directed opioid remediation efforts. State-directed activities funded by the OSF, are appropriated by the California legislature, and led by California's state agencies and departments.

In addition to funds for abatement, the National Opioid Settlements provide funding to states for costs incurred by the state for its opioid-related investigations and litigation. More Information on payment amounts and fund transfers can be found in the State Payments and State-Directed Projects section of the report.



#### **Bankruptcy Agreement Overview**

As a result of the Mallinckrodt settlement and bankruptcy, California, and counsel representing a group of California cities and counties, reached an agreement on the allocation of recoveries that California receives, pursuant to the Statewide Abatement Agreement. A copy of the allocation agreement for the bankruptcy is available here:

Like the opioid settlements, funds from the Mallinckrodt bankruptcy do not pass through DHCS. Payments to the State of California (NOAT II – State Share) and Local Governments (NOAT II – Local Government Share) are distributed by the NOAT II Trustees.

#### **NOAT II - Local Government Share**

Allocations from the NOAT II – Local Government Share must be expended on future opioid remediation activities in one or more of the areas described in Exhibit 4 (Exhibit E), as required in the Statewide Abatement Agreement. Funds from NOAT II are not subject to the HIAA spending requirements found in the California SSA. The individual allocations are connected to elections made by participating cities and counties for the national Distributors Settlement. Specifically, allocations are distributed to the county in which a city is located unless the city elected to receive its share of funds in the Distributor Settlement. If a city later changes its distribution election in the Distributor Settlement, that change in election will apply to their Local Government share for the Mallinckrodt bankruptcy, provided that the change in election is received by NOAT II at least 60 days before distribution.

#### **NOAT II - State Share**

Like the CA State Fund, allocations from the NOAT II – State Share are deposited into the California OSF and must be used for future opioid remediation. Usage of this state share is



appropriated by the California legislature and led by California's designated state agencies and departments. More Information on the OSF and state allocation fund transfers can be found in the State Payments and State-Directed Projects section of the report.

### **Opioid Settlements Fund**


The Opioid Settlements Fund (OSF) was created in the State Treasury through <u>Government</u> <u>Code, Title 2, Division 3, Part 2, Chapter 6, Article 2, Section 12534</u> to deposit opioid settlement funds allocated to the state for state-directed opioid remediation. State-directed activities funded by the OSF are limited to opioid remediation activities in accordance with the terms of the judgment or settlement from which the funds were received.

#### **Litigation Deposits Fund and Fund Transfers**

Payments to California for state abatement are first deposited into the Litigation Deposits Fund (LDF) which is administered by the California Department of Justice (DOJ). Upon order of the Director of Finance, all funds received in the LDF allocated for state abatement are transferred to the OSF (Infographic 1).

In addition to funds dedicated for state abatement, the National Opioid Settlements provide funding to states for costs and expenses incurred by the state for its opioid-related investigations and litigation. While these funds are allocated to reimburse for costs and expenses, the vast majority will be transferred to the OSF to be used by the state for opioid remediation.

The LDF is an interest-bearing account. Interest earned on funds from the LDF are considered opioid settlement funds and subject to the same spending requirements as direct settlement payments.

# **State Payments and State-Directed Projects**

This section provides details on payments made to the state from opioid settlements and opioid-related bankruptcies and includes details on California's appropriations to state agencies for state-directed opioid remediation activities. California received an allocation of funds from opioid settlements (CA State Fund), the Mallinckrodt Bankruptcy (NOAT II – State Share), and from a settlement with McKinsey and Company (states only) in FY 2022-23. Payments are made to the State of California by third-party administrators <u>BrownGreer, PLC</u> (CA State Fund) and <u>NOAT II</u> (Mallinckrodt Bankruptcy) and direct payments to the state from the McKinsey and Company settlement.

#### **State Payments and Transfers**

California received a total of **\$141,031,249.51** in FY 2022-23. This total includes payments from the Janssen, Distributor, and McKinsey settlements, and the Mallinckrodt bankruptcy.

Table #6 shows all payments California received from each settlement in FY 2022-23.19

In FY 2022-23, the LDF accrued approximately **\$686,183.31**<sup>20</sup> in interest before funds were transferred into the OSF. In addition, **\$10 million** (roughly **7 percent**) was retained by the DOJ for reimbursement for its past opioid-related investigations and litigation. A total of **\$131,717,427.83** was transferred into the OSF in FY 2022-23.

### **State Budgetary Appropriations**

Governor Newsom's FY 2022-23 California budget appropriated **\$127.829 million** from the OSF to support state-directed opioid remediation activities and DHCS' opioid settlement fund oversight responsibilities.





#### Substance Use Provider Workforce Training (DHCS)

In addition to the increasing need for opioid use disorder treatment services, California is facing a behavioral health workforce shortage. Approximately 2.9 million Californians have a substance use disorder and yet there are fewer than 20,000 substance use disorder counselors across the state.<sup>22,23</sup> DHCS is expanding California's behavioral health workforce to address this shortage and improve access to services.

DHCS implemented this project as part of the <u>Behavioral Health Workforce Development</u> (<u>BHWD</u>) <u>Initiative</u>, <u>Mentored Internship Program (MIP</u>)</u>. MIP offers funding to support paid internships for students 18 and older in behavioral health organizations providing substance use services. Each intern is assigned a mentor to provide support for their work in the behavioral health profession. The program prioritizes recruiting students from underserved

and diverse communities and connects them with providers from a similar background to help build a stronger, more diverse workforce. In FY 2022-23, MIP used opioid settlement funds to enhance the number of skilled individuals trained to treat substance use, through new and continued funding opportunities to community service organizations. MIP also helped behavioral health providers enhance school-to-provider workforce pathways, and equipped interns with necessary skills through training and support.

#### Youth Opioid & Fentanyl Education and Awareness Campaign (CDPH)

Young adults, aged 18 to 25, are nearly twice as likely to have a substance use disorder compared to adults 26 and older, and more than three times as likely as adolescents aged 13 to 17.<sup>24</sup> Media and public awareness campaigns have been shown to shift key attitudes and increase knowledge around opioid misuse and dependence. This awareness can lead to decreased stigma and a greater willingness to seek help or share resources.<sup>25</sup> California created the Youth Opioid Fentanyl Education and Awareness Campaign to prevent substance use and overdoses, increase awareness of fentanyl contamination, and offer life-saving strategies to respond to the opioid crisis. The campaign utilizes Centers for Disease Control and Prevention (CDC) ads called Facts on Fentanyl and Lifesaving Naloxone.

Initial messaging for the campaign launched in September 2023, focusing on counties with the highest rates of overdose according to the <u>California Overdose Surveillance Dashboard</u>. The target audience for the campaign is Californians ages 16 to 39. The audience includes a multicultural demographic, including Black/African American, American Indian/Alaska Native, Hispanic/Latinx, Asian/Pacific Islander and LGBTQ+ populations. Media placements include streaming video and audio (YouTube, Hulu, Spotify), social media (Facebook, Instagram, Snapchat, TikTok), digital display banners, digital out-of-home media (transit shelters, billboards, college/shopping mall screens, and checkout screens), and paid search terms (Google search keywords). In fall of 2024, the campaign intends to launch more extensive messaging related to the dangers of fentanyl and how to reverse an overdose with naloxone, through additional media channels.

#### **Naloxone Distribution Project (DHCS)**

Naloxone is a lifesaving drug that can rapidly reverse an opioid overdose. Naloxone works by blocking the opioid receptor sites and reversing the toxic effects of the overdose. It has few known adverse effects and no potential for abuse. Increasing the availability of naloxone allows bystanders or first responders to reverse an overdose.<sup>26</sup> DHCS created the Naloxone Distribution Project (NDP) in 2018 to combat opioid overdose-related deaths through the provision of free naloxone. First responders, schools, health departments, community organizations, and law enforcement entities may apply to the NDP to have naloxone shipped directly to their address. As of December 2024, the NDP in California has distributed more than five million units of naloxone, which have been used to reverse more than 324,000 opioid overdoses (Infographic 2).<sup>27</sup>

In FY 2022-23, the NDP used the opioid settlement funds to expand naloxone distribution among programs and providers addressing the needs of individuals experiencing homelessness. Through this funding, the NDP was able distribute more than 40,968 kits to approximately 66 unique homeless service organizations, resulting in 959 overdose reversals for this at-risk community (Infographic 2).<sup>27</sup>



# Atlas Platform and Outreach Campaign (DHCS)

While an estimated nine percent of Californians had a substance use disorder in 2018, only ten percent of those individuals received any type of treatment (Infographic 3).<sup>28</sup> Individuals encounter significant obstacles when seeking treatment, including navigating the complex substance use disorder treatment system, financial constraints, and geographic distance.<sup>29,30,31</sup>



In addition to the obstacles in finding treatment, it is often challenging for individuals and families to determine which treatment options are best suited to their needs, offer high quality services, and are covered by their insurance.

In FY 2022-23, DHCS partnered with the organization Shatterproof to build <u>TreatmentAtlas.org</u>, a free, easy-to-use online directory of substance use treatment facilities in California. Treatment Atlas includes dynamic search filters and an American Society of Addiction Medicine (ASAM) substance use assessment embedded in the search tool, so that individuals can find the best substance use disorder service for their needs. Treatment Atlas provides information about the level of care offered in facilities, services provided, and payment options. Shatterproof intends to expand outreach, increase the use of this resource, and coordinate with Unshame California to raise awareness of substance use disorder treatment.

#### Statewide Anti-Stigma Campaign: Unshame California (DHCS)

The stigma associated with substance use can pose a significant impediment to accessing treatment, resulting in individuals delaying their engagement with services. Stigma towards



people with substance use disorders can also hinder the provision of optimal care. However, research indicates that awareness campaigns can help mitigate the stigma associated with substance use disorder and treatment.<sup>32,33,34</sup> <u>Shatterproof's National Stigma Initiative</u> is dedicated to changing attitudes about substance use disorder.

In FY 2022-23, California partnered with Shatterproof to conduct a needs assessment in the state to identify problematic substances within counties, stigma related issues, gaps in training, and community-specific needs for information. This information, along with stories collected from individuals in recovery, served as the basis for the Unshame California campaign, which launched in March 2023. As part of the campaign, local social media influencers promoted key health messages around opioid use disorder and the need for treatment, in collaboration with Unshame California's social media accounts (@UnshameCA and @SomosUnshameCA). Shatterproof also

launched the website <u>Unshame California</u>, which hosts free trainings, resources, and shares personal stories to reduce stigma associated with substance use disorder.

#### **Opioid Overdose Data Collection and Analysis (CDPH)**

Real-time tracking of overdose and drug responses enables the early detection of spikes in non-fatal overdoses, helping allocate resources efficiently and target interventions to specific geographic areas of concern. Successful surveillance programs have been able to respond to increases in non-fatal overdoses through shared data, targeted messaging, deployment of community coordination efforts to connect people to services, and distribution of naloxone to mitigate outbreaks.<sup>35,36,37</sup>

CDPH launched the Overdose Data Collection & Analysis Project (ODCAP) to improve overdose surveillance and allow California health departments to respond more rapidly to overdose spikes. The project intends to support near real-time tracking of non-fatal overdose and drug misuse surveillance, through the CDC's <u>BioSense Platform</u>. In FY 2022-23, ODCAP launched a pilot surveillance dashboard using data from Riverside County, to allow for user testing and begin developing best practices in accessing, working with, and displaying surveillance data.

#### Integrating Employment in Recovery Pilot Project (DOR)

Studies show that individuals who are employed are more likely to feel integrated into their communities after treatment, and less likely to relapse.<sup>38</sup> Employment provides many benefits for individuals in treatment for substance use disorders, including stable income, positive social connections, and a sense of self-sufficiency.<sup>39</sup> Historically, however, employment and career

training has been a secondary focus in substance use treatment programs.

California established a pilot program, Integrating Employment in Recovery, to provide training to substance use treatment facilities on incorporating employment services into recovery. Through the program, the California Department of Rehabilitation provides vocational rehabilitation employment services co-located within treatment centers. In FY 2022-23, four treatment centers were selected to serve in the pilot, based on their abilities to serve diverse populations and offer a variety of services. Individuals in treatment received vocational programming from peer specialists on topics such as career exploration, resume development, interviewing techniques, and self-advocacy.

#### **Opioid Settlement Oversight**

Within the SSAs and Government Code 12534, DHCS is named as the entity to oversee the State and participating cities and counties' use of funds over the periods of fund distribution. To support DHCS with these responsibilities, the department was appropriated \$1.716 million to fund 11 new positions and \$1 million for contracted resources.

While DHCS staff are the primary individuals responsible for DHCS' opioid settlement responsibilities, contracted resources were appropriated to assist with the anticipated high volume of technical assistance needs to participating cities and counties as well as the multitude of stakeholder engagement, monitoring, oversight, and reporting activities. Aurrera Health Group is DHCS' contractor assigned to assisting with opioid settlement funds technical assistance activities including facilitating webinars, engaging stakeholders, and developing resources for cities and counties.

# **City and County Payments and Expenditures**

The following section provides an overview of all participating cities and counties payments and expenditures during FY 2022-23. Funds are provided to cities and counties by third-party administrators (BrownGreer, PLC and NOAT II) and are distributed through three types of fund allocations: CA Abatement Accounts Fund, CA Subdivision Fund, and NOAT II Fund – Local Government Share.

### **City and County Payments**

In FY 2022-23, participating cities and counties received a combined total of **\$221,554,974.92**. Table #8 below contains total amounts received per fund from settlements and NOAT II for the Mallinckrodt Bankruptcy.

# **City and County Total Spending**

In total, cities and counties reported spending **\$4,962,303.99** in FY 2022-23, approximately **2 percent** of their total received payments. In addition to spending funds on allowable opioid remediation activities, participating cities and counties can also carry over or encumber funds.<sup>40</sup>

Chart #3 shows the relative amount of spent funds and remaining funds against the total amount received in FY 2022-23. The remaining (i.e., unspent) funds are retained by the Participating Subdivisions to use in future FYs.



### Spending by Exhibit E Category

In annual reports filed with DHCS, participating cities and counties were asked to report their total expenditures (i.e., spent funds) and select the Exhibit E category most associated with their project(s).

Cities and counties reported spending **\$4,590,464.94** (or **93 percent** of all expenditures) on remediation projects with an attributable Exhibit E Category. The largest proportion of spending was associated with the "Prevent Overdose Deaths and Other Harms (Harm Reduction)" category. Approximately **46 percent** of all Exhibit E expenditures during FY 2022-23 fell into this category. Much of this spending was associated with the purchase and distribution of naloxone and overdose training for individuals and communities.

The second highest expenditure category was "Addressing the Needs of Criminal Justice-Involved Persons," at **19 percent** of expenditures.

The third highest expenditure category was "Support People in Treatment and Recovery," comprising **13 percent** of expenditures.

FY 2022-2023



### **Spending by Account Type** The CA Abatement Accounts Fund

Allocations from the CA Abatement Accounts Fund must be spent on future opioid remediation activities in one or more of the areas described in <u>Exhibit E</u>. Cities and counties must also dedicate at least 50 percent of their funds received in each calendar year on one or more of the HIAA. Additionally, funds from the CA Abatement Accounts Fund may be spent on reasonable and related administrative expenses.

In FY 2022-23, **267** cities and counties received **\$177,727,258.15** from the CA Abatement Accounts Fund. Out of **267** cities and counties, **34** reported expenditures totaling **\$4,290,421.94**. A full list of city and county CA Abatement Accounts Fund payments and expenditures can be found in Appendix B.<sup>42</sup>


A total of **\$12,200.08** (**0.28 percent**) was reported to have been spent on related administrative expenses.

Subtracting the administrative expenses from the total expenditures, cities and counties spent a total of **\$4,278,221.86** from the CA Abatement Accounts Fund on Exhibit E opioid remediation activities. Exhibit E spending categories for the CA Abatement Accounts Fund mirror the categories listed in the prior section, *Spending by Exhibit E Category*. This is because the CA Abatement Accounts Fund accounted for **80 percent** of all the funds received by cities and counties, making it the largest driver of spending at the local level.

The following figure represents aggregate data from the **34** cities and counties that spent CA Abatement Accounts funds on Exhibit E activities during the FY 2022-23.

#### **High Impact Abatement Activities (HIAA)**

In FY 2022-23, cities and counties spent a total of **\$3,960,262.70** on activities that met California's HIAA requirements. This accounted for **92 percent** of funds, including administrative expenses, spent from the CA Abatement Account.<sup>43</sup>

Cities and counties reported **\$317,959.16** in spending that did not fall into one of the HIAA categories. This is about **seven percent** of all funds spent from the CA Abatement Accounts Fund.

The most frequent HIAA category for this reporting period was HIAA 6: The purchase of naloxone for distribution and efforts to expand access to naloxone. Approximately **50 percent** of all HIAA expenditures during the FY 2022-23 year were spent on this category, for a total of **\$1,996,640.40**.

The second most frequent category was HIAA 3: Addressing the needs of communities of color and vulnerable populations disproportionately impacted by substance use disorder. This accounted for **\$1,665,420.68**, or about **42 percent** of all HIAA expenditures.

**\$157,936.67** was spent on HIAA 1: Provision of matching funds or operation costs for substance use disorder facilities with an approved project within the <u>Behavioral Health</u> <u>Continuum Infrastructure Program (BHCIP</u>), and **\$116,415.56** was spent on HIAA 2: Creating new or expanded substance use disorder treatment infrastructure. These activities comprised **four percent** and **three percent** of spending, respectively.


Less than **one percent** of HIAA spending was dedicated to the last two HIAA categories. **\$5,566.50** was spent on HIAA 4: Diversion of people with SUD from the justice system and **18,282.89** was spent on HIAA 5: Interventions to prevent drug addiction in vulnerable youth.

## The CA Subdivision Fund

Remaining funds<sup>44</sup> from the CA Subdivision Fund must be used for future opioid-related projects but not limited to the activities listed in Exhibit E and not subject to the California HIAA requirements. Funds can also be used to reimburse past opioid-related expenses, which may include fees and expenditures related to opioid litigation and can also be spent on related administrative expenses.

In FY 2022-23, **75** cities and counties received **\$34,801,878.12** from the CA Subdivision Fund. Out of **75** cities and counties, **10** reported expenditures totaling **\$546,342.14**. A full list of city and county CA Subdivision Fund payments and expenditures can be found in Appendix C.<sup>45</sup>



**\$187,065.10** was reported to have been spent on projects attributable to an Exhibit E category, **\$194,035.13** was reported to have been spent on an allowable use that is not attributable to an Exhibit E category, **\$163,105.62** was reported to have been spent on legal expenses, and **\$2,136.29** was reported to have been spent on related administrative expenses.

## **NOAT II – Local Government Share**

Similar to the CA Abatement Accounts Fund, funds from NOAT II must be used for opioid remediation in one or more of the areas described in Exhibit 4 of the Mallinckrodt Bankruptcy Plan, which is the same list in Exhibit E of the National Opioid Settlement Agreements. Unlike the CA Abatement Accounts Fund, allocations from NOAT II are not subject to the California HIAA requirement. Additionally, funds may be spent on reasonable related administrative expenses, up to five percent of a city or county's allocation.

In FY 2022-23, **264** cities and counties received **\$9,025,838.65** from NOAT II – Local Government Share. Out of **264** cities and counties, **16** reported expenditures totaling **\$125,539.91**. A full list of city and county NOAT II – Local Government Share payments and expenditures can be found in Appendix D.<sup>46</sup>

**\$361.93** (**0.29 percent**) was reported to have been spent on related administrative expenses.


In FY 2022-23, cities and counties spent a total of **\$125,177.98** from the NOAT II Fund – Local Government Share on Exhibit 4 (i.e., Exhibit E) opioid remediation activities. Approximately **55 percent** was spent on the category, "Treat Opioid Use Disorder", **21 percent** on "Prevent Misuse of Opioids," and **14 percent** on "Prevent Overdose Deaths and Other Harms (Harm Reduction)".

## **Highlighted Strategies for Opioid Remediation**

California elected to have the majority of funds from the opioid settlements and bankruptcy distributed directly to cities and counties. Cities and counties received their first payments from these agreements during FY 2022-23. While most cities and counties elected to reserve their funds for future activities, several used their funds to establish or expand opioid remediation efforts. The following section highlights innovative efforts from two cities and two counties.

## **Corcoran: Using Settlement Funds to Address Co-occurring Needs**

The City of Corcoran is a small, rural community located in the Central San Joaquin Valley of California with a population of just under 23,000. Due to the city's rural location (20 miles from the Kings County seat of Hanford) and small population, Corcoran City has a small budget for services to address community needs. The need for community services has grown in recent



years as Corcoran's downtown business district has seen a rise in homelessness, with a growing population of unhoused individuals with co-occurring mental health and substance use disorders residing in an encampment in a park.

Corcoran City received \$24,335.54 in opioid settlement and bankruptcy funds, which city administrators directed \$4,344.86 towards addressing the needs of individuals residing in the park. The city intends to direct future funds toward this same activity. In FY 2022-23, the city established a 12-month service contract with Kings Community Action Organization to conduct on-the-ground outreach within the encampment. A team comprised of housing staff, behavioral health professionals, health and human services staff, and substance use disorder treatment program employees visited the encampment to assist individuals based on their needs. Kings Community Action Organization provided connections to a variety of social support programs including access to a food bank, housing assistance (e.g., Bridge Housing), and low barrier treatment for substance use disorder. Corcoran staff noted that the opioid settlement funding was crucial in supplementing city funds to bring services from the larger city of Hanford to the small city of Corcoran, and to adequately address the needs of individuals residing in the downtown encampment.

## **Lompoc: Installing Naloxone Boxes on City Properties**

Lompoc, California is a suburban city in Santa Barbara County located on California's Central Coast with a population of about 44,000 residents. Opioid-related overdoses have continued to rise in the county, with a growing number of emergency calls requiring the use of opioid overdose reversal medications.

Lompoc City received \$88,531.97 in opioid settlement funds in FY 2022-23, a portion of which the city directed toward expanding naloxone availability. With the support of the Lompoc City Council, the Lompoc Fire Department used opioid settlement funds to establish ten overdose response boxes throughout the community. The overdose response boxes included two units of naloxone, CPR masks, and a direction booklet to aid individuals responding to an overdose. The boxes were established in city-owned buildings including a local recreation center, the police department, aquatics center, library, landfill, and city hall. The Lompoc Fire Department led trainings with city staff at these locations on how to administer naloxone in the event of an overdose. The trainings helped to build confidence among local staff on how to respond to an overdose and emphasized coordinating with first responders as soon as possible.

## San Diego County: A Comprehensive Approach to Opioid Settlement Planning

San Diego is the second largest county in California, with a population of approximately

3.2 million people. County of San Diego (County) used opioid settlement funds to address priorities identified through convenings of opioid experts and community stakeholders, as well as the community at large through surveys and local forums. The County also used the funds to build upon programs established under the Overdose to Data 2 Action (OD2A) grant, which was awarded from the Centers for Disease Control and Prevention and helps jurisdictions implement prevention activities and collect timely data on nonfatal and fatal overdoses.

In FY 2022-23, the County directed a large portion of its settlement funding to developing the <u>Overdose Surveillance and Response Program (OSAR</u>). OSAR detects real-time overdose clusters by cross-referencing data from Emergency Departments, Emergency Medical Services, the Medical Examiner, the California Poison Control System, and other sources. The County's Health and Human Services Agency, which consists of Public Health Services, Behavioral Health Services, and Medical Care Services, all collaborate via OSAR to share data and determine the appropriate response. OSAR staff investigate overdose clusters and deploy a rapid response to the field by collaborating with local harm reduction partners. OSAR helps the County identify short- and long-term overdose trends that can be further addressed through community engagement and support services.

Through the local forums conducted, the County has also identified several projects to prioritize with future years of settlement funding. Some of these projects include:

- Medication-Assisted Therapy (MAT) Pilot Program: The County will implement a MAT pilot program through its Emergency Medical Services (EMS) program, which allows paramedics to assess and treat opioid withdrawal in the field using buprenorphine. Paramedics work to connect these patients to Substance Use Navigators at CA Bridge-affiliated emergency departments. Patients who decline EMS transport are referred to community-based MAT programs for follow-up care.
- » Harm Reduction Services: The County will establish a mobile unit to provide harm reduction services at several locations throughout the county. The mobile unit will provide direct services including integrated medical screening for Human Immunodeficiency Virus (HIV), Hepatis C (HCV), and Sexually Transmitted Infections (STI), education about transmission of blood-borne infectious diseases, harm reduction, syringe disposal, and overdose prevention.
- Treatment and Recovery Support for Incarcerated Individuals: The County Sheriff's Department will establish a program for evidence-based treatment for individuals transitioning out of County jails. Opioid settlement funds will be used to help increase access to evidence-based treatment, including medications for opioid use disorder, as well as recovery support.

- San Diego Relay Program: The County will leverage opioid settlements funds to launch the San Diego Relay program, an emergency department-based overdose response system that will operate 24 hours a day/7 days a week. The program is based on a <u>successful model in New York</u>, which dispatches a peer to hospitals to meet patients after an overdose. Peers stay in contact with patients for up to 90 days and connect them to appropriate support services, including overdose prevention, harm reduction, substance use disorder treatment, eligibility programs and social services.
- Project Alert: Through a contract with the San Diego County Superintendent of Schools for the San Diego County Office of Education, the County will implement Project Alert, an evidence-based substance use intervention. The program is intended to be delivered over the course of two academic years, and includes teacher-facilitated class discussions, student led-role plays, and small group activities. The program was originally developed for 7<sup>th</sup> and 8<sup>th</sup> grade students, but the County is using settlement funds to expand the program delivery to include 6<sup>th</sup> grade students.
- Drug Checking Services: San Diego County will work with a contractor to launch a Drug Checking Services (DCS) program. DCS, also known as pill testing or adulterant screening, helps inform people who use drugs about the composition of their substances to increase awareness, avoid unintended effects, and reduce harm. DCS can also provide information on community-level trends, offering opportunities to inform public health interventions and response efforts. The program will utilize Fourier-transform Infrared (FTIR) and fentanyl test strips. Services will be mobile and paired with other harm reduction services. This effort aligns with San Diego County's Comprehensive Harm Reduction Strategy.

### **Tuolumne County: Establishing Treatment and Housing Infrastructure**

Tuolumne County is a small, rural county situated in the Sierra Nevada foothills of California, with a population of approximately 56,000. After extensive data collection and a public survey of residents, the county identified homelessness and opioid use as two of its most pressing concerns. Recognizing these persistent challenges, Tuolumne County determined that opioid settlement funds could be used to augment housing and treatment services in the community.

Tuolumne County utilized \$500,000 from its opioid settlement allocation towards the \$2 million cost to acquire two buildings, creating a 50-bed housing and service navigation center to tackle the challenges of substance use and homelessness in the community. Using a housing first-model, the county refurbished these buildings to serve as an interim housing facility for eligible residents engaging in social services. It prioritizes older adults, adults with disabilities, families, transitional aged youth, and individuals in treatment and recovery. The center will offer navigation services and intensive case management for entry into permanent housing, provided by Social Workers, Behavioral Health Workers, Peer Specialists and Public Health staff.

The center is also staffed with 24/7 onsite Resident Assistants to provide additional support and case management services. The site accepted its first residents on October 7, 2024. As the county worked towards the official opening of the navigation center, staff established a virtual data dashboard and bulletin board to provide local resources and share information about available support services.

Tuolumne County has involved community residents throughout the planning and implementation of the navigation center, encountering both successes and challenges along the way. The county has faced pushback from homeowners in the surrounding community who expressed concerns about the navigation center. The county worked to overcome this opposition by sharing information about the services offered by the center, and the stories of individuals who will be staying there. The county's "Adopt a Room" program also inspired community members, including over 50 individuals and various service groups such as churches and rotary programs, to contribute care packages for individuals who will be joining the interim housing center when it opens.

## Conclusion

The California Opioid Settlements Annual Expenditures Report provides an overview of California's opioid settlement expenditures in FY 2022-23. The report is intended to meet the obligations of California's state-specific agreements and demonstrate the State's commitment to transparency regarding the use of funds.

As California continues to evolve in its approach to the changing opioid crisis, insights from the first year of opioid settlement funding can be used to guide statewide and local efforts. While the FY 2022-23 expenditures were modest, many cities and counties are engaged in strategic planning processes to assess current strengths and needs in their communities. By sharing information to refine strategies, adopting best practices, and leveraging the experiences of other local entities, California and its cities and counties can enhance their opioid remediation efforts, ensuring every dollar spent contributes meaningfully to the mission of these funds.
