Assisted Outpatient Treatment

AB 1421

- The Assisted Outpatient Treatment (AOT) Demonstration Project Act of 2002, known as Laura's Law, provides for court-ordered community treatment for individuals with a history of hospitalization and contact with law enforcement.
- Counties utilize courts, probation, and mental health systems to address the needs of individuals unable to participate in community mental health treatment programs without supervision.



Assisted Outpatient Treatment

AB 1976


- All California counties are required to offer AOT or opt out through the passage of a resolution adopted by their County Board of Supervisors.
- The bill prohibits a county from reducing existing voluntary mental health programs as a result of the implementation of AOT services.
- AB 1976 repeals the sunset date of Laura's Law, thereby extending the program indefinitely.



AOT Participation

AOT Participation

- 20 counties established AOT programs prior to AB 1976: Alameda, Contra Costa, El Dorado, Kern, Los Angeles, Marin, Mendocino, Nevada, Orange, Placer, San Diego, San Francisco, San Luis Obispo, San Mateo, Santa Barbara, Shasta, Solano, Stanislaus, Ventura, and Yolo.
- 11 new counties have opted in: Fresno, Humboldt, Kings, Mariposa, Napa, Riverside, Sacramento, Santa Clara, Siskiyou, Tehama and Tulare.





2021 AOT Legislative Report

Overview

The 2021 Annual AOT Report to the legislature provides an overview of the strategies employed by all AOT programs across California and reflects aggregated data for individuals served by court-order or court-settlement during the July 1, 2018 - June 30, 2019 State Fiscal Year.

Pending Investigation 9%_ Court-Involved Ineligible 33% Enrollment 9% Met Criteria, Unable to be Voluntary_ Enrollment Met Criteria, 28% Unable to be Court-Involved Enrollment located 21%



2021 AOT Legislative Report

Key Findings (cont.)

 218 participants were served by court-order or court-settlement within 12 counties: Alameda, Contra Costa, Los Angeles, Mendocino, Nevada, Orange, Placer, San Diego, San Francisco, San Mateo, Santa Barbara, and Ventura.



2021 AOT Legislative Report

Key Findings (cont.)

- Homelessness decreased by 35 percent;
- Hospitalization decreased by 39 percent;
- Contact with law enforcement decreased by 45 percent;
- Victimization was decreased by 71 percent;
- Violent behavior decreased by 47 percent;

2021 Annual Legislative Report

Key Findings (cont.)

- 29 percent of individuals were able to secure employment or participated in employment and/or educational services;
- Clients presenting with a co-occurring mental health and substance use disorder decreased substance use by 8 percent;
- Most counties reported improvements in clients' social functioning and independent living skills; and,
- Client and family satisfaction surveys indicated satisfaction with AOT services.
