Rates that could be used to deduce a masked value are reported as \*.
- 5. While DHCS expects that 3-5% of Medi-Cal membership will be eligible for ECM, this will vary based off of local demographics and not all eligible members may want to participate in the program, so penetration rates are expected to be significantly lower than 3-5%. There are no explicit targets for ECM penetration rates at this time, only baseline trends which will evolve as more data is collected.
