Activity Name	Activity Description
COAST Team	The COAST team is a multi-disciplinary team that responds to individuals experiencing mental health crisis including substance use issues during initial crises (page E-3 of the Allowable Expenses PDF). They provide case management of our residents that have chronic mental health issues connecting them with community-based resources including substance treatment and recovery. One of their main goals is to provide community education and outreach for the prevention of substance abuse and mental health related issues (page E-5 of the Allowable Expenses PDF). The team consists of Licensed Clinical Social Worker, FF/PM with a Support Canine and Police Officer. The support Canine is assigned to the COAST team and is trained to the level of service animal established by the ADA and has passed the AKC temperament test. The canine's primary role is to respond to behavioral health calls for service to assist with providing comfort, increasing opportunities for communication, decreasing anxiety and lifting spirits to lessen depression. The team provides support and transportation to stabilization units and treatment or recovery services (page E-6 of the Allowable Expenses PDF) as well as providing referrals to harm reduction services, treatment, recover support, health care, to persons that use opioids or persons with OUD and have co-

Activity Name	Activity Description
Ontario's Opioid Safe Community/Leave Behind Narcan	An ASO which includes Ontario Fire Department's Leave Behind Narcan Program. The City of Ontario has experienced an increase in overdoses since early 2020. The implementation of leave behind Narcan allows members of the Ontario Fire Department to better serve the citizens by providing Narcan to patients who have previously overdosed as well as spread opioid awareness. The addition of the 4mg Narcan dose to the county protocol has been extremely successful. We are committed to being part of the solution by leaving Narcan behind to prevent future overdose.
