² Individuals enrolled in LTC aid codes 13, 23, 53, and 63. Does not include individuals who may have used LTC services, but were not enrolled in an LTC aid code.

³ As they are entitled to full-scope Medi-Cal benefits, most individuals age 0-25 without satisfactory immigration status are dispersed throughout other aid categories.
