Proportion of California Population Certified Eligible for Medi-Cal By County and Age Group – September 2015


Proportion of Each County's Population Enrolled In Medi-Cal Varies Considerably

Medi-Cal, California's Medicaid program, plays a significant role in providing health care coverage to the state's population. Based on recent figures, roughly one-third of the state's population is enrolled in Medi-Cal. While much discussion has centered on one-third of the state's population enrolled in Medi-Cal, little examination has focused on the significant variability seen among California's unique counties.

In some California counties, Medi-Cal plays an even greater role in providing health care coverage to the population. In particular counties, such as Tulare and Merced, Medi-Cal provides coverage to roughly 50% of the population. In other counties such as Placer, Marin, San Mateo and El Dorado counties roughly 20% residents are enrolled in Medi-Cal. Within Los Angeles County, where over one-quarter of the state population resides, close to 40% of the county's population is enrolled in Medi-Cal (**Figure 1**).

There are 17 counties within California where at least 4 out of 10 individuals residing in the county receive health care coverage through Medi-Cal's system of care. Medi-Cal provides health care coverage for at least one-third of the population or greater in twenty-eight out of California's fifty-eight counties (**Figure 1**).

Figure 1 - Percent of County's Population Enrolled in Medi-Cal; September 2015



Medi-Cal Services as the Primary Insurer of the State's Youngest Citizens


Medi-Cal is the primary health care system for more than one half of the state's population between the ages of 0 and 18, but provides coverage to only 21% of California residents 65 or older (Figure 2).

Medi-Cal provided coverage to nearly 60% of California children between the ages of 0 and 5. Within seven of California's counties, Medi-Cal provided coverage to 80% or more of the children ages 0 to 5 residing within the county. Over 57% of children ages 0 to 5 residing in Los Angeles County are afforded health care coverage through Medi-Cal (**Figure 3**).
