Background/Description:

In accordance with Welfare and Institutions Code Section 5771.1, members of the Behavioral Health Services Oversight and Accountability Commission (BHSOAC) serve as ex-officio members of the California Behavioral Health Planning Council by virtue of their position. The Behavioral Health Services Oversight and Accountability Commission has rebranded themselves and also go by the Commission on Behavioral Health.

The current Vice Chair of the Commission on Behavioral Health, Al Rowlett, will participate in Council meetings as their official representative.

Presenter Bio:



Al Rowlett was named Turning Point Community Programs' Chief Executive Officer in 2014. Commissioner Rowlett has been with the agency since 1981 and today provides leadership and guidance to over 40 programs in several Northern and Central California counties. He holds a Bachelor of Arts degree from Ottawa University, a Master's in

Business Administration in Health Services Management from Golden Gate University and in Social Work from California State University, Sacramento. He is also a Licensed Clinical Social Worker.

Rowlett was appointed as a trustee to the Elk Grove Unified School District in 2009 serving through 2012. He is currently a Volunteer Clinical Professor at the University of California, Davis Department of Psychiatry co-directing the Community Psychiatry seminar for residents and formerly served as an adjunct professor for the CSUS Mental Health Services Act cohort. In 2020, Assembly Speaker Anthony Rendon re-appointed Al to the California Institute for Regenerative Medicine Board.

Background/Description:

In March 2024, Californians passed Proposition 1, now referred to as Behavioral Health Transformation, to transform behavioral health by addressing gaps in care for the most vulnerable Californians.

The two legislative bills that created the language in Proposition 1 are:

- Behavioral Health Services Act (BHSA) [SB 326](#)
- Behavioral Health Infrastructure Bond Act [AB 531](#)

The California Department of Public Health (CDPH) will receive funding to implement population-based behavioral health-prevention strategies.

- A minimum of 4% of BHSA funds will be directed for population-based mental health and substance use disorder prevention programs.
- A significant portion of these prevention funds (51%) will be reserved for programs addressing prevention for populations who are 25 years or younger.

Representatives from CDPH will provide an update on the implementation of the Population Based Prevention for the Behavioral Health Services Act.

10. Representing the Planning Council

10.1 Selection of Planning Council Members to Attend Training/Conferences

The Planning Council maintains a list of various organizations' annual trainings, conferences, and events. The Council will periodically solicit volunteers to travel to these events on behalf of the Planning Council. Once all interested members have submitted their names, the Officer Team will evaluate and select a representative(s) based on how closely they match the scope and purpose of the event. The following criteria will be used in making this determination:

- Experience and seniority (for policy development)
- Council member's attendance at previous trainings, conferences, and events
- New member (for training purposes)
- Regular attendance and active participation
- Subject matter expertise
- Specific criteria required by the requesting organization

Council members should explore whether their employer will fund or reimburse for traveling and attending these events.

Council members are expected to share the information/knowledge gained from these events with the Council. Members should be prepared to address the following questions after attending these events:

1. What three things did you learn?
2. How does what you learned relate to the work of the Council and/or your committee?
3. Is there any action the Council should take as a result of the information you learned? (If yes, please explain)

10.2 Roles and Accuracy of Planning Council Positions

Individual members may be called upon to represent the Planning Council before the Legislature, state departments, or other groups. In addition, individual members may wish to represent the Planning Council at particular forums.

In any forum, members must indicate whether they are representing the Planning Council or are speaking as individuals. Individuals may represent the Planning Council only when

authorized by the Chairperson or Executive Officer, and are responsible for representing the Planning Council's positions accurately.

10.3 Personal Projects

Planning Council members are to use their status as Planning Council members only when doing official business of the Planning Council. Members are not authorized to use their positions as Planning Council members to obtain information for personal projects.

10.4 Media Policy

The Planning Council will refer all media inquiries to the Executive Officer. The Executive Officer will use the steps outlined below when contacted by the media:

- Provide the reporter with the information sought if they possess that information or refer to other staff as appropriate based on expertise
- Arrange for an interview with the appropriate Planning Council member who is the best source of information provided that the member knows they are speaking on behalf of the Planning Council and must accurately represent the position of the Planning Council
- Work with the Department's Public Information Office if the request for information is politically sensitive

10.5 Transparency Policy

To facilitate open communication and understanding on all projects conducted by the California Behavioral Health Planning Council (CBHPC) among its members who may or may not be involved in paid employment related to CBHPC business, Planning Council members will notify the Executive Officer, who will place a transparency statement notification on the Executive Committee agenda to be included in the Executive Committee minutes when the following occurs:

- A member is doing paid work for the California Department of Health Care Services (DHCS) or other state agencies whose work may be reviewed by the CBHPC
- A member is doing paid work for the federal government that may be related to federal Substance Abuse and Mental Health Services Administration (SAMHSA) Act Block Grant activities
- A member is doing paid work for a contractor of the DHCS
- A member is doing paid work for a county when that work is likely to be reviewed by the CBHPC

Agenda Item: Opportunities for Strengthening Public Systems for the Justice-Involved Population

Background/Description:

The Council on Criminal Justice and Behavioral Health (CCJBH) is a 12-member council chaired by the secretary of CDCR and comprised of representatives from the Department of State Hospitals (DSH), the Department of Health Care Services (DHCS), and appointed experts from criminal justice and behavioral health fields. The council investigates, identifies, and promotes cost-effective strategies that prevent adults and juveniles with behavioral health needs from becoming incarcerated; identifying incentives for state and local justice and health programs to adopt such approaches; reporting activities to the legislature; and providing recommendations for improving the cost-effectiveness of existing behavioral health and criminal justice programs.

The California Behavioral Health Planning Council (CBHPC) is mandated in Welfare & Institutions Code 5771 to review and report on the public behavioral health system, to advocate for adults and older adults with serious mental illnesses and children and youth with serious emotional disturbances and their families, and to make recommendations regarding mental health policy development and priorities.

The Behavioral Health Services Act targets funding to provide services to the most vulnerable populations including those at risk of incarceration, re-entering the community from a justice-involved setting, at risk of conservatorship, in foster care, and/or at risk of institutionalization. It is imperative that Council Members understand the needs of our justice involved behavioral health population in order to make quality recommendations on the implementation of the Behavioral Health Transformation and advocate for the behavioral health needs of persons with lived experience of justice-involvement.

The Executive Officer of the Council on Criminal Justice and Behavioral Health (CCJBH) will provide an overview of the opportunities in the current public behavioral health system to strengthen the continuum of care for justice-involved individuals.

Presenter Bio:



Brenda Grealish is currently the Executive Officer of the Council on Criminal Justice and Behavioral Health (CCJBH), which is part of the California Department of Corrections and Rehabilitation. Prior to joining CCJBH, she worked at the California Department of Health Care Services (DHCS), where she served in several positions, including Chief of the former Mental Health Services Division, Assistant Deputy and Acting Deputy Director for Mental Health and Substance Use Disorder Services, and Chief of the Medical Behavioral Health Division. Prior to working at DHCS, she held several positions at the California Department of Corrections and Rehabilitation, Office of Research, including Deputy Director, Research Manager III and Research Manager II. In her early career, she held several positions at the former California Department of Mental Health, including Research Program Specialist I and Research Analyst I/II. She earned a Master of Arts degree in Psychology from California State University, Sacramento.
