

IMPORTANT NEWS ABOUT YOUR CHILD'S CCS COVERAGE

We have important information about your child's enrollment in the California Children's Services (CCS) Program. This notice explains what you need to do to keep your child's California Children's Services (CCS) Program coverage. If your child is also enrolled in Medi-Cal, you may receive another notice about their Medi-Cal renewal.

For the past three years your child has been enrolled in the CCS Program, even if they were no longer eligible. As of April 1, 2023, the CCS Program offices have restarted checking CCS eligibility yearly. The renewal process may include reviewing your finances, confirming your residence, and verifying your child continues to be medically eligible for the program.

Your child may stay on the CCS Program until their annual eligibility renewal date. If your child is found to be no longer eligible, you will receive a written notice before your child's CCS coverage ends.

Take action by following these steps:

1. Update your or your child's contact information with your local CCS county office, even if you already provided it to your Medi-Cal eligibility office. If your mailing address, phone number, or email changed in the past three years, inform your local CCS county office as soon as possible. Failing to update your contact information may result in missing important information about your child's CCS Program coverage and their coverage could end.

2. **Answer all requests for information.** Please give your child's local CCS county office all the information it asks for. Be sure to check your mail for renewal paperwork and return all paperwork by the deadline.

If you have any questions about your child's CCS Program eligibility, please contact your local CCS county office or your child's CCS case manager. A list of CCS county office addresses and phone numbers are included in this letter.
