Summary of	Country Inn of Downey has submitted a plan to address the institutional practices. Country Inn of Downey will
Remediation	ensure that all individuals living in the setting will be assessed individually and documented in the individual
Strategy	service plan. All modifications/restrictions will be based on an individual assessed need, documented in the
	person-centered plan. Any restrictions will be reviewed at least annually or as needed.
	Video surveillance is used only in public areas of the setting. Video recorded footage, without audio, is kept for
	30 days. Individuals a responsible parties can request to see pertinent footage before it is erased. Signage is
	posted at the entrance that informs individuals, staff and guests that recordings are in process.
	Although staff in scrubs contribute to the institutional appearance, it does not impact community integration.
	Country Inn of Downey states shared bedrooms also have privacy dividers in the event individuals needs or
	desires additional privacy while in their room,
	Country Inn of Downey states that individuals can dress or groom however they desire, in any area of the
	setting, as long as private areas of the body are covered, and the choices of the individuals do not disrespect
	any other individuals in the setting. Individuals can also wear robes or pajamas in common areas.
	Country Inn of Downov stated individuals can disc privately even in their hadroom without incurring a fee
	Country Inn of Downey stated individuals can dine privately, even in their bedroom without incurring a fee.
	Seats are not assigned anywhere in the setting and individuals are able to sit where they desire.



Country Inn of Downey stated that medications are administered in a private area of the home unless the individual decides they want to take their medications during a mealtime. Country Inn of Downey stated they have a commercial kitchen is restricted however there is a designated area in the dining room with a communal refrigerator and microwave that is accessible to individuals at all times. Some individuals also have minifridges and microwaves in their bedrooms.

Any restriction to having a fridge or microwave in the bedroom is based on an assessed need that is reviewed by the person-centered team and documented in the person-centered plan. Individuals can request food items from the kitchen, order groceries to be delivered, access the grocery store, and order food from neighboring restaurants. The administrator will review this information with individuals currently living at the setting, staff, and responsible parties before 7/15/22 and then upon admission, at least annually, or as needed thereafter.

Country Inn of Downey states individuals can visit with their guests in common areas of the home. Individuals who share a bedroom should request permission from their roommate to have guests in their shared bedroom. Visitors are asked to sign in and out, but this is a suggestion and not mandatory.
