Summary of Evidence

Individuals have limited access to the community and the site has blanket restrictions in place. Specifically, individuals are not allowed to leave the site without assistance. The provider does not include individual or group community outings in their plan of services. The property is fully secured with security cameras, video monitoring, locked doors, and alarmed doors. Additional restrictions include visitors are not allowed in the dining room during meals and must wait in common areas, no community outings, no valuables, individuals are not able to participate in cooking or laundry, private dining is not supported, food and visitor restrictions.

Summary of Remediation Strategy

Individuals living in the setting require assistance from staff when outside of the home; this is documented in their person-centered service plans and based on assessed needs. An activity calendar is posted in a common area of the home with activities in the community and onsite. Activities are based on individual preferences and needs, although most individuals prefer activities onsite. Individual participation is up to them. Community visitors are also welcome and include more than family, such as a pianist, Tai Chi instructor, and others. Individuals are not required to inform staff about when they plan to return to the setting and the entrance doors and outside gate do not lock and remain open at all times. The front door does have a chime to alert the setting when the door is being used. All individuals are aware of this when they move in and consent to the chime. Bedroom doors have exterior doors, and some have alarms, based on an individual's assessed needs and documented in the personcentered service plan. Video cameras are used and are triggered with motion; footage is maintained for approximately two weeks. Individuals are aware of this and consent upon move in. Individuals are given medications in private areas. All individuals require assistance with personal care which is documented in their person-centered service plan and based on an assessed need. Visitors are allowed at all times although the setting asks for prior notice for overnight visitors to arrange for accommodations. Individuals can participate in any activities they
