SUBJECT: JANUARY 2025 MANDATORY ENROLLMENT FOR FOSTER CHILDREN AND YOUTH IN SINGLE PLAN COUNTIES

The purpose of this letter is to provide counties with information related to current and former foster children and youth in Single Plan Counties who will be mandatorily enrolled in a Medi-Cal managed care health plan (MCP) effective January 1, 2025, and the resources available to support their transition.

Background

Assembly Bill (AB) 118 (Committee on Budget, Chapter 42, Statutes of 2023 - SEC.157) amended Welfare and Institutions Code (W&I) section 14184.200 mandating that foster children and youth and former foster children and youth Medi-Cal members living in Single Plan Counties (i.e., Alameda, Contra Costa, and Imperial) transition from Fee-For-Service (FFS) Medi-Cal to an MCP on January 1, 2025.

Policy

Currently, foster children and youth, as well as children and youth formerly in foster care, are voluntary members in Single Plan Counties. Voluntary members may choose either FFS Medi-Cal or enroll in an MCP. Effective January 1, 2025, DHCS will require foster children and youth in Single Plan Counties (Alameda, Contra Costa, and Imperial) to join an MCP. This change will impact approximately 8,180 Medi-Cal members, identified with a foster or former foster youth aid code, residing in a Single Plan County. Current and former foster children and youth will be transitioned from FFS Medi-Cal to an MCP. Current and former foster children and youth who are currently enrolled in an MCP will no longer have the choice to change to FFS Medi-Cal. This transition will not impact Medi-Cal coverage or benefits. MCPs are required to comply with statutory requirements and DHCS guidance to ensure "continuity of care" and "access to care" when transferring foster children and youth into managed care. DHCS has developed All Plan Letter (APL) 24-014 with requirements for MCPs.

What This Means for County Eligibility Workers

Medi-Cal members often turn to their county eligibility workers first with any questions about their Medi-Cal coverage, benefits, and providers. County eligibility workers can answer member questions and support their transition in the following ways:

- Help members understand if the 2025 Mandatory Enrollment for Foster Children and Youth in Single Plan Counties impacts them based on the criteria in this letter,
- Answer member questions about the 2025 Mandatory Enrollment for Foster Children and Youth in Single Plan Counties with the resources below,
- Direct members to DHCS 2025 Mandatory Enrollment for Foster Children and Youth in Single Plan Counties webpage below, and
- Direct members to the Medi-Cal Health Care Options (HCO) Field Operations Program staff in your county office or direct them to the Medi-Cal [Health Care Options \(HCO\) website](#) for information about health plan choices and provider choices.

Resources for County Eligibility Workers

Member Notices

Notices will be sent to current and former foster children and youth (identified by aid code) in Single Plan Counties who will be enrolled in an MCP on January 1, 2025. Member notices will also be mailed to authorized representatives documented within the Medi-Cal Eligibility Data Systems (MEDS).

Notices Being Sent to Members Who are Currently Enrolled in FFS Medi-Cal:

- November and December 2024 – Members will be mailed a letter from Medi-Cal HCO with information about their automatic enrollment in an MCP and additional plan options available.
- December 2024 – Members will be mailed a Confirmation Letter from Medi-Cal HCO with the MCP they will be enrolled in with an enrollment effective date of January 1, 2025.
- January 2025 – Members will receive a welcome packet from their new MCP.

Notices Being Sent to Members Who are Currently Enrolled in an MCP:

- November 2024 and December 2024 – Members will be mailed a letter from Medi-Cal HCO stating that they will no longer have the choice to change to FFS Medi-Cal starting January 1, 2025. Members will be informed that they will stay in the MCP they are already enrolled in and be provided with information on other Medi-Cal health plan options available.

Kaiser Permanente
