SCHEDULE FOR THE MEDI-CAL TUBERCULOSIS (TB) PROGRAM TRAINING FOR MEDI-CAL TB PROVIDERS

The Medi-Cal TB program was effective October 1, 1994. This Medi-Cal program provides outpatient TB-related services to TB-infected individuals who meet the Medi-Cal requirements for TB program eligibility.

Under this program, Medi-Cal clinics and Medi-Cal providers who service TB-infected persons are encouraged to assist such persons in applying for Medi-Cal. These providers may help applicants complete all initial Medi-Cal forms used in the application process and may gather applicant verification. The main focus of this training is the discussion of completing these forms and gathering applicant verification.

We have designated three dates and locations for the TB program training sessions for Medi-Cal TB providers. Training will be conducted by Department of Health Services staff.

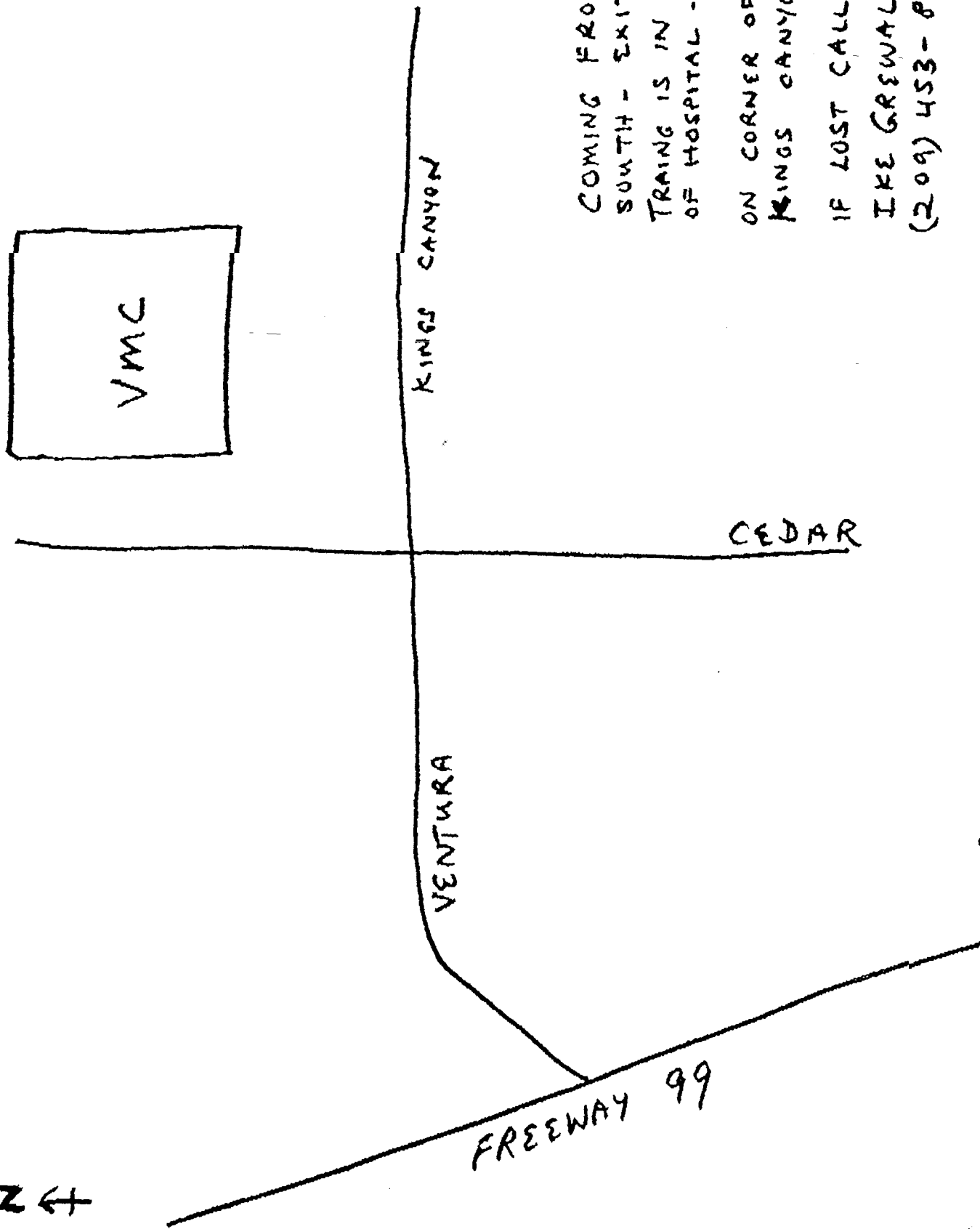

From Highway 80: Take the University Avenue exit and follow University (heading east) to Shattuck (about 2 miles), take a left one block to Berkeley Way, where you take a right.

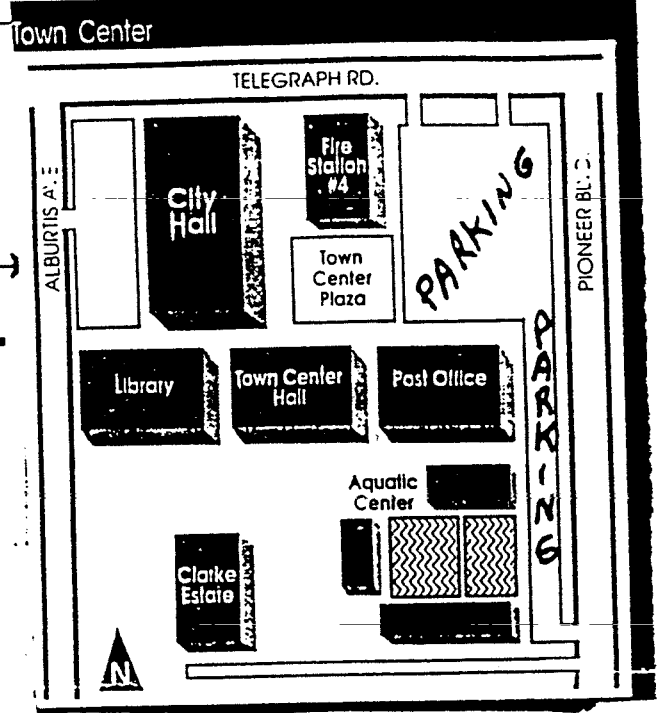
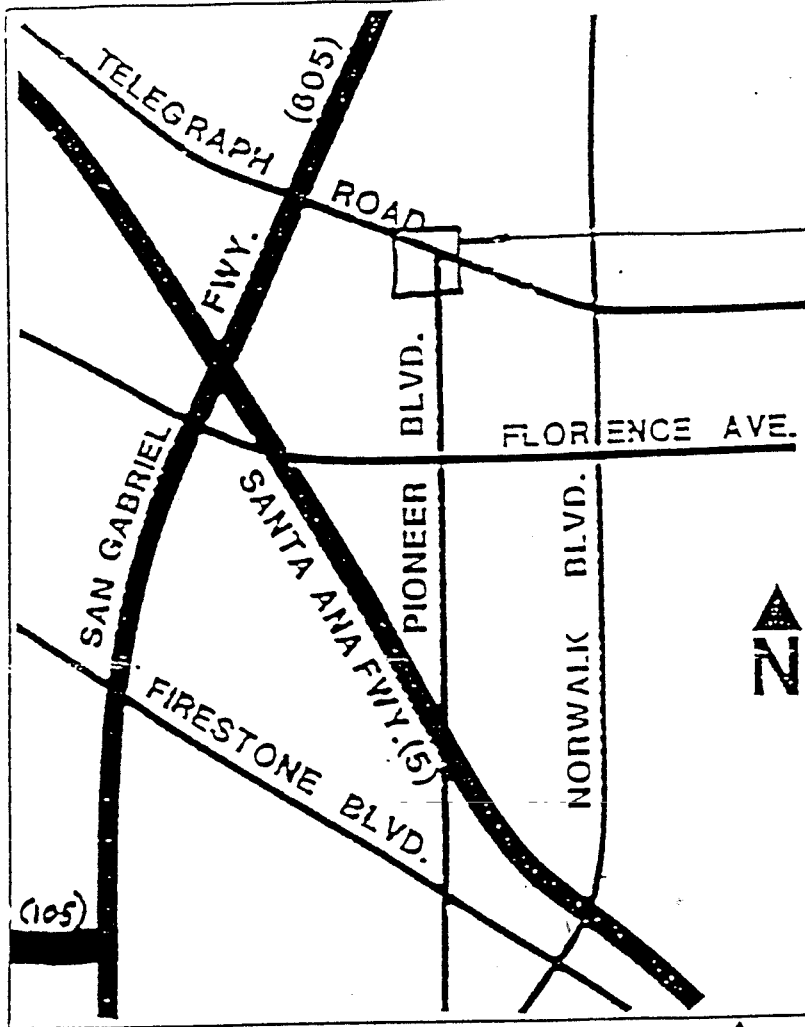
Parking is a major problem in this area. If it is at all possible, please take BART. The downtown Berkeley station ("Berkeley") is just two blocks away. When you exit the BART station you will be on Shattuck Avenue. Go north on Shattuck to Berkeley Way and take a right.

If you must drive, there is paid parking available on Berkeley Way between Shattuck and Milvia. The lot takes quarters and you can park for up to four hours (if you can find a space). Street parking in this area is limited to two hours. If you plan to drive and would like to find an all-day spot, you can find parking in residential areas located about a 15 minute walk from the Health Department building. Follow University Avenue to Martin Luther King Way (about 3 blocks west of Shattuck), take a left and follow MLK about 4 blocks, where the on-street parking is not limited to 2 hours. Be sure to check the signs on the street to make sure it's not a street cleaning day.
