SUBJECT: Updated Submission Instructions for Community Reinvestment Plans

PURPOSE:

This PHM Information Notice (IN) provides updated instructions for the submission of Community Reinvestment Plans due by September 1, 2026, and annually thereafter. MCPs must submit their Community Reinvestment Plan through the Department of Health Care Services' (DHCS) ReInvest360 Submission Portal. Email submissions will not be accepted. Please follow the instructions outlined in this PHM IN.

BACKGROUND:

As outlined in [All Plan Letter \(APL\) 25-004](#), MCPs are required to submit an initial Community Reinvestment Plan on September 1, 2026, and every three years thereafter as well as a subsequent Community Reinvestment Plan on September 1, 2027, and every three years thereafter, and 2028 and every three years thereafter. Community Reinvestment Plans are used by DHCS to ensure compliance and alignment with APL requirements.

ACTION ITEM: Community Reinvestment Plan Submission

A Technical Update to APL 25-004 was published on April 13, 2026, outlining technical changes to the Community Reinvestment Plan submission requirements. APL 25-004 indicated that MCPs were required to submit a Community Reinvestment Plan to DHCS using the templates provided within the APL Appendix or in another format specified by DHCS and pursuant to specific timelines and process to be communicated by DHCS subsequent to this APL release. Pursuant to this IN, MCPs will be required to use the **ReInvest360 Submission Portal** to submit Community Reinvestment Plans electronically. ReInvest360 is DHCS's required electronic system for the submission of Community Reinvestment Plans.

- **Appendix B, Exhibits 1 and 2:** [APL 25-004 Appendix B, Exhibit 1: Public Health Director Attestation](#) and [Appendix B, Exhibit 2: Behavioral Health Director Attestation](#) must be signed, completed, and then submitted through the ReInvest360 Submission Portal.
- **Appendix B, Exhibits 4 and 5:** The templates previously included in Exhibits 4 and 5 of APL 25-004 are no longer to be used for Community Reinvestment Plan submissions. These templates, including all questions and required information, have been fully integrated and embedded directly into the ReInvest360 Submission Portal. MCPs should not upload or reference the prior Exhibit 4 or Exhibit 5 templates and must instead complete all corresponding questions within ReInvest360. Please see the ReInvest360 Submission Template for the updated list of required information.

DHCS will email the link to ReInvest360 including a Community Reinvestment Submission Guide with instructions for the submission of Community Reinvestment Plans to MCP primary and secondary contacts.

DUE DATE

MCPs submit an initial Community Reinvestment Plan based on funding requirements provided by DHCS by September 1, 2026, for the initial submission for the investment period, and every three years thereafter by the first Working Day of September.

MCPs submit a subsequent Community Reinvestment Plan within the three-year investment period based on funding requirements provided by DHCS by the first Working Day of September 2027, and every three years thereafter, and by the first Working Day of September 2028, and every three years thereafter, for the subsequent submissions within the investment period.
