

SUBJECT: MEDI-CAL MANAGED CARE PLAN NON-MEDICAL TRANSPORTATION

POLICY

PURPOSE:

This Information Notice is providing guidance for Substance Use Disorders Drug Medi-Cal (DMC) State Plan and Drug Medi-Cal Organized Delivery System (DMC-ODS) counties in response to an updated Medi-Cal Managed Care policy for Non-Medical Transportation (NMT) pursuant to All Plan Letter (APL) 17-010 NON-EMERGENCY MEDICAL AND NON-MEDICAL TRANSPORTATION SERVICES.

BACKGROUND:

APL 17-010 ensures that Medi-Cal Managed Care beneficiaries have access to Non-Emergency Medical and NMT for all covered services, both offered by the Managed Care Plan (MCP) and those not offered by the MCP. The addition of NMT as a covered benefit in the MCP is effective October 1, 2017.

According to the Medi-Cal Managed Care policy:

"Effective October 1, 2017, in part to comply with CMS-2333-F and to have a uniform delivery system, MCPs must also provide NMT for Medi-Cal services that are not covered under the MCP contract. Services that are not covered under the MCP contract include, but are not limited to, specialty mental health, substance use disorder, dental, and any other services delivered through the Medi-Cal fee-for-service delivery system".

DISCUSSION:

In order to ensure access to transportation for DMC and DMC-ODS beneficiaries who are enrolled with a MCP, the DMC County or DMC-ODS county plan and its contracted providers can refer beneficiaries to their MCP when the need for NMT is identified. The MCP is reimbursed for this service as part of their capitated rate and each beneficiary that is enrolled with an MCP is entitled to the service. This guidance is specific to beneficiaries who are enrolled in managed care only.
