Your title XXI Children's Health Insurance Program (CHIP) state plan amendment (SPA), CA-14-0004, submitted on June 17, 2014, has been approved. This SPA incorporates the Modified Adjusted Gross Income based eligibility application processing, eligibility screening, and enrollment provisions in section 2107(e)(1)(S) of the Social Security Act. The retroactive effective date of this SPA is October 1, 2013.

Upon submission of this SPA, California was using separate applications for two of its separate CHIP populations: (1) the Medi-Cal Access Program (MCAP) for children from conception to birth up to 317 percent of the federal poverty level (FPL) statewide; and (2) the County Children's Health Initiative Program (CCHIP) in three counties (San Francisco, San Mateo and Santa Clara) for children from age 0 up to age 19 above 261 percent of the FPL up to and including 317 percent of the FPL.

The Centers for Medicare and Medicaid Services (CMS) requested additional information on July 15, 2014 about how the state's separate applications for the MCAP and CCHIP populations complied with the requirement at 2107(e)(1)(S) of the Act and 42 CFR 457.330 to use a single, streamlined application for all insurance affordability programs. The state worked with CMS to operate under a variety of mitigation strategies to address these requirements, including modifying existing MCAP and CCHIP applications to ensure consistency with the state's single streamlined application.

The state provided clarifying information about this SPA on several occasions during 2014 and 2015, and most recently on July 14, 2016. The final communication provided confirmation that the state replaced the separate applications for the CCHIP populations in January 2015 and the MCAP population in October 2015 with the interim application included in Medicaid SPA 13-0022-MM2 approved on December 10, 2013.

With the information provided on July 14, 2016, the state has in place processes and procedures for enrollment simplification and coordination with health insurance exchanges and Medicaid, including the use of a single streamlined application for all insurance affordability programs.

Enclosed is a copy of the CS24 state plan pages to be incorporated within California's approved state plan. CA-14-0004 supercedes section 4.3, Single Streamlined Application Screen and Enroll Process and section 4.4, Renewals, Screening by Other Insurance Affordability Programs of the existing state plan. This approval does not apply to any revisions to the alternative single streamlined application made after CMS approved Medicaid SPA 13-0022-MM2.


