**PROPOSED STATE PLAN AMENDMENT TO CONTINUE AUGMENTATION
PAYMENTS FOR EMERGENCY AIR MEDICAL TRANSPORTATION SERVICES**

This notice provides information of public interest regarding a proposed State Plan Amendment (SPA) by the Department of Health Care Services (DHCS). The proposed SPA is seeking federal authority to continue augmentation payments for Emergency Air Medical Transportation Services.

DHCS plans to submit to the federal Centers for Medicare & Medicaid Services (CMS) SPA 20-0011, which proposes to continue the augmentation payments for fee-for-service Medi-Cal emergency air medical transportation services for state fiscal year (SFY) 2020-21, in accordance with the provisions of the Emergency Medical Air Transportation Act (EMATA). (Senate Bill 326, Chapter 797, Statutes of 2015; extended by Assembly Bill (AB) 1410, Chapter 718, Statutes of 2017).

Under the EMATA, an additional penalty of \$4 is imposed on Vehicle Code violations statewide, with the exception of parking offenses. The penalties collected under EMATA are transferred by counties into the Emergency Medical Air Transportation and Children's Coverage (EMATCC) Fund, formerly known as the EMATA Fund. The penalty assessments terminate on July 1, 2020; however, AB 651 allows DHCS to continue making augmentation payments to emergency medical air transportation providers through December 31, 2021. The augmentation payments will be made using monies available in the EMATCC Fund and any available federal matching funds.

Upon federal approval of the SPA, DHCS will make augmentation payments for eligible emergency air medical transport services provided for the July 1, 2020 through June 30, 2021 period, in accordance with the EMATA. The effective date of the proposed SPA is July 1, 2020. All proposed SPAs are subject to approval by CMS.

DHCS estimates that the annual aggregate Medi-Cal expenditures for emergency air medical transportation services will increase by \$10 million in total funds. The maximum pool for augmentation payments in SFY 2020-21 is estimated to be \$10 million in total funds, which is the same as the prior SFY.
