**PROPOSED STATE PLAN AMENDMENT REGARDING
THE GROUND EMERGENCY MEDICAL TRANSPORT
QUALITY ASSURANCE FEE PROGRAM**

This notice provides information of public interest regarding a proposed State Plan Amendment (SPA) by the Department of Health Care Services (DHCS). SPA 22-0040 proposes to renew the Ground Emergency Medical Transportation (GEMT) Quality Assurance Fee (QAF) program and the reimbursement add-on provided for Medi-Cal ground emergency medical transports, effective for the service period of July 1, 2022 through June 30, 2023.

Senate Bill (SB) 523 (Chapter 773, Statutes of 2017) established a QAF program for GEMT services, effective July 1, 2018. Under the GEMT QAF program, DHCS collects a QAF on all GEMT services by a provider subject to the QAF, regardless of payer type, as identified by the service codes listed below. The QAF is used to increase reimbursement to eligible emergency medical transport providers by application of an add-on to the Medi-Cal fee-for-service fee schedule rate for the following service codes:

Service Code	Description
A0225	Neonatal Emergency Transport
A0429	Basic Life Support
A0427	Advanced Life Support, Level 1
A0433	Advanced Life Support, Level 2
A0434	Specialty Care Transport

SPA 22-0040 will continue the add-on increase to the Medi-Cal fee-for-service fee schedule amount for the above-listed service codes. DHCS estimates that the annual aggregate Medi-Cal expenditures for ground emergency medical transports will increase by \$29.9 million in total funds.

Assembly Bill (AB) 1705 (Chapter 544, Statutes of 2019) establishes the Public Provider Ground Emergency Medical Transportation Intergovernmental Transfer (PP-GEMT IGT) program for eligible public GEMT providers. Providers are eligible to participate in this program if they provide GEMT services to Medi-Cal beneficiaries, are enrolled as a Medi-Cal provider for the period being claimed, and are owned or operated by the state, a city, county, city and county, fire protection district, special district, community services districts, health care district, or a federally recognized Indian tribe. Participation in the program by an eligible public provider is voluntary. Once the PP-GEMT IGT program is implemented, public providers in the PP-GEMT IGT program will no longer be able to participate in the GEMT QAF program. This means that public providers will no longer be

assessed the QAF prospectively from the implementation date of the PP-GEMT IGT Program and will not be eligible to receive the add-on pursuant to the GEMT QAF program. The PP-GEMT IGT program is anticipated to be implemented on January 1, 2023, contingent on federal approval of SPA 22-0015.

SPAs 22-0040 and 22-0015 are subject to approval by the federal Centers for Medicare and Medicaid Services (CMS).
