PROPOSED STATE PLAN AMENDMENT TO EXTEND THE SUPPLEMENTAL REIMBURSEMENT FOR QUALIFIED PRIVATE HOSPITALS PROGRAM TO JUNE 30, 2020

This notice is to provide information of public interest with respect to proposed State Plan Amendment (SPA) 19-0023. Proposed SPA 19-0023 will extend the Supplemental Reimbursement for Qualified Private Hospitals program to June 30, 2020. The continuation of the Program for an added year will allow for enhanced Medi-Cal payments to private hospitals and improve the availability of essential services for Medi-Cal beneficiaries. The Department is also seeking to add 2019-20 payment amounts to page 10 of Section D.1 of Supplement 4 to Attachment 4.19-A of the State Plan. The SPA is necessary to allow intergovernmental transfer funded payments for State Fiscal Year (SFY) 2019-20. Below are the proposed payment amounts for SFY 2019-20:
