Section 51240. Utilization of Nonphysician Medical Practitioners.

(a) – no change

(b) The number of nonphysician medical practitioners who may be supervised by a single primary care physician shall be [begin underline]<u>in accordance with applicable</u> <u>professional licensing statutes and regulations.[</u>end underline] [begin strikeout]-limited to the full-time equivalent of one of the following:

(1) Four nurse practitioners.

(2) Three nurse midwives.

(3) Two physician's assistants.

(4) Four of the above individuals in any combination which does not exceed the limit stated in either subparagraph (2) or (3).[end strikeout]

(c) through (d) – no changes

[begin strikeout] (e) Each nurse practitioner shall have completed a clinical and didactic educational program of at least six months duration, which shall be:

(1) Of a length of time and focus appropriate to the scope and functions of the area of practice.

(2) Offered in one of the following:

(A) A college or university that offers a baccalaureate or higher degree.

(B) A health care agency that has an academic affiliation with a college or university as specified in (A).[end strikeout]

Section 51476. Keeping and Availability of Records.

(a) Each provider shall keep, maintain, and have readily retrievable, such records as are necessary to fully disclose the type and extent of services provided to a Medi-Cal beneficiary. Required records shall be made at or near the time at which the service is rendered. Such records shall include, but not be limited to the following:

(1) through (6) – no changes

(7) Identification of the person rendering services. Records of each service rendered by nonphysician medical practitioners (as defined in Title 22, CCR, Section 51170) shall include the signature of the nonphysician medical practitioner and the countersignature of the supervising physician [begin underline]to the extent required by the applicable professional licensing statutes and regulations[end underline].
