

HCS CYBHI FEE SCHEDULE PROGRAM SCOPE OF SERVICES, CODES, AND REIMBURSEMENT RATES

Purpose

This document outlines the scope of services for the Children & Youth Behavioral Health Initiative (CYBHI) statewide, multi-payer fee schedule (Fee Schedule) program, which includes a variety of outpatient, nonspecialty mental health and substance use disorder services (e.g., psychoeducation, screening and assessments, treatment, case management).

See the table below for the service categories, procedure codes, brief service descriptions, eligible practitioners, and reimbursement rates per individual under the CYBHI Fee Schedule program.

Required modifiers, frequency limits, and acronym list can be found in the Appendix at the end of the document.

APPENDIX

Modifiers

This section outlines the required and allowable modifiers for the 53 procedure codes included on the CYBHI Fee Schedule program.

Required modifiers

- » All claims **must** include the **"U4" modifier**, which is considered the CYBHI Fee Schedule program identifier. << **"U4"** must be in first modifier position on a claim line.>> Claims submitted for reimbursement without the "U4" modifier will not be processed.
- » For psychoeducation codes H2014 and H2027, individual services **must** include the "**HA**" **modifier** and group services must include the "HQ" modifier.

Dyadic services

The CYBHI Fee Schedule program reimburses dyadic services for recipients ages 0 to 20 years and/or their caregivers. The dyad is defined as the child ages 0 to 20 years and the child's caregiver(s). The CYBHI Fee Schedule program reimburses specific assessment, screening, counseling and brief intervention services provided to the caregiver for the benefit of the child when billed under the child's health insurance with the "U1" modifier.

Dyadic services for caregivers include the following:

» Brief emotional/behavioral assessment (96127), ACEs screening (G9919, G9920), Annual screening for alcohol misuse (G0442), Depression screening (G8431, G8510), Psychosocial status assessment (96156), Psychiatric diagnostic evaluation (90791), Family Training and Counseling for Child Development (T1027), Psychoeducational Services (H2027)

Telehealth

Telehealth means the mode of delivering health care services via information and communication technologies to facilitate the diagnosis, consultation, treatment, education, care management and self-management of a patient's health care.

» For services provided via synchronous telephone or other real-time interactive audio-only telecommunications systems, use the "93" modifier. For services provided via synchronous, interactive audio and visual telecommunications systems, use the "95" modifier.

Instructions for use of time as units

For procedure codes that are time-based, each measure of time as defined by the code description equals one unit (e.g., 15 minutes, 30 minutes). Most time-based codes can be billed more than once per day per student. Time billed for reimbursable services should include only direct service time. Indirect service time has been included in the reimbursement rate and should not be billed.

The Midpoint rule

Time-based services must be billed to the code with the appropriate time increment. To be eligible for reimbursement, the service must have lasted at least half plus one minute of the billing increment specified for that code. This is known as the midpoint or half-point rule. For codes that are billed per 15 minutes, a minimum eight (8) minutes of service must be provided to bill for one unit. Partial units must be rounded up or down to the nearest guarter hour. For example, a service that takes 24 minutes can be billed for 2 units of service (e.g., 15 minutes (1 unit) + 9 minutes (half-point rule) = 24 minutes or 2 billable units).

Frequency limitations for procedure codes

Frequency limitations are not imposed for medically necessary services provided to students under the CYBHI Fee Schedule program, per state statue⁶. For the current annual frequency limitations for each code, please see the Medi-Cal Non-Specialty Mental Health Services manual.
