Changes to the Cost Report Instructions

The following change(s) are **required** for a complete submission of the 2011-2012 Cost Report. This year's Cost Report instructions differ from last year, as indicated below:

- 1. Cost Report Submission:** New guidelines have been established for submission of the 2012 TCM Cost Report. These guidelines are detailed on page 14 and 15 of the 2012 Cost Report Instructions.
- 2. Interim Medi-Cal TCM Encounter Payment Rate Calculation Worksheet (IMTEPR):** A revised Interim Medi-Cal TCM Encounter Payment Rate Calculation Worksheet (IMTEPR) has been developed for FY 2011-12 to record all Target Populations served by an LGA reporting budget unit. This revised form replaces the prior version.

For Your Information: This year, all costs for providing TCM services will be based on the target populations of Children Under the Age of 21, Medically Fragile Adults, Individuals At Risk of Institutionalization, Individuals in Jeopardy of Negative Health or Psycho-Social Outcome, and Individuals with Communicable Diseases. For LGAs that subcontract with CBOs/LPEs, a Cost Report must be submitted for each CBO/LPE service provided.

Reminder of Important Changes Identified in Previous Years

- Addition of a Supplemental Worksheet - “Interim Medi-Cal TCM Encounter Payment Rate Calculation”:
 - The purpose of this new worksheet is to calculate one interim Medi-Cal payment rate (encounter rate) that will approximate the Medi-Cal TCM program cost per encounter eligible for Federal Financial Participation claimed through the CPE process.
- Time Survey: For cost report due November 1, 2012 - The 2009 completed MAA-TCM time surveys and related template(s) should be used.
- Averaging Staff: For cost report due November 1, 2012 - staff who were “TCM direct supervisors of case managers” or “direct support staff to case managers” in FY 2011/12 who did not time survey in the FY 2009/10 should be included in the “Averaged” section of the Salaries & Benefits Scheduled 1A and classified as “TCM”. The purpose of this change is for establishing an interim rate to include cost for TCM staff(s) not present during the time survey period in FY 2009/10.
- Identify cost report(s): Use a unique program name on “Worksheet A” for each cost report template filed. List program names from the cost report templates that are filed by the LGA on the **cover letter**. Identify the cost reports that includes 100% of costs of each target population.
- Time Survey: A “Add-Time Survey” button was added to the Combined MAA-TCM Time Survey Template.
- Addition of “Summary of Allowable Funding For Claiming Federal Matching Funds” Worksheet
 - The purpose of this worksheet is to identify the funding sources for eligible Certified Public Expenditures (CPE) of billable TCM services provided to Medi-Cal(s) beneficiaries. This worksheet will serve to determine if the funding source provided adequate CPE for Federal Financial Participation (FFP) match, as required by 42 CFR 433.51 (page 20, 45).

Note: This worksheet does not take into account timing requirements for expenditures.
- Cost Report must be submitted for all service providers (LGAs, CBOs, and LPEs).
- Effective January 1, 2009 Assembly Bill (AB) 2527 amends Welfare & Institutions (W&I) Code 14132.44 – LGAs may contract with other Local Public Entities (LPE) to provide TCM services. See PPL 08-027 and PPL 09-002.
- New Certifications and Attestation Documents:
 - “Local Government Agency Certification Statement “
For additional information please see PPL 08-006
 - “Non-LGA Local Public Entity Certification and Local Government Agency Attestation Statements”

- Non-LGA Local Public Entity (LPE) costs – When the LGA contracts with an LPE to provide TCM services to Medi-Cal beneficiaries, the “Non-LGA Local Public Entity Certification” and “Local Government Agency Attestation Statements” must be used.
- Closing-Year Costs.
- Cover letter must be signed by the LGA Coordinator.
- Changes to how you allocate costs to S&B Sch 1A. Refer to Policy and Procedure Letter (PPL) 06-014.
- The “Encounter Methodology” must include a supplemental schedule identifying type (Medi-Cal or Other) and number of encounters by month. (This information can be obtained from the Encounter Log).
- Include complete job descriptions of all TCM classifications with your Cost Report. These descriptions must include specific TCM duties.
- Staff classifications on the Salary & Benefits Schedules (S&B Sch) are further restricted:
 - To ensure the validity of TCM Case Manager classification, the Cost Report Review Tool requires a list of staff who are classified as TCM Case Managers, identified by the number of TCM encounters claimed by each in the prior fiscal year. For TCM Case Managers who claimed no TCM encounters you must provide an explanation, including what TCM Services were provided.
 - The Direct Supervisor of Case Manager staff must be no more than two organizational levels above the case manager level. For example, no CFOs or department managers, these are classified as ADMIN or NTCM.
 - If ADMIN staff is listed individually on S&B Sch 1A, include each staff’s job title in the “Role” column. If ADMIN costs are entered as one aggregated amount, the staff names, job titles, and individual salaries and benefits must be listed on a separate page.
- The Encounter Methodology worksheet must include all valid Medi-Cal encounters (not just claimable Medi-Cal encounters). Encounters that are not claimable must be counted (and entered in the Encounter Log) and included on this worksheet. The worksheet now includes a separate line for these encounters.
- A complete and comprehensive narrative describing the types of programs and services that are included in the TCM budget unit must be submitted.
- The Cost Report Review Tool has been enhanced to include the following calculations to alert you to possible unreasonable costs:
 - The approximate cost per encounter hour.
 - The ratio of Administrative Salaries & Benefits to TCM Salaries & Benefits.
 - The ratio of Operating Expenses (not including Contractors) to TCM Salaries & Benefits.
- The organizational chart should be as complete as possible, including staff names, job titles, and who they report to, or provide a complete roster of staff names, job

titles, and who they report to. It is recommended to include on organizational/chart roster, and the budget unit numbers or account numbers shown on the general ledger.

Community - Based Organization(s) (CBO) Changes:

- Financial Statements: Balance sheet and Income Statements for all **CBOs**, and CPA audited financial statements where applicable.
- Other Required Materials to be included are:
 - Income Tax Returns (CBO's)
 - CBO bylaws and Articles of Incorporation (If not submitted with the Cost Report in a prior year).
- On Worksheet B, all CBOs must offset private funding (e.g., client fees, foundation grants, etc.).

TCM Cost Report Overview

Cost Report Format for Targeted Case Management (TCM) Programs

Obtain a current Cost Report Template and supplemental forms from the Department of Health Care Services (DHCS) TCM website: <http://www.dhcs.ca.gov/provgovpart/Pages/TCM.aspx>. Only the current year forms may be submitted. Report submitted with outdated forms will be returned, which will affect your ability to submit invoices.

Note: Read all of these instructions before completing the Cost Report Template.

Annual Cost Report

California Welfare and Institutions (W&I) Code, Section 14132.44, requires each TCM provider of service to complete and submit to DHCS a Cost Report on the prior fiscal year (ending June 30) for each local program providing TCM services. The Cost Report must be prepared in a format specified by DHCS and submitted by November 1 of each year. Title 22 of the California Code of Regulations (22 CCR) Section 51535.7 requires LGAs to submit **one Cost Report for each program that provides TCM services** to one of the five target populations. The target populations are Children Under the Age of 21 (14), Medically Fragile Individuals (15), Individuals at Risk of Institutionalization (16), Individuals in Jeopardy of Negative Health or Psycho-Social Outcomes (17), and Individuals with a Communicable Disease (18). For LGAs that subcontract with CBOs/LPEs, a Cost Report must be submitted for each CBO/LPE service provider.

Purpose of a Cost Report

The purpose of a Cost Report is to:

- 1) Establish an **Encounter Rate** for the provision of TCM Services
- 2) Determine the **actual total cost** of providing TCM Services
- 3) Establish the TCM Maximum Amount (CAP)

Using actual allowable costs, funding, and encounter data from the prior fiscal year (2011-12), the Cost Report calculates the “Billable Rate Per Encounter for Current Year (Worksheet A, Line 20).

The Adjusted (net) Allowable Case Manager Costs in the Cost Report (Worksheet A, Line 19) reflects the allowable direct and indirect costs of providing TCM services as delineated in the federal Office of Management and Budgets Circular A-87 (OMB A-87). The guiding OMB A-87 principle to determine allowability is that costs must be “reasonable and necessary” for the provision of TCM services. LGAs must analyze their costs and only consider costs allowable, that are both, reasonable and necessary to provide TCM services (see the link to the OMB website in Appendix A). A certification statement, signed by the TCM Coordinator or the TCM Coordinator’s designee, must accompany the Cost Report and attest to the validity and allowability of the cost data and funding sources.

Reimbursement

LGAs are reimbursed by the Federal Medical Assistance Percentage (FMAP) (currently 50 percent) of the funds expended for providing TCM services to Medi-Cal beneficiaries based upon the actual costs of providing TCM.

For each LGA, the Department will establish an interim Medi-Cal payment rate from DHCS accepted cost reports. The interim Medi-Cal payment rate will be calculated by dividing the total allowable costs by total encounters from the cost reports containing 100% of the LGAs costs and encounters for each target populations. The interim Medi-Cal payment rate will be used for the initial submission of TCM claims for federal reimbursements for all target populations. Refer to “Interim Medi-Cal TCM Encounter Payment Rate Calculation” worksheet for details on how the rate is calculated

TCM program payments are subject to reconciliation by the Department of Health Care Services (DHCS). The reconciliation will compare the actual cost to interim payments LGAs have been reimbursed for the same fiscal period that services were provided.

Interim Medi-Cal TCM Encounter Payment Calculated Rate

The Interim Medi-Cal payment rate for all target populations is calculated by dividing the total allowable costs by total encounters from all cost reports containing 100 percent of each target population’s cost.

Interim Medi-Cal TCM Encounter Payment Rate = Total Adjusted Allowable Case Managers Cost [Cost Report Worksheet A, line 19] in all target population(s) ÷ Total Reported TCM Encounters in all [Cost Report Worksheet A, line 19] Target population(s)

Encounter (Enc.) Rate

The TCM encounter rate is calculated by dividing the total TCM costs by the total number of TCM encounters (Medi-Cal and non-Medi-Cal, whether or not they were claimed).

Encounter Rate = Total TCM Cost ÷ Total # TCM Enc. (Medi-Cal and Non Medi-Cal)

TCM Maximum Amount (CAP)

The CAP is the total dollar amount that may be claimed in the current fiscal year. It is calculated by multiplying the rate per TCM encounter by the projected number of Medi-Cal-only encounters (Worksheet A, Line 22). The projections must be supported by program documentation that identifies staff levels sufficient to achieve the projected number of encounters, by TCM encounter logs, and by client case record documentation. Use the Encounter Methodology Worksheet to calculate the projected number of Medi-Cal-only encounters.

CAP = Rate per TCM Encounter X Projected # of Medi-Cal Only Encounters

Maximum Reimbursement (Federal Share or FMAP)

The LGA receives a TCM approval letter that identifies the TCM interim encounter rate and the CAP. The maximum reimbursable federal share is computed by multiplying the CAP by the prevailing FMAP.

$$\text{Max Reimbursable Federal Share} = \text{CAP} \times \text{FMAP}$$

Maximum Reimbursements to the LGAs

The number of projected Medi-Cal encounters is multiplied by the appropriate TCM interim encounter rate; this amount is then multiplied by the FMAP. *This is the maximum amount the LGA will be reimbursed per Title 22, 51535.7 – Targeted Case Management Services Reimbursement.*

$$\text{Max amount the LGAs will be Reimbursed} = \text{Billable Rate per Enc.} \times \text{Projected Medi-Cal Enc. \#} \times \text{FMAP}$$

Note: TCM program reimbursements will not be subject to CAPs under the new TCM Reimbursement SPA submitted to CMS for approval. Until CMS approves the Reimbursement SPA, all existing reimbursement requirements remain in effect. Therefore, it is important that the total projected encounters reflect encounters for all target populations provided services by the budget unit.

Preparing the TCM Cost Report

Required Documents

Essential components of the Cost Report include the following materials. All materials are located on the DHCS TCM website <http://www.dhcs.ca.gov/provgovpart/Pages/TCM.aspx>.

Note: Read all instructions before completing the materials. Cell-by-cell instructions for completing the Excel template workbooks begins on page 26.

1. **DHCS Time Survey Summary Template.**
2. **DHCS Cost Report Template** (Note: enter data only in the blue cells), which includes:
 - a. **Calculation for Averaged Percentages** (Survey Averaging Worksheet) – Input hours from TCM Time Survey Summary Template List.
 - b. **Salaries & Benefits Schedules** (Salaries Worksheet):
 - i. **S&B Sch 1A** – Salaries and benefits from payroll details.
 - ii. **S&B Sch 1B** – Direct and indirect operating expenses from general ledgers and Countywide Cost Allocation Plans.
 - iii. **S&B Sch 2A** – Percentages from the List Worksheet on the DHCS Time Survey Summary Template.
 - iv. **S&B Sch 2B, 2C, and 2D** – Formula-driven: Do not enter data here.
 - c. **S&B Sch 3A & 3B for Contractors** – Use only for Community-Based Organizations (CBOs) and/or Local Government Entities (LPEs) (not individuals).
 - d. **Worksheet D** – To enter 100-percent TCM (such as purchase of computer programming services used solely for TCM) and 100-percent non-TCM (NTCM) operating expenses (such as food, respite care, transportation, and medical expenses) for the budget unit that provided TCM services only.
 - e. **Worksheet C** – Cost reclassification analysis tool: Do not enter data here.
 - f. **Worksheet B** – To record and offset federal (and private) funding that supports the provision of TCM services.
 - g. **Encounters Worksheet** – Calculates and documents methodology used to record prior-years encounters and project current-year encounters.
 - h. **Worksheet A** – Summarizes all costs and calculates the encounter rate. This worksheet must be signed in blue ink by the LGA coordinator or an authorized signer.
3. **Certification/Attestation Statement(s)** - Signed (blue ink) by an appropriate representative, such as LGA MAA/TCM Coordinator, the Chief Financial Officer or other individual duly authorized and states the signatory's title.
 - a. For each cost report submitted by an LGA service provider, include "LOCAL GOVERNMENT AGENCY CERTIFICATION STATEMENT FOR TARGETED CASE MANAGEMENT COST REPORT."

- b. For each Non-LGA Local Public Entity (LPE) service provider cost report, include "NON-LGA LOCAL PUBLIC ENTITY CERTIFICATION AND LOCAL GOVERNMENT AGENCY ATTESTATION STATEMENTS FOR TARGETED CASE MANAGEMENT COST REPORT "
4. **Certify validity of CBO/LPE Cost Report(s) (if applicable)** - Each CBO/LPE Cost Report submitted to DHCS has been reviewed for accuracy and validity by an appropriate LGA representative, such as a Chief Financial Officer or the LGA MAA/TCM Coordinator. For each CBO/LPE cost report submitted by an LGA, include the "TCM COST REPORT CERTIFICATION STATEMENT"
5. **Cost Report Checklist** – Completed by TCM Coordinator.
6. **Cost Report Review Tool (RT)** – Completed by TCM Coordinator.
7. **Funding Schedule** – Identifies all funding sources that support the whole budget unit; source document for Worksheet B. Funding Schedule isolates unallowable funding used to support the provision of all TCM services.
8. **Summary of Allowable Funding for Claiming Federal Matching Funds** - Identifies allowable funding, eligible for Federal Matching Funds, pursuant to 42 CFR 433.51 for Medi-Cal TCM services.
9. **Interim Medi-Cal TCM Encounter Payment Rate Calculation Worksheet** – Calculates an interim encounter payment rate.
10. **Operating Expense Schedule** – Describes accounts that have vague account names or names that suggest they are unallowable.
11. **Cost Report packaging instructions** - Table of Contents, Program Description, Cost Allocation Description, Tabs, Supporting Documents, Highlighted Numbers on Supporting Documents, and Cost Report Checklist.
12. **A complete job description** - (Duty statement) of all TCM classifications in the budget unit.

Before constructing the Cost Report, gather the following documents for each program and CBO/LPE (if applicable):

1. Detailed organizational chart (or complete roster) showing the relationship of each position listed on the Cost Report to the others listed on the Cost Report.
2. FY 2011-12 - General Ledger.
3. FY 2012-13 - Board-approved final budget showing actual expenses for the prior year (FY 2011-12), if available. Only include relevant pages relating to TCM with the Cost Report.
4. FY 2011-12 - Summary of total expenses and funding and where they are found in supporting documentation.
5. FY 2011-12 - Salaries and benefits by employee (from payroll warrant detail or general ledger and/or other documented cost allocation plan).

6. FY 2011-12 - Services and supplies (from general ledger and/or other documented cost allocation plan).
7. Copies of contracts for non-LGA TCM service providers (CBO/LPE) for FY 2011-12.
8. Copies of FY 2011-12 contracts (Interagency Agreements/Memorandums of Understanding) for which funding may be received for TCM related services.
9. September or October 2009 "TCM Program Time Surveys for **Employees Performing MAA and/or TCM**" signed forms for programs that time-surveyed to TCM.
10. A complete and comprehensive narrative describing the types of programs and services that are included in the TCM budget unit.
11. A copy of the page of the CWCAP (or the relevant departmental administrative cost allocation plan) that shows the indirect cost percentage of the TCM budget unit.
12. Financial Statements: Balance sheet, general ledger, etc. for all **LPEs**.
13. Financial Statements: Balance sheet plus I.R.S Annual Information Return e.g. I.R.S Form 990, for all **CBOs** and CPA audited financial statements where applicable.
14. Income Tax Returns for **CBOs**.
15. CBO Bylaws and Articles of Incorporation (If not submitted with the prior years Cost Report).

2012 TCM Cost Report Submission Requirements

- Table of Contents
- TCM Cost Report Checklist
- LGA Cost Report Certification Statement
- CPE Certification and LGA Attestation Statements

- Cost Reports Supporting Documents
 - Organizational Chart Including the Defined Budget Unit (BU), and Listing all Staff & Positions within the BU
 - A Complete and Comprehensive Narrative Describing the Types of Programs and Services that are included in the TCM BU
 - General Ledger Grouping Schedule for Reported Costs and Funding
 - Salary and Benefit Costs – Payroll Amounts by Employee
 - Financial Statements of the TCM Service Provider who Files the Cost Report

- Signed Cost Report Template
- Funding Schedule
- Summary of Allowable Funding for Claiming Federal Matching Funds Worksheet
- Interim Medi-Cal TCM Encounter Payment Rate Calculation Worksheet

Summary of Steps

Below is a summary of 12 basic steps (defined fully under “Step-By-Step”) for the preparation of a TCM Cost Report:

1. Identify TCM budget unit of the LGA, CBO, or LPE that provides TCM services by analyzing budget account numbers from your general ledger and detailed organizational charts (include these supporting documents when you submit your Cost Report). Answer the question: What part of our organization provides TCM services?
2. Describe the cost allocation method for Method 1 and 2 used in your LGA. Answer the question: How do we account for the costs for providing TCM services? (Write this down and submit it with the Cost Report.)
3. List the staff alphabetically by last name, who provide or support the provision of TCM services. The TCM Cost Report assumes that the TCM staffs are part of a budget unit that is identifiable on a general ledger by a unique account code.
 - a. Classify as **TCM**, TCM case managers, direct supervisors and direct support staff to TCM case managers who time-survey in FY 2009/10 (no more than two organization levels above).
 - b. Classify as **TCM**, TCM case managers, direct supervisors and direct support staff of TCM case manager **who did not time-survey in FY 2009/10** in the “Averaged” section of the Salaries and Benefits Schedule (S&B Sch) 1A. (For *this FY only*.) List their job titles in the Role column.
 - c. Classify as ADMIN administrative staff who provide personnel and budget support to TCM case managers. List their job titles in the Role column.
 - d. Classify all other staff as **Non-TCM** (NTCM).
4. Enter the data from each TCM staff’s original signed time survey into the DHCS MAA/TCM Combo Time Survey. Enter the LGA and program names only at the top of the List worksheet. Enter each TCM staff name and position only on numbered worksheets (do not enter them on the List or Totals worksheets). Enter the percentages for each category from the List Worksheet on that template into S&B Sch 2A and the Calculation for Averaged Percentages (Survey Averaging) worksheet.
5. Using your LGA’s general ledger and payroll warrant details, identify the account numbers for funding, salaries, benefits, and operating expenses that support these staff (the Cost Report template and supporting documents must identify **all** funding and costs that support the budget unit). Provide a copy of the relevant pages of these supporting documents with your Cost Report. Include as operating expenses indirect departmental or LGA-wide administrative services that support the budgetary, personnel, and management needs of the TCM budget unit.
6. Identify which of the TCM budget unit’s operating expenses are allowable per OMB A-87. Enter only allowable operating expenses on S&B Sch 1B. Enter unallowable operating expenses on Worksheet D, Column 4. If you list operating expenses by individual staff, operating expenses for NTCM staff must be reported only on Worksheet D, Column 4.

7. Enter the LGA (or CBO/LPE) and program names only at the top of Worksheet A.
8. Enter staff salaries and benefits on S&B Sch 1A, allowable direct and indirect operating expenses on S&B Sch 1B, unallowable operating expenses on Worksheet D, Column 4, and unallowable federal (and private) funding amounts on Worksheet B.
9. Construct a summary of the total salaries, benefits, operating costs, and funding shown in the Cost Report that identifies these costs in the supporting documents.
10. Using your LGA's TCM encounter log, complete the Encounter Methodology Worksheet.
11. From each of the cost reports containing 100% of each TCM targeted population's cost enter 1) Total TCM Reported Encounters [from Worksheet A, line 14] and 2) Adjusted Allowable Case Manager Costs [from Worksheet A, line 19] into the Interim Medi-Cal TCM Encounter Payment Rate Calculation Worksheet
12. Complete the Cost Report Review Tool to ensure completeness, reasonableness, and accuracy.
13. Include a cover letter that would identifies cost reports by using the unique program name from "Worksheet A" for each cost report templates filed. List program names from the cost report templates that are filed by the LGA on the **cover letter**. Identify the cost report that includes 100% of costs of each target populations.
14. Develop Table of Contents. Be sure to structure your Cost Report Packet with page numbers, tabs, labels, etc.

All amounts entered into the Cost Report must be supported by Time Survey, general ledgers, payroll warrant details, subcontractor contracts (if applicable), and program descriptions. Enter data **only in the blue cells** of the Cost Report template.

Note: If you need to add additional lines to the Cost Report worksheets (B, D, Salaries, and Contractor Worksheets), Funding Schedule, Summary of Allowable Funding for Claiming Federal Matching Funds, and Cost Report Review Tool, click on the associated "Add" button and enter the number of lines to add.



Step-By-Step for a Successful Cost Report

Defining the Budget Unit

The budget unit should be the smallest budgetary/organizational unit identifiable on the LGA organizational chart and general ledger that includes the TCM-related costs of all employees meeting the TCM Case Manager qualifications, their supervisors, and support staff. The TCM Cost Report assumes the TCM budget unit is readily identifiable on LGA organizational charts and LGA general ledgers.

The guiding principle of OMB A-87 regarding eligibility of federal reimbursement, requires costs to be “reasonable and necessary” for the provision of TCM services. By identifying the smallest budget unit possible, you help ensure that the costs included in the Cost Report and allocated by the Cost Report template formulas are reasonable to the exact cost of providing TCM services. Two different methods are described below:

Method 1

The TCM Cost Report must include all the costs of the budget unit that provides TCM services. The Cost Report may include **indirect expenses**, which are the portion of departmental or LGA-wide budget, personnel, and management expenses that can be allocated to the TCM budget unit. Include indirect expenses in the total operating expenses entered on S&B Sch 1B.

If your budget unit consists of only a few TCM staff and many ADMIN and NTCM staff, determine if the budget unit costs can be identified at a more detailed level to isolate the costs of the TCM staff.

Method 2

Some LGAs have cost accounting methods that allow them to identify all the costs and funding sources of individual employees. Such Cost Reports might not include any NTCM costs or unallowable funding sources. To construct a Cost Report that has no NTCM costs, take the ratio of TCM salaries to total salaries of the budget unit, and apply the ratio to the budget unit’s total ADMIN and operating expenses. Then, construct the Cost Report so that it only includes the budget unit’s TCM costs and the TCM portion of ADMIN and operating costs. Include the portion of departmental ADMIN costs related to TCM as indirect operating expenses on S&B Sch 1B. Include this calculation with your Cost Report. In either case, the Cost Report must include an explanation of the LGA’s cost allocation method, and all costs and funding sources must be supported by general ledgers and other relevant documentation.

Classifying Salaries and Benefits (S&B Sch 1A)

Based on the primary function of the employee within the budget unit, classify salaries and benefits amounts into TCM, NTCM, and ADMIN.

TCM Staff – Staff who time-survey to TCM: TCM case managers, their direct supervisors, and their direct support staff. If they time-survey, their salaries and benefits amounts are entered on S&B Sch 1A in the rows at the top under the heading “Time-Surveyed to TCM”. If they **did not time-survey**, their cost can be averaged in the “Averaged” section and their classification must be listed as “direct supervisor of case manager or direct support staff of case manager”. **Note: this change is for cost report(s) due November 1, 2012.** Enter staff in alphabetical order by last name.

Include a complete job description of all TCM classifications with your Cost Report, including the specific TCM duties of that classification.

NTCM Staff – These are staffs within the budget unit that provide TCM services who neither provided nor supported the provision of TCM services. These may be staff who provide direct medical care, transportation, pharmacy, MAA, and other services that are not TCM. Staff names, positions, salaries, and benefits may be listed on S&B Sch 1A, or they may be listed on a separate supporting document and recorded on S&B Sch 1A on one line as an aggregate amount. Enter staff in alphabetical order by last name. Alternatively, if you use a single aggregate amount, enter the name of the supporting schedule in the employee name cell. If you use aggregate amounts, a supporting schedule must be included with the Cost Report. List the NTCM staff on the supporting schedule in alphabetical order by last name. Do not use organizational charts as the supporting schedule for this purpose.

ADMIN Staff – Managerial and administrative staff who support the management, personnel, and budget needs of the TCM budget unit. (Note: If personnel and budget services are not part of the budget unit, DO NOT expand the size of the budget unit to include them. Calculate these costs as an indirect expense and include it with operating expenses on S&B Sch 1B.) These expenses may be listed on the S&B Sch 1A or on a separate supporting document and recorded as an aggregate amount on S&B Sch 1A on one line. Please enter the ADMIN staff in alphabetical order by last name. If you use a single aggregate amount, enter the name of the supporting schedule in the employee name cell. If you use aggregate amounts, a supporting schedule must be included with the Cost Report. Do not use organizational charts as the supporting schedule for this purpose. List the ADMIN staff on the supporting schedule in alphabetical order by last name. List ADMIN staff job titles in the Role column on S&B Sch 1A or next to their names on the supporting document.

Classifying TCM Contractors Costs (S&B Sch 3A & 3B)

Classify the cost of TCM contractors by Specific or Non-Specific. S&B Sch 3A & 3B are provided for this purpose and may only reflect the costs of CBOs/LPEs. Each CBO/LPE that contracts with your LGA to provide TCM services must complete a TCM Cost Report. If there is only one CBO/LPE and the LGA does not provide these services, submit the CBO's/LPE's Cost Report as though it were the LGA's Cost Report, and do not use S&B Sch 3A or 3B. If there are multiple CBOs/LPEs, the results of each CBO/LPE Cost Report are entered onto S&B Sch 3A or 3B of the LGA's combined Cost Report.

Most CBO/LPE contracts are non-specific; that is, the contract does not specify the total amount the CBO/LPE will receive for providing TCM services, it states a maximum amount or a rate. For non-specific contracts, enter the total net expenses from Worksheet A, Line 7, Column 7, of the CBO/LPE Cost Report into the column titled Total TCM Costs per Analysis on S&B Sch 3A of the LGA's combined Cost Report. Enter the adjusted allowable case manager costs from Worksheet A, Line 19, of the CBO/LPE Cost Report into the column titled Total Costs per Analysis on S&B Sch 3A of the LGA's combined Cost Report.

If the CBO/LPE contract specifies the total amount the CBO/LPE will receive for the fiscal year to provide TCM services, enter the amount from Worksheet A, Line 7, Column 7, of the CBO/LPE Cost Report into the column titled "Total TCM Costs" on S&B Sch 3B of the LGA's combined Cost Report. If the contract is for both TCM and NTCM services, enter the amount from Worksheet A, Line 19, of the CBO/LPE Cost Report into the column titled "Total Costs per Analysis" on S&B Sch 3B of the LGA's combined Cost Report. If the contract is for TCM services only, enter the amount from Worksheet A, Line 7, Column 7, in both columns.

Classifying Operating Expenses (S&B Sch 1B and Worksheet D)

Using your LGA's general ledger and Countywide Cost Allocation Plan (CWCAP) (the one submitted annually to the State Controller's Office), identify the account numbers and names for operating expenses. You must submit a copy of the letter that the Controller sent back to your county, if applicable. Operating expenses may be direct or indirect.

Direct expenses are for staff who provide and directly support the provision of TCM services; these include the ADMIN and NTCM staff that are in the budget unit that provide TCM services. Direct expenses include the cost of services and supplies, as well as operating expenses incurred by the TCM budget unit, including leases, and amortized capital expenditures. Report these on S&B Sch 1B.

On S&B Sch 1B, operating expenses may be **distributed proportionately** according to staff salary and benefits or entered as a direct cost assigned **by employee**. If your LGA's cost allocation method allows you to identify the operating expenses of each staff, then report these costs in the column Operating Expenses by Employee in the row for the appropriate staff. Otherwise, combine direct and indirect operating expenses into one amount and enter it in the single blue cell at the bottom of the column titled Distributed

Operating Expenses. Enter the name of the supporting documentation for this amount beneath the column.

Some costs may be identified as 100-percent TCM (such as individual contractors) or 100-percent NTCM that will not be further redistributed by the Time Survey. Worksheet D has been provided for these costs. Report services of individual contractors who support TCM program operations 100 percent (such as a software consultant for TCM documentation) on Worksheet D, Column 1.

Unallowable costs are classified as NTCM costs in the Cost Report. Report NTCM operating expenses on Worksheet D, Column 4. **Unallowable** (NTCM) costs for staff who provide or support the provision of TCM services include, but are not limited to:

- Interest payment
- Malpractice insurance
- Medical equipment used for medical treatment
- Drugs and Medication
- Lab equipment
- Fund raising
- Lobbying
- Food
- Respite care/services
- Transportation for clients
- Drug testing supplies
- Recreational activities for clients

Indirect expenses are departmental or LGA-wide administrative services that support the budgetary, personnel, and management needs of the TCM budget unit. The percentage of the departmental or LGA-wide indirect expenses (including salary and benefit costs) that support this budget unit are accounted for in the TCM Cost Report as operating expenses on S&B Sch 1B. The most common example of this is the CWCAP submitted annually by each county to the State Controller's Office. A copy of the page of this CWCAP (or the relevant departmental administrative cost allocation plan) that shows the indirect cost percentage of the TCM budget unit must be included with the Cost Report.

All operating costs of the budget unit that provides TCM services, must be included in the TCM Cost Report on S&B Sch 1B or Worksheet D. No operating cost of the budget unit may be excluded from the Cost Report.

TCM Time Survey Summary Template (used with S&B Sch 2A)

Since no MAA-TCM time survey was completed during the FY 2011-2012 for cost report(s) due November 1, 2012, use the 2009 completed MAA-TCM time surveys and related templates to report staff time. Therefore, there will be no reason to add or delete time surveys on the FY 09/10 MAA-TCM Combo Time Survey excel Template.

Staff who completed a FY 09/10 time survey and were included in the Salaries section of the FY 2010 Cost Report should be included in the "Salaries" tab of the FY 2012 Cost Report in the section marked "Time Surveyed to TCM". For Cost Report due November 1, 2012 if a participant was included in the FY 2010 Cost Report but is no longer participating in TCM in FY 11/12, simply include the participant's name and time survey results but omit any salary and benefit information

This template ensures accurate tabulation of the time survey hours reported by each TCM staff. It must be submitted electronically along with the Cost Report and Cost Report Review Tool template. Each hard copy Cost Report must also include individual time Survey signed by the TCM staff who complete them and his or her supervisor.

Enter the time survey hours reported by each staff who time-surveyed into the individual worksheets of the TCM Time Survey Summary Template. Enter time survey data into time survey worksheet 1 for the first TCM staff listed on S&B Sch 1A. Enter the name and job title of the staff in the appropriate cells at the top of each time survey worksheet. Enter time survey data into time survey worksheet 2 for the second TCM staff listed on S&B Sch 1A. Continue entering time survey data into the numbered worksheets in the same order as that the staff is listed on the S&B Sch 1A (this should be in alphabetical order by last name).

All information entered into the numbered time survey worksheets automatically flows into the Totals and List worksheets, other than the LGA and Program names entered at the top of the List Worksheet. Do not enter any data onto these two worksheets.

Once all the individual time survey data has been entered into the template, click on the List worksheet and scroll to the far right, where you will find the time survey percentages that must be copied and pasted onto S&B Sch 2A for the TCM staff. If the staff names were entered in the same order on the time survey worksheets as they are on S&B Sch 1A, then the time survey percentages will copy and paste easily onto S&B Sch 2A.

Just below the bottom line of time survey percentages on the List worksheet, is the total number of time survey hours for each of the four categories. Enter these numbers into their related cells on the Calculation for Averaged Percentages (Salary Averaging Worksheet of the TCM Cost Report template).

Worksheet B (Supported by the Funding Schedule and General Ledger)

The purpose of Worksheet B is to identify the amount of funding for the TCM budget unit that must be adjusted (eliminated) from TCM Total Allowable Case Manager cost identified on Worksheet A, line 16. The Funding Schedule, discussed below, must be completed prior to completion of Worksheet B.

Worksheet B does not include reimbursements from MAA/TCM programs. Funding sources that may require offset include, but are not limited to:

- Federal funds
- Client fees
- Private donations
- Private foundation grants
- Funding Schedule

The purpose of the Funding Schedule is to identify **all** funding sources that support the whole TCM budget unit. Required information to be included: (1) name of funding source, (2) funding source funds that support the TCM budget unit, (3) whether the funds support TCM encounters, (4) amount of unallowable federal and private funding, and (5) computation of unallowable funding requiring adjustment against TCM costs. All funding sources identified with unallowable funding on the *Funding Schedule* must be included on the Cost Report Worksheet B.

Summary of Allowable Funding for Claiming Federal Matching Funds Worksheet

Although this worksheet looks similar to the Funding Schedule, use this additional worksheet to identify funding sources for eligible Certified Public Expenditures (CPE) of billable TCM services provided to Medi-Cal beneficiaries. This worksheet will serve to determine if the funding source provided adequate CPE for Federal Financial Participation (FFP) match, as required by 42 CFR 433.51.

Remember an electronic copy **as well as a** hard copy **of the** Funding Schedule and Summary of Allowable Funding for Claiming Federal Matching Funds worksheets **must be submitted.**

Encounters Methodology Worksheet

Using your LGA encounter log, tally the **total** number of: TCM encounters conducted with Medi-Cal beneficiaries and the TCM Medi-Cal encounters that were not claimable, such as those conducted in locked facilities or with persons served under other case management programs (Maternal Child Health (MCH), the TCM LEAD program, California Child Services (CCS), etc.). If these program costs are included in the TCM Budget Unit, then total the non-claimable Medi-Cal TCM encounters conducted. Enter these numbers where indicated in the top half of the Encounter Methodology Worksheet.

Analyze your LGA's projected claimable Medi-Cal TCM encounters by considering how many additional or fewer staff will be providing services to how many additional or fewer clients. This change might be caused by adding or reducing the number of programs provided by the LGA or by targeting a new client population.

After determining a percentage of change, select Increase or Decrease from the pull-down menu and enter the percentage in the blue cell indicated. Enter a brief explanation of how this projection was determined in the large blue space. Add descriptive supporting documentation (details of program changes and per-case manager encounters) if the change is large (more than 20%).

Interim Medi-Cal TCM Encounter Payment Rate Calculation Worksheet

This worksheet records the total prior fiscal year costs of TCM services to all TCM target populations and related encounters. It calculates the interim Medi-Cal TCM encounter payment rate to be used for reimbursement for the TCM service period beginning July 1, 2012 until the next interim rate is established.

The purpose of an interim Medi-Cal TCM encounter payment rate is to provide an interim payment that will approximate the Medi-Cal TCM program cost per encounter eligible for Federal Financial Participation claimed through the CPE process. For each LGA, the Department will establish an interim Medi-Cal payment rate based on a weighted average from cost reports due by November 1, 2012. The interim Medi-Cal payment rate will be calculated by dividing the total allowable costs by total encounters from the cost reports containing 100 percent of each target population's cost.

Worksheet A (supported by the Cost Report Review Tool)

Do not enter any data directly into Worksheet A. This worksheet is entirely formula driven. Verify that Line 7, Column 4, is zero. If it is not zero, there will be an ERROR message in Line 7, Column 7. If you get an error message, review how you entered data in the S&B Schedules. Do the time-survey percentages for TCM staff on S&B Sch 2A total 100 percent on each row? On S&B Sch 2A, is the correct 100.00% selected for ADMIN and NTCM? Are the salaries, benefits, and operating expenses entered accurately? How about the number of encounters on the Encounter Methodology Worksheet? Any major imbalance on Worksheet A may be caused by one of these problems.

If the imbalance in Line 7, Column 4, is one or two dollars, balance it to zero by entering an opposite amount on S&B Sch 2D at the bottom of the column titled "Total Other/ Direct/ MAA Salary & PTO" (for \$1 on Worksheet A, enter -\$1 on S&B Sch 2D). Do not use this method anywhere other than on S&B Sch 2D.

Cost Report Review Tool

Use the Cost Report Review Tool to check for accuracy and reasonableness. Enter the requested sums from the Cost Report and enter the page number where those sums are found in the supporting documents. It is vital that these primary figures match (within a dollar or two) your general ledger, payroll detail, and working trial balance.

The Cost Report Review Tool includes three calculations to alert you to possible unreasonable costs:

The approximate cost per encounter hour is generated.

The ratio of Administrative staff S&B to TCM staff S&B is generated.

The ratio of Operating Expenses (not including Contractors) to TCM staff S&B is generated.

The Cost Report Review Tool must be completed for the Cost Report to be approved.

Remember an **electronic copy** as well as a **hard copy** of the **Cost Report Review Tool** must be submitted.

Packaging Your TCM Cost Report

1. Use the standardized Table of Contents from Appendix C.
2. Enhance the table of contents by indicating any color-coding scheme you are using. Number all pages of the Cost Report as shown in the Table of Contents.
3. On all supporting documents, highlight key figures and note to which Worksheets or Schedules these figures refer.
4. Tab and label the Cost Report packet using headings from the Table of Contents.
5. Ensure that all Essential Materials and Required Supporting Documents are included.
6. Verify that the Cost Report Checklist and the Cost Report Review Tool have been completed and are included (hard copy and electronically).
7. Compose a separate cover letter for each Cost Report that explains any unusual features in the Cost Report and any major changes from the previous year.
8. Please use the simplest sure method of securing your Cost Report for mailing (rubber bands, binder clips, or simple folders). Unless your Cost Report is more than 200 pages thick, please do not use three-ring binders.
9. Follow the electronic naming instructions on page 20.
10. **Email your DHCS MAA/TCM Combo Time Survey Template, DHCS TCM Cost Report Template, Funding Schedule, Cost Report Review Tool Template, Summary of Allowable Funding for Claiming Federal Matching Funds and Interim Medi-Cal TCM Encounter Payment Rate Calculation** no later than November 1, 2012, to dhsaitcm@dhcs.ca.gov.

Audit File

Once your Cost Report is completed, packaged, and sent to DHCS, the person preparing the TCM Cost Report must create an audit file. All documents related to the TCM Cost Report must be stored where they are accessible to the person responsible to answer questions from an auditor (typically the person who prepared the Cost Report). The State will contact the LGA's MAA/TCM Coordinator to ask for more information regarding the Cost Report or to arrange for an audit.

Cell-By-Cell Instructions for a Successful Cost Report

Use the following tables to complete and analyze the two Excel workbook template used in the TCM Cost Report: the Time Survey Summary Template and the TCM Cost Report Template. Each workbook consists of multiple worksheets. The Time Survey Summary Template workbook consists of worksheets labeled List, Totals, blank, and individually numbered worksheets from 1 up to 200. The TCM Cost Report Template workbook consists of worksheets labeled A, Encounters, B, C, D, Salaries, Survey Averaging, Contractors, and References.

These instructions are presented in the order in which they should be completed: Time Survey; Survey Averaging; S&B Sch 1A, 1B, 2A, 3A & 3B; and Worksheets D, C, B, encounters, and A. These tables include information on the formulas used in these templates. **Do not alter these formulas; enter data only in the blue cells.** Formula information is provided only to help you understand how the templates process data so that you can better analyze your results.

Note: The Instructions for the Time Survey Template may not be necessary since 2009 Time Surveys are been used to complete this cost report. However, they are provided below as reference.

Time Survey Summary Template

General Instructions: Enter the data entered by TCM staff on their signed Time Survey forms. *The formulas in this workbook calculate the percentages you will enter into S&B Sch 2A and the Salaries Averaging worksheet.* After entering the time survey hours onto the worksheets numbered from 1 up to 200 (only 50 at a time), the workbook will calculate the percentages for each TCM time survey category on the List worksheet and will tally the total hours for each category on the Totals Worksheet.

Select the appropriate version of the Time Survey Summary Template from the TCM website that includes a worksheet for each of your TCM staff from 1 up to 200 in increments of 50 at a time. If you need a workbook containing more than 200 numbered worksheets, please contact DHCS.

List Worksheet Instructions

4. Cells highlighted in blue are data entry fields. **Enter data ONLY in the blue cells;** all other cells are locked.
5. Cells highlighted in green contain formulas that must not be altered.
6. Yellow highlighted cells are also formula fields that link to or from another sheet in the workbook, as indicated in the adjacent cell. Do not alter these cells.

Contractor – Non-Specific (S&B Sch 3A)

Use S&B Sch 3A if your contract with your CBO/LPE does not specify the total amount the LGA will reimburse the CBO/LPE for the fiscal year. The CBO/LPE TCM staff must time-survey and complete a TCM Cost Report. The CBO/LPE's Total Costs (Worksheet A, Line 7, Column 7) and Total TCM Costs per Analysis (Worksheet A, Line 19) will be entered in the LGAs combined TCM Cost Report on S&B Sch 3A.

Contractor – Specific (S&B Sch 3B)

Use S&B Sch 3B if your contract with your CBO/LPE specifies the total amount the LGA will reimburse the CBO/LPE for the fiscal year. This worksheet helps determine which costs do not flow correctly to Worksheet A. Total costs on Worksheet C1 should be equal to the total costs of the Salaries Schedules and the Contractors Worksheet. A section of each cost has been provided for analysis. The most common error is incorrect data entry of Time Survey results in S&B Sch 2A.

General Instructions: Enter funding sources and total amounts for funding that must be offset per 42 CFR Section 433.51, W&I Code 14132.44(f), and 22 CCR Section 51535.7. Then enter the percentage of those amounts that support the provision of all TCM services. For TCM encounters to be eligible for federal reimbursement, they must be funded by **allowable public funds**. Federal funds that support the provision of TCM services to Medi-Cal beneficiaries must be offset here. Funding sources that must also required offset include but are not limited to: private funds, client fees, private foundation grants, etc. The Total Assigned to TCM Services links as a negative number to Worksheet A, Line 18, to calculate the Adjusted Allowable Case Managers Cost on Line 19.

Funding Schedule Detailed Instructions

Use the following steps to complete the Funding Schedule:

- Step 1.** Name of Funding Source: Identify the name of each funding source that supports the whole budget unit. This **does not** include reimbursements from MAA/TCM programs.
- Step 2.** Funding Amount: Identify the total amount of funding each source provided.
- Step 3.** Funding Supports TCM Encounters: Indicate whether or not the funding supports TCM encounters. Enter **Yes** or **No**.
- Step 4.** Total Unallowable Funding Supporting TCM Encounters: If *Step 3 = Yes*, enter total amount of funding from *Step 2* [total nonallowable federal funding (LGAs, CBOs and LPEs) and total client fees].
- Step 5.** Compute Unallowable Funding that Supports the Provision of all TCM Encounters: Multiply the amount from *Step 4* by the Average Percent TCM from the *Survey Averaging Worksheet*.
- Step 6.** Alternative Method: If you used an alternative method for determining the unallowable funding amount, explain the method used to calculate it. The adjustment amount should be included in the column identified as *Step 5*.

NOTE: Some LGAs have staff provide case management under TCM and other programs. Some of those LGAs time-survey all case management as TCM and adjust the Cost Report by offsetting the related NTCM S&B. This is only acceptable if the Cost Report has no case managers in Averaged, all the NTCM case managers are in Averaged or ADMIN, or the NTCM case manager's Time Survey are adjusted to report their NTCM case management hours in Other Programs.

Summary of Allowable Funding for Claiming Federal Matching Funds Worksheet

General Instructions: This worksheet will determine if there was sufficient allowable funding for Claiming Federal Matching Funds (pursuant to 42 CFR 433.51) for Medi-Cal TCM claims invoiced to the TCM program for Federal Reimbursements.

You will use the Cost Report Template to complete this worksheet. **This worksheet can not be completed until Cost Report Template has been completed in its entirety.**

You will need to ensure that your macros are enabled and that your security level is set to Medium or Low.

Step 1 (Excel Column B): Name all funding sources that support the whole budget unit. Complete steps 2-7 for each of the funding sources identified.

Note: By selecting “Add funding source line”, additional lines can be added.

Step 2 (Excel Column C): List the total amount of the funding that supports the budget unit, received from the source named in Step 1.

Step 3 (Excel Column D): Verify whether the amount in Step 2 supports TCM encounters. This will be either “Yes” or “No”. If Yes, proceed and complete steps 4-7, if No skip steps 4-7.

Step 4 (Excel Column E): If you answered “Yes” to Step 3, list funding identified in Step 2 eligible for Federal Matching funds pursuant to 42 CFR 433.51 (CPE); otherwise, enter "0."

Step 5 (Excel Column F): Using the Survey Averaging Worksheet enter the “Average Percent TCM;” otherwise enter N/A. If you enter N/A, please enter comments for this row.

Step 6 (Excel Column G): Using the Encounter Methodology Worksheet enter the “Percent of TCM Encounter / Total TCM Encounter.” This is the first percentage amount identified in the last column of the Encounter Methodology Worksheet (cell E9); otherwise enter N/A. If you enter N/A, please enter comments for this row.

Step 7 (Excel Column H): Calculated automatically. If you receive a “#VALUE!” message, double check that Step 4 and Step 5 are either marked with a % or N/A.

Step 8 Once you have entered all the information for the funding sources you will need to tab to the field in row “B”, Column G. Using the Cost Report Worksheet A, Line “20”, enter the billable rate per encounter.

Step 9 Tab to row “C”, Column G, using the “Encounters “ tab of the Cost Report Template, enter the Total Reported TCM Claimable Medi-Cal Only Encounters (Line D9 of the worksheet).

Once you have completed Step 1-9 the amount on lines D and E will automatically compute. A positive/negative amount on Line E will identify if there was sufficient/insufficient allowable funding for claiming Federal Matching Funds

Encounter Worksheet Encounter Methodology

General Instructions: This worksheet calculates the projected number of Medi-Cal encounters for the reporting period. There are two calculations on this worksheet linked to Worksheet A, Lines 14 and 21.

Cells B1, B2, and B3 are automatically filled with text from other worksheets. Enter data only in the **blue** cells. The **green** cells contain formulas, and must not be altered. The **yellow** cells are formula fields that link to or from another worksheet. Cell D8 contains a pull-down menu: click on the cell, and select the fiscal year in which the encounters were conducted.

Using your LGA encounter log, tally the total number of claimable TCM encounters conducted with Medi-Cal beneficiaries. Then tally the TCM Medi-Cal encounters that were not claimable, such as those conducted in locked facilities or with clients served under other case management programs. Then tally the total non-Medi-Cal TCM encounters conducted. Enter these numbers where indicated in the top half of the worksheet.

Project the number of claimable Medi-Cal TCM encounters your LGA will conduct in the current year by considering how many additional or fewer staff will be providing services to how many additional or fewer clients. This change might be caused by adding or reducing the number of units providing TCM or by targeting a new client population. After determining a percentage of change, select Increase or Decrease from the pull-down menu (Cell B18) and enter the percentage in the adjacent blue cell. Enter a brief explanation of how this projection was determined in the large blue space.

Using your LGA encounter log develop a supplemental schedule identifying the type (Medi-Cal only and Other) and the number of encounter(s) by month. e.g.

*Non-Claimable, are those conducted in locked facilities or with persons served under other case management programs (TCM LEAD program, California Child Services (CCS), etc.)



Interim Medi-Cal TCM Encounter Payment Rate Calculation Worksheet

General Instructions: This worksheet records the total prior fiscal year costs of TCM services to all TCM target population and related encounters. It calculates the interim Medi-Cal TCM encounter payment rate to be used for reimbursement for the TCM service period beginning July 1, 2012 until the next interim rate is established.

Use the Cost Report Template(s) (that contains both, 100% of the TCM cost and 100% of the TCM encounters) to complete this worksheet. **This worksheet cannot be completed until Cost Report Template has been completed in its entirety.**

You will need to ensure that your macros are enabled and that your security level is set to Medium or Low.

Step 1 (Excel Column B4): Enter LGA Name

Step 2 (Excel Column B&C5): Enter Reporting Period From: to To:

Step 3 (Excel Column C9 to 14): Enter the "Total TCM Reported TCM Encounters" from each TCM target population cost report Worksheet A, Column 1, Line 14.

Step 4 (Excel Column D9 to 14): Enter the "Adjusted Allowable Case Manager Costs" from each TCM target population cost report Worksheet A, Column 1, Line 19.

Step 5 (Excel Column C15): **Calculates automatically** - Total All Target Population TCM Encounters (Sum of Column 1, Lines 1 through 6).

Step 6 (Excel Column D16): **Calculates automatically** - Total All Target Population Allowable Case Manager Costs (Sum of Column 2, Lines 1 through 6).

Step 7 (Excel Column D17): **Calculates automatically** - Interim Medi-Cal TCM Encounter Payment Rate for TCM service period beginning July 1, 2012 (Column 2, Line 8 Divided by Column 1, Line 7).

Once you have completed Steps 1-4 the amount on line D17 is the LGA Interim Medi-Cal Encounter Payment Rate to be used for reimbursement for the TCM service period beginning July 1, 2012 until the next interim rate is established.

Worksheet A

TCM RATE CALCULATION WORKSHEET

General Instructions: This worksheet summarizes the TCM budget unit's reported TCM and NTCM costs for the prior fiscal year and calculates the TCM per-encounter rate for reimbursements in the current fiscal year. The worksheet also calculates the maximum reimbursement amount (CAP) before reimbursements are multiplied by the prevailing Federal Medical Assistance Percentage (FMAP). The current FMAP is 50 percent.

There are only four blue cells requiring data entry: the LGA Name, the Program Name, and Reporting Period Dates. Review the worksheet to evaluate potential data-entry errors in the supporting worksheets and to analyze the effects of reported costs found in supporting documents.

If Line 7, Column 4, does not equal zero, review how you entered data in the S&B Schedules. Do the time-survey percentages for TCM staff on S&B Sch 2A total 100 percent on each row? Did you select the 100.00% for ADMIN and NTCM? Are the salaries, benefits, and operating expenses entered accurately? How about the number of encounters on the Encounter Methodology Worksheet? Any major imbalance on Worksheet A is caused by one of these problems.

If the imbalance in Line 7, Column 4, is one or two dollars, you can balance it to zero by entering an opposite amount on S&B Sch 2D at the bottom of the column titled Total Other/ Direct/ MAA Salary & PTO (for \$1 on Worksheet A, enter -\$1 on S&B Sch 2D). **Do not use this method anywhere other than on S&B Sched 2D.**



Helpful Hints

Congratulations! You have completed your 2012 TCM Cost Report. To expedite the approval process, please review the following hints before you submit/mail your 2012 Cost Report to DHCS.

- ✓ Were proper templates used? – Time Survey, Cost Report, Cost Report Review Tool, Funding Schedule, Summary of Allowable Funding for Claiming Federal Matching Reimbursement, and Interim Medi-Cal TCM Encounter Payment Rate.
- ✓ Is Worksheet A signed in **blue** ink?
- ✓ Is a Cover Letter included on county letterhead and signed by the LGA Coordinator?
- ✓ Are Time Survey signed and dated by employee(s) and supervisor?
- ✓ Is an Organization chart, with employee names, job title, and who they report to included?
- ✓ Are Job descriptions specific to TCM?
- ✓ Are copies of CBO/LPE contracts included?
- ✓ Are documentations of Salary & Benefits clearly identified by employee?
- ✓ Have you reviewed all of your calculations to ensure flow accuracy?
- ✓ Is the Cost Report Review Tool completed?
- ✓ Is the Cost Report Checklist signed and included?
- ✓ Is the Funding Schedule worksheet completed?
- ✓ Is the Summary of Allowable Funding for Claiming Federal Matching Funds worksheet completed?
- ✓ Is the Interim Medi-Cal TCM Encounter Payment Rate Calculation Worksheet completed and included?
- ✓ Don't be overwhelmed by the TCM Cost Report Template. It is large, but relatively few cells require you to enter data. The simplest approach to the TCM Cost Report Template is to enter the required numbers into the blue cells, then take time to ensure that the results are reasonable (do not get stuck trying to analyze the results before you have entered all of the data).
- ✓ Start preparing your TCM Cost Report(s) early. If you have any questions, contact your LGA TCM Coordinator. If your LGA TCM Coordinator or the LGA MAA/TCM Consultant cannot provide the information you need, they will contact DHCS for further information.

First Year of Participation in TCM

The TCM Cost Report is based on the prior year TCM costs, the prior year TCM encounters, and the prior year TCM time survey. When TCM was initiated in 1994, no prior year data was available. Procedures have been developed to accommodate the entry of new programs into the TCM system.

It is assumed that the new program began maintaining TCM Encounter Logs during the current year.

Programs initiating participation in TCM must determine the following:

1. The methodology for determining the costs to be entered on S&B Sch 1A, 1B, 2A and Worksheets D, B, and Encounter Methodology.
2. The methodology for determining the number of TCM encounters to include on Line 14 of Worksheet A.

Typically, LGAs annualize these costs by using the costs and encounters available to them for this fiscal year and multiplying them to estimate what costs and encounters are for one fiscal year. Example: TCM Encounter Logs are maintained beginning on July 1. The total number of encounters for July through September (three months) is multiplied by four to determine the annual number.

If the required time surveys are not available from 2009, contact DHCS/TCM Unit for guidance.

Programs in Operation the Prior Year but Not in TCM

1. Prior year costs can be used. The most current year time survey results (September or October 2009) are applied to costs of persons who would have been involved in TCM if the program had been participating in the prior year. After defining the budget unit and classifying prior year staff as TCM, ADMIN, and NTCM, enter costs as required in the 2012 TCM Cost Report Instructions.
2. Annualize the number of encounters (Medi-Cal and non-Medi-Cal) on the current year TCM Encounter Logs to determine the number to include on the Encounter Methodology Worksheet. Example: TCM Encounter Logs are maintained beginning on July 1. The total number of encounters for July through September (three months) is multiplied by four to determine the annual number.

If the required time surveys are not available from 2009, contact DHCS/TCM Unit for guidance.

Programs Not in Operation the Prior Year

1. Use the established program budget for the current year. Apply the time survey results from September or October 2009 to the costs of persons who are involved in TCM. Enter costs and encounters on S&B Sch 1A, 1B, 2A and Worksheets D, B, and Encounter Methodology as required in the 2012 TCM Cost Report Instructions.
2. The numbers of encounters (Medi-Cal and non-Medi-Cal) on the current year TCM Encounter Logs are annualized to determine the number to include on Line 14 of Worksheet A. Example: TCM Encounter Logs are maintained beginning on July 1. The total number of encounters for July through September (three months) is multiplied by four to determine the annual number.

If the required time surveys are not available from 2009, contact DHCS/TCM Unit for guidance.

Closing-Year Costs

TCM Service Provider Filing Closing-Year Costs

All costs of providing TCM services to a target population must be reported in the annual TCM Cost Report for that target population. These costs must include costs of any TCM service provider that provided TCM in the prior fiscal year, but who ceased providing TCM services in June 30, 2012, or earlier in that target population. Therefore, if more than one (1) cost report must be filed for a target population, and 2) one of the service providers is participating in TCM for FY 2012/2013, the costs and encounters of service providers who ceased providing TCM June 30, 2012, or earlier, would not be included in the cost report used to calculate the interim encounter rate.

Report prior year costs in a Cost Report Template to be emailed to DHCS A&I with all other templates in the cost report for that target population.

Important: Do not include “Total Projected Claimable Medi-Cal Only TCM Encounters for Current Year” on the “Encounter Methodology” Worksheet. Worksheet A row 21 “Total Projected Medi-Cal Only Encounters for Current Year” **should equal 0.**

Time Survey: In order to apportion personnel costs in the annual TCM cost report, all TCM service providers must time survey every year in which TCM services are provided, irrespective of whether or not services are expected to be provided in the subsequent year. If the required time surveys are not available from 2009, contact DHCS/TCM Unit for guidance.

How to name your final “Closing-Year Costs” Templates and Tools

If your LGA chooses not to participate in providing TCM services to a specific target population in FY 2012-13, name the templates and tools as follows:

1. Final
2. Current Year

3. LGA Name

4. Abbreviated TCM target population name (CH, FA, IR, NO, and CD)
5. Abbreviated Template/Tool name (CR, TS, RT, FS, and IMTEPR)

Example: Final 2012 Sacramento NO TS.xls

If a TCM service provider other than an LGA (CBO or LPE) does not participate in the TCM program in FY 2012/13, name the templates and tools as follows:

1. Final
2. Current Year
3. LGA Name
4. Abbreviated TCM target population name (CH, FA, IR, NO, and CD)
5. Abbreviated Template/Tool name (CR, TS, RT, FS, and IMTEPR)
6. CBO or LPE agency identifier

Example: Final 2012 Amador CD RT ABCD.xls
