


**PURPOSE**

This bulletin transmits the proposed Fiscal Year (FY) 2012-2013 reimbursement rates for Drug Medi-Cal (DMC) services. The proposed rates and subsequent claim payments are contingent upon Legislative action and approval of the FY 2012-2013 Budget Act. The rates will be effective July 1, 2012 through June 30, 2013.

While counties and direct contract providers may submit DMC claims based on the proposed FY 2012-2013 rates, the Department of Health Care Services (DHCS) may not be able to issue payments for any services provided in FY 2012-2013 until the Budget Act is signed.

**DISCUSSION**

Effective July 1, 2012, DMC functions from the Department of Alcohol and Drug Programs (ADP) will transfer to DHCS, in accordance with Assembly Bill 106, Chapter 32, Statutes of 2011.

Each year, the State develops new reimbursement rates for DMC services. The FY 2012-2013 rates were developed in accordance with the Welfare and Institutions Code, Sections 14021.6 and 14021.9; and Health and Safety Code, Section 11758.42. For FY 2012-2013, the cumulative growth in the Implicit Price Deflator used to develop the proposed rates was 7.1 percent, as reported by the Department of Finance.

These rates reflect ADP's analysis of costs for the non-NTP dosing DMC treatment modalities.
