### FUNDING CATEGORIES

- **Infrastructure funding** is financial support designated for the development, expansion, or improvement of physical facilities and infrastructure.
- **Operational funding** refers to financial resources allocated to cover the day-to-day expenses of running programs and services.
- **Health Care Services funding** refers to financial resources allocated specifically for the delivery of direct services to individuals and families.
- **Housing Services funding** include supportive housing services, interim housing services, financial assistance and housing-related wraparound supportive services.

## TYPES OF NON-RESIDENTIAL SETTINGS

Outpatient services offer **treatment and support** for substance use disorders (SUD) or mental health conditions **without requiring overnight stays**, including programs like standard and intensive outpatient, partial hospitalization, counseling, medication-assisted treatment, and peer support.
