SUBJECT: Rollback of Federal Medical Assistance Percentages (FMAP), Enhanced Federal Medical Assistance Percentages (eFMAP), and the Statewide Maximum Allowance (SMA) Rates for Specialty Mental Health Services (SMHS), Drug Medi-Cal Organized Delivery System (DMC-ODS) and Drug Medi-Cal (DMC) Non-Narcotic Treatment Program (non-NTP) Services Due to the End of the COVID-19 Public Health Emergency (PHE)

PURPOSE: This Information Notice communicates to counties the new FMAP and eFMAP for each quarter following the end of the COVID-19 PHE, and the expiration of the COVID-19 increased SMA rates for SMHS, DMC-ODS and DMC non-NTP services.

BACKGROUND:

On March 18, 2020, the President signed the FFCRA into law. The FFCRA provided a temporary 6.2 percentage point increase to California's Federal Medical Assistance Percentage (FMAP) under section 1905(b) of the Social Security Act, effective January 1, 2020, and extending through the last day of the calendar quarter in which the public health emergency declared by the Secretary of Health and Human Services for COVID-19, including any extensions, terminates. The FFCRA also provided a 4.34 percentage point increase to the enhanced FMAP (eFMAP) for eligible expenditures.

On May 13, 2020, the federal Centers for Medicare & Medicaid Services (CMS) approved SPA 20-0024, along with the Department of Health Care Services' (DHCS) request for interim payment flexibilities. As a result, for SMHS, DMC-ODS non-NTP services and DMC non-NTP services provided on or after March 1, 2020, DHCS provided interim reimbursement equal to the lower of the county's billed amount or the interim rate increased by 100 percent. SPA 20-0024 also authorized DHCS to settle interim payments for outpatient SMHS, DMC-ODS non-NTP and non-inpatient services, and DMC non-NTP services to allowable cost instead of the lower of allowable cost or usual and customary charge.

POLICY:

With the end of the COVID-19 PHE on May 11, 2023, and in accordance with the guidelines outlined in the FFCRA and SPA 20-024, DHCS will roll back the increases to the FMAP, eFMAP, the SMHS, DMC-ODS and DMC non-NTP interim rates, and will settle interim payments to the lower of allowable cost or usual and customary charge. This process is described in more detail below.

FMAP and eFMAP Rollback

Beginning April 1, 2023, through January 1, 2024, the temporary increases to the FMAP and eFMAP will be reduced each calendar quarter until the FMAP and eFMAP return to their original values (prior to the FFCRA). These FMAP rollbacks have been deployed in the Short Doyle Medi-Cal claiming system.

The table below displays the quarterly changes to the FMAP and eFMAP.

SMHS, DMC-ODS and DMC-SPA Non-NTP SMA Rate Rollback

SMHS, DMC-ODS and DMC non-NTP services provided on or after March 1, 2020, and through May 11, 2023, will be reimbursed an interim payment equal to the lower of the county’s billed amount or the county interim rate or the SMA, increased by 100 percent. At cost settlement, DHCS will settle interim payments to allowable cost, rather than the lower of allowable cost or usual and customary charges, for services provided during this same period of time. Effective May 12, 2023, the SMA for SMHS, DMC-ODS and DMC non-NTP services will be reduced by 100 percent. At cost settlement, DHCS will settle interim payments for all DMC-ODS and DMC services to the lower of allowable cost or usual and customary charges for services provided after May 11, 2023; and will settle interim payments for outpatient SMHS provided by county contract providers to the lower of actual cost or usual and customary charges for services provided after May 11, 2023.
