DHCS Bold Goals: 50x2025

- » Ensure all health plans exceed the 50th percentile for all children's preventive health measures
- » Facilitate improved performance on the Topical Fluoride for Children (TFL-CH) MCAS measure
- » Address many questions from managed care plans about
 - How to improve dental care coordination and access
 - How to find data on topical application of fluoride

Dental Fluoride Application

- >> Protective coating applied on the **teeth** to prevent **tooth** decay
- » Fluoride strengthens teeth and reduces risk of cavities by approximately 25%
- >> Fluoride treatments are important because they can help prevent and treat a variety of dental issues such as
 - Tooth decay
 - Sensitivity
 - Dental conditions
 - Root surface decay

Care Coordination

Care coordination services allow Medi-Cal members to call and gain access to dental services with the direction and support of our TSC agents, who assist members with:

- Locating a General Dentist, Specialist Dentist or a Clinic that offers dental services
- Accessing appointments
- Language Assistance and American Sign Language Service
- Transportation Assistance

Members can also access care coordination services by calling the Medi-Cal Dental TSC at (800) 322-6384.

Scheduled for 21 events throughout the state this year and growing.




Opportunities for partnership and engagement with local oral health plans, school districts, and MCPs. Media and public reception of this modality is very positive.

- » CHW Services (Current Dental Terminology (CDT) Code D9994) is an allowable code.

Who Can Provide Dental Fluoride Application?

- » Federal Qualified Health Center (FQHC), Rural Health Center (RHC), and Indian Health Center (IHC) Providers
 - Primary ICD-10 or Secondary ICD-10 code and
 - Procedure code
- » Medical Providers
 - Procedure Codes: D1206, D1208, or 91888
- » Dental Office
 - Procedure Codes: D1206 or D1208

Which Dental Fluoride Service Codes are Used by FQHC/RHC/IHC?

» Claim Data

- Procedure Code: 00003 and
- ICD-10 codes: K036 or Z293
- » Encounter Data
 - Revenue Code: 0521 and
 - Procedure Code T1015 with Modifier SE

Which Dental Fluoride Service Codes are used by Medical Providers?

» Claims Data

- Current Procedural Terminology (CPT) code of 99188, or
- Current Dental Terminology (CDT) code of D1206, or
- CDT code of D1208

Which Dental Fluoride Service Codes are used by Dental Offices?

» Claims Data

- CDT code of D1206, or
- CDT code of D1208



- » Dental Fluoride Application can be provided by Dental, Medical, and FQHC/RHC/IHC Providers
- » Dental services provided by FQHC, RHC, and IHC will be in the claims and encounters using medical claims
- » Different types and combinations of ICD-10 codes, procedure codes, CPT, CDT, or Revenue codes are used for different providers
- » DHCS captures paid claims/encounter data related to Dental Fluoride Services
