PURPOSE

The purpose of this bulletin is to provide information to counties and providers regarding the Department of Alcohol and Drug Programs (ADP) plan for Drug Medi-Cal (DMC) billing for the year 2000 and beyond (Y2K).

DISCUSSION

ADP plans to change the format of the Drug Medi-Cal claims effective July 1, 2000 by expanding the following fields:

4) Admit Date	YYMM	CCYYMM	2 Chars

All Counties/Providers must implement the above changes on all automated DMC billings by June 30, 2000. This includes all media types (tape, disk and E-mail). As of July 1, 2000, only Y2K-formatted claims will be accepted; this includes resubmission or supplemental claims received after July 1, 2000.

For claims submitted through June 30, 2000, ADP will utilize Department of Health Services' (DHS) windowing program to process billings on the current (150-character record) format.

ADP will test county or provider data in DHS's Y2K test environment upon request. Karen Redman of Information Management Services Division (IMSD) is ADP's External Interface coordinator.

The Drug Medi-Cal Eligibility Worksheet (ADP 1584) will be available in the Y2K format for submission of manual billings starting February 1, 2000. DHS will not accept claims in the non-Y2K format after the above-mentioned date.
